1. All contestants must be present at the Marina (fees paid and livewells checked) for pre-tournament meeting 30 minutes prior to takeoff. **LATE TEAMS WILL BE ASSIGNED LAST TAKE-OFF NUMBERS!!**
2. 2 persons per boat.
3. Aerated livewells required in all boats. Largemouth and Smallmouth bass must measure **15"** with mouth closed. Undersized bass will incur a one (1) pound penalty to be deducted only from total weight. Five (5) bass limit per boat. Live bass only will be weighed. Total weight will determine places. **ALL** bass will be released after weigh-in.
4. **LATE-PENALTY FOR END OF TOURNAMENT HOURS ---- DISQUALIFICATION.**
5. Big Bass will break heavy stringer ties. Big Bass to be designated by team member.
6. Any contestant wishing to protest the conduct of a fellow contestant must do so within 15 minutes of weigh-in time.
7. Only artificial lures and pork may be used. No trolling. Only one rod may be used at a time. All fish must be caught with rod and reel and landed from the boat.
8. Apple Canyon Lake rules must be obeyed. Any citation from lake security will result in disqualification. Life jackets are recommended.
9. Sportsmanship, courtesy, and safety are expected from all participants.
10. Survey cards **must** be filled out and signed prior to weighing fish. No Exceptions.
11. **RULES INTERPRETED BY THE TOURNAMENT COMMITTEE. ALL DECISIONS ARE FINAL!!**
