President's Message

The summer is flying by quickly and the Board of Directors have been very busy. As mentioned in the last issue of the *Apple Core*, the Board members have been actively involved in the planning of the construction CAMP construction project. At the July meeting, two major components of the CAMP process was the approval of contracting with Farnsworth Group to design development of construction documents for the Association office and the clubhouse. Also approved was for the CAMP Architect and Design committee to develop and advertise an Request for Proposal for a Construction Manager at Risk and interview at least three candidates.

CAMP ARCHITECT AND DESIGN

A Construction Manager At-Risk is an individual who oversees the entire construction project working for the Association – not the construction contractor. This individual assures the following:

- Construction Manager works closely with the architect and committee to assure the plans are followed through;
- Construction Manager works with Association to control budget, schedule, and quality of work;
- Construction Manager works through the design-bid-build process.
- Works with the Architect and Design Commission during the pre-planning stages, during the design and drawing phases, and at the pre-construction stage;
- Assists the owner in the construction schedule, project budget, cash-flow analysis, discussion of means and methods, and costs projects;
- Basically, responsible for the quality of workmanship, materials, costs, etc. of the project.

June Operating Revenues were \$295,238.

Year-to-Date (YTD) Revenues were \$1,689,470 and were **over** budget \$10,937. Revenue lines with deviations greater than \$5k from budget were:

The above activity resulted in YTD Operating Revenues **greater** than Operating Expenses for an operating income of \$84,078 which was **under** budget by \$22,012.

R&R expenditures for June were \$37,016. Line items greater than \$1k include: Forestry Mower (\$23,804), Engineering for Dam (\$5,700), Stream Stabilization (\$5,100), Pool Well (\$1,590) All R&R expenditures are within budget YTD except for fairway mower over \$2,640 and Dewatering Bag over \$135.

Note: BOD approved additional expense for the mower at the 1/2019 meeting.

R&R expenditures (YTD) were \$189,460 with a remaining budget of \$371,940.

Work Resumes on CAMP Projects

Work on the Clubhouse Area Master Plan (CAMP) is beginning to increase again after taking a back seat for much of 2019. The CAMP Architecture and Design (AD) and Finance and Marketing (FM) commissions have been working during this time on changes to CAMP from a year ago. The original CAMP design was one building with a basement; soil borings proved to us that a basement was not an option. During this process we heard from many owners on their ideas and thoughts about CAMP. Many of you asked why we couldn't phase the project, why we weren't saving money for a project this large and why we weren't considering remodeling the old clubhouse. Today, I want to update you on these items and a few more CAMP details.

WHY AREN'T WE SAVING MONEY FOR A PROJECT THIS LARGE?

The majority of the increase in the annual assessment for 2019 went into planning for the future. The breakdown of your dues for 2019 was \$596.94 for Operating, \$82.75 for Capital and \$297.81 for R&R (Replacement and renovation). Budgeting money into the capital account was done to save for future capital projects, whether it is for CAMP, the dam or another project in the future. This is the first time in many years that money was designated for a future capital project.

WHY DON'T WE PHASE THE PROJECT?

Now that we know we can not have a building with a basement, we are planning for two buildings, one will be the Administrative building, with offices and meeting space. This building can be built while we are still operating out of the current building so operations are not impacted with construction. The new building will have sufficient office space for the current staff with room for some expansion. This will allow for employees to not be sharing an office, room for storage and an area to complete our projects throughout the year. The building will have three meeting rooms, one which can be opened up to a larger room to accommodate the monthly Board of Directors meeting, or a group of 50-75 people. Once this building is complete, we can start on the old clubhouse

immediately, or it could be decided to wait a year or two to save up more money to complete this building.

WHY DON'T WE JUST REMODEL THE OLD CLUBHOUSE?

The clubhouse is fifty years old and is grandfathered for ADA compliances and other county codes. If we were to remodel the building, we would need to bring the building into compliance which would be very costly. Long discussions with the AD commission and the architects determined that tearing down the old building and rebuilding would be the most cost effective.

WHAT'S NEXT FOR CAMP?

The Board of Directors will be voting on a contract for Design Development and Construction Documents with the Farnsworth Group at their August meeting. If approved, we will start designing both buildings and preparing construction documents. Even though we plan on only starting construction of the Administrative building, we are planning both buildings to be more cost efficient. In the next two months the CAMP AD commission will be interviewing Construction Managers. This position will be a partner to ACL during design by offering value engineering – ways to save money on the design of the building. During construction they will be our eyes on the project, making sure that short cuts are not taken by contractors that can cost us more in the future.

In the upcoming months look for more CAMP articles in the Apple Core and on the CAMP page of the Apple Canyon Lake website. CAMP AD and FM commissions are meeting at least once a month, their meeting times, agenda and minutes are all posted on the website also. If you have questions about CAMP you can also contact me, I would be happy to explain and answer your questions.

ARCHITECTURAL AND ENVIRONMENTAL CONTROL COMMITTEE MINUTES

JULY 13, 2019
UNAPPROVED

- 1.0 Call to Order – The July 13, 2019 meeting of the ACL Architectural & Environmental Control Committee was called to order by Vice Chair Jim Frank at 8:00 a.m.
Committee members present: Jim Frank, Barb Hendren, Bob Ballenger, Gordy Williams, Building Inspector Joe Wiener, Steve Tribbey, Mike Harris, John Diehl, Bill Ware; also guest Shaun Nordlie. Absent: Cindy Zophy.
- 2.0 Election of Officers: Mike Harris nominated Cindy Zophy for Chairperson; seconded by Gordy Williams. Motion passed unanimously. Gordy Williams nominated Jim Frank as Vice Chair; seconded by Bill Ware. Motion passed unanimously. Mike Harris nominated Barb Hendren as Secretary; seconded by Steve Tribbey. Motion passed unanimously.
- 3.0 Approve Minutes of the May 4, 2019 meeting – Steve Tribbey moved to accept the minutes of May 4, 2019 as written; seconded by Mike Harris. Motion passed unanimously.
- 4.0 Property Owner Comments
- 5.0 Building Inspector’s Report – Joe Wiener reported that we’ve issued 98 permits so far this year. There have been 2 permits issued for new houses; one is built, and the other is not going to be built. The other permits are for garages, sheds, and shoreline work. Joe has been approving permits that are for smaller things and has been taking all larger projects, and any shoreline work and garages to the committee for approval. Two thirds of the septic systems scheduled for pumping this year have been inspected; a reminder letter is going out next week for those not yet completed.
- 6.0 New Business
 - 6.1 13A1 Mustang Lane – Construct concrete patio and concrete cart path. Finish shoreline wall, steps. Steve Tribbey moved to “Approve the construction of a 5’ wide concrete cart path and an 8’ by 15’ concrete patio and to finish a limestone shoreline retaining wall and limestone shoreline steps, all within the 100’ lakefront setback, as per the attached sketch. No concrete is permitted within 5’ of the shoreline; a silt fence must be installed and maintained. The AECC requests that the concrete be tinted or stamped to better blend in with the environment.” Discussion: This request is a renewal for previously issued permits 16-098 and 18-002 which have expired. This application also revises permit 19-026 from an aggregate patio to concrete. The concrete patio close to the lake is a concern to several committee members. Motion passed unanimously with 8 yes votes, 0 no votes.
 - 6.2 10A56 Cardinal Court – Concrete patio, concrete boardwalks, aggregate cart paths, improve drainage. Bill Ware moved to “Approve the following work as per the attached sketch:
 - 1. repair and top dress the existing shoreline rip rap (within the 100’ lakefront setback)
 - 2. repair and top dress the two existing shoreline rip rap (within the 100’ lakefront setback)
 - 3. construct a 4’ wide concrete boardwalk, serpentine (partially within the 100’ lakefront setback). The AECC requests that the concrete be tinted or stamped to better blend in with the environment.
 - 4. construct a 4’ wide 10’ long concrete boardwalk and 11’ by 28’ concrete patio under the existing deck (not within the 100’ lakefront setback).
 - 5. install storm water control features at house gutters and under the east cart path with proper erosion prevention control on the discharge side, which must be approved by the Building Inspector.
 No concrete is permitted within 5’ of the shoreline. A silt fence shall be installed and maintained throughout the project as indicated on the site plan.” Seconded by Gordy Williams. Discussion: The description of storm water control features that are planned is vague. There is a gully in the greenway space next to the proposed water drainage area – we need to make sure there is no erosion here. Also, the type of tube is not specified. The committee agreed to approve the project only if Joe Wiener keeps a close eye on it to see that it’s done appropriately. Motion passed with 7 yes, 1 no. Gordy Williams left the meeting at 8:32 am.
 - 6.3 14A70 Falling Sun Drive – Enclose existing attached roofed deck. Mike Harris moved to “Approve the enclosure of an existing attached roofed porch as per the attached sketches to create a three-season room.” Seconded by Steve Tribbey. Motion passed unanimously with 7 yes.
 - 6.4 11A172 Palmer Court – New attached garage, porch, steps and driveway. Barb Hendren moved to “Approve the construction at 11A172 Palmer Court as per the submitted drawings of a new attached two-car garage, a new attached entry foyer, an attached entry porch and steps. Also a new driveway and culvert location is planned to create a circle drive with new entry onto Palmer Court. A silt fence shall be installed and maintained throughout the project as indicated on the site plan and all lot corner posts and structure setbacks must be located and flagged by a licensed surveyor in accordance with ACL B&E Code 102.3. Approval is subject to receiving permits from the authorities having jurisdiction.” Seconded by Mike Harris. Discussion: the property corners have been staked, and the owner knows that they need to get a culvert permit from the township. Motion passed with 6 yes votes, and 1 abstaining.
 - 6.5 6A90 Appomattox Drive – New attached garage. Bill Ware moved to “Approve the construction of the attached 26’ by 24’ garage as per the submitted plans. A silt fence shall be installed and maintained throughout the project as indicated on the site plan and all lot corner posts and structure setbacks must be located and flagged by a licensed surveyor in accordance with ACL B&E Code 102.3.” Seconded by Steve Tribbey. Discussion: the colors and roof will match the existing dwelling. The layout appears to meet ACL setback requirements. Motion passed unanimously with 7 yes.
 - 6.7 ACL Energy Policy – The committee had a discussion on the proposed language. There are three items that need to be addressed: 1. Allowing solar ground arrays as long as they are screened from neighbors’ view

and the committee approves their location. Question – should a size limitation be imposed? 2. Allowing rain barrels as long as they are covered. 3. Include language on geothermal energy systems. Also, should paragraph g be removed.

CAMP FINANCING AND MARKETING AD HOC COMMISSION MEETING MINUTES

JULY 12, 2019

- 1.0 Call to Order - The meeting was called to order at 11:00 am.
Commission Members present: Gary Hannon, Mike Harris, Steve Tribbey, Joe Forman, Barb Hendren, General Manager Shaun Nordlie; via telecom: Tom Brennan, and George Reed. Absent: Cindy Carton. Guests present: Joe Wiener, Chair of CAMP A&D Ad Hoc Commission.
- 2.0 Approve FM minutes of 6/7/19 meeting – Minutes were approved as written; motion made by Gary, seconded by Steve, and approved unanimously.
- 3.0 CAMP Updates
Joe Wiener went over the updated proposal that the A&D Commission received from Farnsworth for Design & Development, and explained that A&D is recommending to the BOD that we enter into an AIA contract with Farnsworth based on their proposal of June 28, 2019. They also want to present a Construction Manager Request for Qualifications (CM RFQ) request to the BOD. These items will be on the BOD agenda of July 20, 2019. Discussion on Farnsworth's Additional Services not included in proposal fee: this has changed significantly from the original proposal. Farnsworth has absorbed some large items from their original proposal, namely, they added the engineering for the large parking lot. This will help us with fine tuning our costs. The estimated cost for Additional Services has gone down significantly, to around \$20,000.
- 4.0 CAMP Financing
Updated Project Costs, Shaun's Spreadsheet - We went over the CAMP related expenses spreadsheet. Gary is updating with CM salary and expenses, dividing over several years, as we would hire a CM for Phase I only and determine whether we would want to use the same person for Phase II. Estimated expenses for CM salary and Design & Development/Construction drawings for 2019, 2020, 2021 were discussed. The owner's contingency was discussed, and the amount that would need to be budgeted for that. Some of the numbers we are working on now will be used in the Budget process for 2020.
Upcoming R&R needs were discussed. Budget meetings for the 2020 budget are in process now. Amortization schedules from Steve Malone of Benton Bank were reviewed. Pros and cons of shorter or longer loan length were discussed. We need to get expenses for the next couple of years pinned down. Assuming the BOD votes to go ahead with the D&D phase, the next step to consider is getting a construction loan.
Dues Calculator is going to change. The proposed budget number for 2020 are in here, but not finalized. Capital needs, operating expenses and upcoming R&R needs will all need to be taken into consideration before we can make a recommendation. The commission agrees we need to stay close to actual needs when proposing any dues increase for the CAMP project.

The Association has three pontoon boats available for rent on a daily or half-day basis. All reservations must be made by a property owner or authorized guest. Property Owners must contact the Association Office to give their permission for a guest to make a reservation. Property Owners are reminded that they are responsible for the activities of their guests, and any violation of the rules by a guest or the cost of damages in excess of the security deposit will be charged against the Property Owner. All boats will be checked in and out of the Marina. An Amenity Tag must be presented to the Marina staff by the lessee. Each boat has a capacity of ten (10) persons. Ten (10) adult-size life jackets are provided. Lessees must provide their own life jackets for children and infants. Anyone who leaves the boat to access Nixon Beach, the Marina Bay Trail, etc. must have an Amenity Tag.

Effective January 1, 2016, the Illinois Boat Registration & Safety Act has been amended and now requires that any person operating a rental boat submit a valid Boating Safety Certificate or complete an abbreviated safety course prior to operating the watercraft. A copy of a valid Boating Safety Certificate must be provided to the Association Office by the rental boat operator at least 24 hours in advance of the rental, or completion of the abbreviated safety course at the Marina will be required. Rental boat operators taking the safety course must arrive at the Marina at least 30 minutes prior to the rental. Rentals will not be extended if the rental boat operator fails to complete the course prior to rental start time. Anyone taking the abbreviated safety instruction course must provide the Association with a copy of their driver's license and complete course paperwork, per the IDNR Watercraft Rental Safety Policy. Upon completion of the abbreviated course, a completion receipt valid for one year will be issued.

Reservations for rental boats will be accepted during normal Association Office hours in person or by calling 815-492-2238. Reservations should be made at least 24 hours in advance of the rental. Same day reservations can be made at the Marina. When the reservation is made, payment for the rental must be made in full. A credit card used for the Security Deposit will be taken as a guarantee at the time the reservation is made. An authorization of the Security Deposit amount will be placed on the card the week of the rental. If a reservation is being made for the same week, the authorization will be placed at the time the reservation is made. The authorization will be released if the boat is returned in same condition. A \$50 fee will be retained from the security deposit if the boat is returned after hours, the renter fails to have the boat inspected, or the renter fails to refuel the boat. The Association will make every attempt to process releases within 72 hours of the rental completion. Please be advised that the credit card company may not process the release immediately.

Cancellation policy: In the event of severe weather on the day of the rental, the rental amount will be returned to the credit card on which it was paid. If a rental is cancelled for any other reason with less than 24 hours' notice, including no shows, the rental fee will not be refunded. Any rentals cancelled with at least 24 hours' notice will be refunded the rental amount in the form of an ACL Gift Card which can be used at the Association Office, Pro Shop, Pro Shop Bar & Grill, and the Marina. ACL Gift Cards cannot be used at The Cove restaurant.

Changes to ACL insurance requirements approved

The Board approved amendments to the insurance requirements in the Rules & Regulations at their December 15 meeting. These amendments are effective immediately.

What is not changing?

- Proof of insurance must be provided for all watercraft, including non-motorized watercraft, golf carts, ATVs/UTVs, snowmobiles, and campers used at Apple Canyon Lake.
- The minimum required amount of liability insurance is still \$500,000 for bodily injury and property damage combined.

What is changing?

- ACLPOA no longer needs to be listed as an Additional Insured or Additional Interest on any policy. We do recommend including this endorsement on recreational vehicle and watercraft policies, so your agent will (hopefully) automatically send renewal documents, but it is not required.
- Documentation requirements have been spelled out in black and white (see below).
- Continuous until cancelled policies will not be accepted. If you have a continuous until cancelled policy on file, a current certificate of insurance showing the policy term expiration date is required.
- The policyholder/named insured must be the property owner of record. Policies listing the property owner as an Additional Insured or Driver will not be accepted.

What do I need to provide the Association?

Acceptable proof of liability insurance documents must meet the following requirements: the policyholder/named insured is the property owner of record; the insured watercraft/vehicle/camper must be described, and the policy term expiration date and liability coverage amounts must be listed.

2019 Trash Facts

Every ACL lot with a home is required to pay an annual \$75 Trash Assessment. Other property owners may elect to pay the trash fee and use the Solid Waste/Recycling Center. For each \$75 fee paid, the property owner has a choice of a trash decal sticker or a paper trash pass. Unless the same vehicle is used to drop off trash every time, a paper

trash pass is needed. The paper trash pass can be transferred between vehicles or presented if an ATV, UTV, or golf cart is used to drop off trash. Photocopies or photos of the pass are not acceptable and entry to the facility will be denied without a decal sticker or a paper trash pass as issued by the Association. If needed, one additional trash pass (paper or decal) can be purchased for \$10, provided the \$75 fee has already been paid. A total of two passes is allowed per lot. If a pass is lost, the replacement fee for each pass is \$30.

If a member has paid the \$75 Trash Assessment, they are also eligible to purchase Large Item and Electronic Item Disposal Permits. These permits allow the property owner to dispose of televisions, computers, furniture, large appliances, etc. Permits must be purchased in advance at the ACL Office. Large Item Disposal Permits are \$15 each and Electronic Item Disposal Permits are \$25 each. This is a very handy service as fewer and fewer locations allow the disposal of items such as televisions and old computer monitors.

No hazardous materials can be disposed of at the Center, nor are septic tanks or septic components, tires, or batteries allowed. Building materials cannot be disposed of at the Solid Waste/Recycling Center, the property owner needs to ensure an on-site dumpster is rented for any construction or renovation projects.

Detailed recycling information and a list of items accepted for Large Item and Electronic Item Disposal is included on the Solid Waste/Recycling Hours brochure given to each property owner with their trash pass. If you have any questions or would like to purchase a Trash Pass, please contact the Association Office at (815) 492-2238.

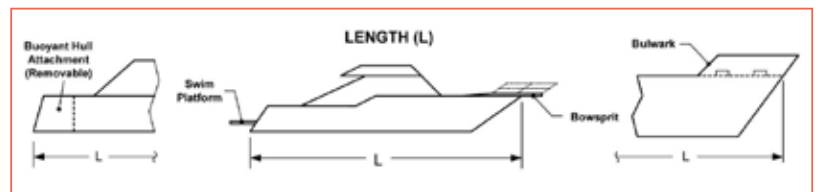
MEASURING WATERCRAFT, ATVS AND UTVS

Association staff must measure any newly registered watercraft with a length of 19' or greater stated on the Watercraft Registration, and any newly registered ATV/UTV to ensure the vehicle is less than 66" in width. Both size restrictions are in accordance with ACL Rules and Regulations, which were amended at the July 15, 2017 Board meeting to clarify how watercraft are measured. If you are considering a new boat or trail vehicle, please pay close attention to the measurements! We had several boats and vehicles registered this summer that were just a hair under the maximum allowed!

C. Boat Size/Horsepower

1. Powered boats, with the exception of pontoon boats, shall be no more than 21 ft. in length from bow to stern in length overall (LOA), as measured by the ACL staff. If watercraft registration shows boat length of 19 ft. or greater, boat must be measured prior to registration with ACL.

- **LENGTH OVERALL DEFINED:** USCG Enclosure (4) to MTN 01-99 CH5, Tonnage Technical Policy, Simplified Measurement 69.203 Definitions, Page 4:
- **OVERALL LENGTH** means the horizontal distance between the outboard side of the foremost part of the bow and the outboard side of the aftermost part of the stern, excluding rudders, outboard motor brackets, and other similar fittings and attachments. Also excluded from length are non-buoyant attachments such as bulwarks, bowsprits, overhanging decks, swim platforms and stern-wheel supports. Buoyant hull structures both fixed and removable are included in the overall length.



2. Pontoon boats shall not exceed 25 ft. as measured from the forward most point of the pontoon(s) to the aft most point of the pontoon(s).
3. Electric powered boats, sailboats or other than power boats shall not exceed 25 ft. in length as measured bow to stern in Length Overall (LOA), as defined above. Motor not included.

FOR ATVS AND UTVS, SECTION XI MOTORIZED VEHICLES- RECREATIONAL, F. OPERATION LIMITATIONS ON OPERATION OF ALL TERRAIN VEHICLES (ATV) AND GOLF CART, STATES: "13. All motorized recreational vehicles shall be 66" or less in overall width."

All measurements will be taken by ACL staff at the Association Office before a decal will be issued. If a property owner is unable to reach the office prior to closing, the office staff will make reasonable arrangements for that property owner to meet with the Safety and Security Department to have the watercraft/vehicle measured and the decal given, provided all paperwork is on file, and the registration fee has been paid in advance. The Safety and Security Department will not accept any paperwork or payments. Please allow extra time for staff to complete these measurements. If the office staff is occupied with other owners, the Safety and Security Department will be called to assist.

The What, When and Why of Permitting in Jo Daviess County

As the spring building season ramps up, the Jo Daviess County Planning & Development Department would like to take this opportunity to provide continuing education to the public regarding the building permit process.

What Requires Permits

If you live in the unincorporated area of Jo Daviess County, you will need to get your building permit from the County Planning & Development office. If you reside within a municipality, you should always check with your local officials regarding their rules of construction. Some of the things that would trigger a permit in the unincorporated areas of the County are:

Any new structure (over 120 Sq. Ft.)

- House • Accessory Building • Dec • Ag Structure

Remodeling or Additions

- Any structural change or reinforcing
- Any work that involves electrical wiring and/or plumbing

Finishing the basement

"Although these are good indicators, you should always call the Planning & Development office for direct information", said Jo Daviess County Code Enforcement Officer, Andrew Mensendike. The office number for the Department is 815-591-3810. Information can also be found on the County web site at www.jodaviess.org.

When you apply for a permit

The permitting process can take seven (7) to ten (10) business days to complete a review of your application and our office will need to have a completed application, with owner, parcel and contractor information. In addition, two copies of a site plan showing where the new structure is going on the property and how far it is to lot lines, other buildings, power lines and waterways, along with two sets of building plans, showing size, support structures, electrical information, entrance and window information should be submitted. Additional information may be requested during the review process.

Why permits are required

We understand the investment made when you begin a construction project. The County review and permitting process can help protect that investment through site review, plan review and construction oversight. Code adoption helps to reduce potential hazards of unsafe construction and ensure public health, safety and welfare.

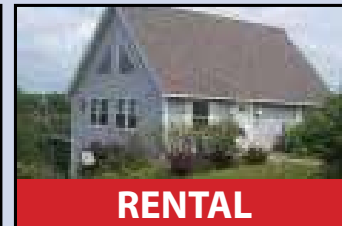

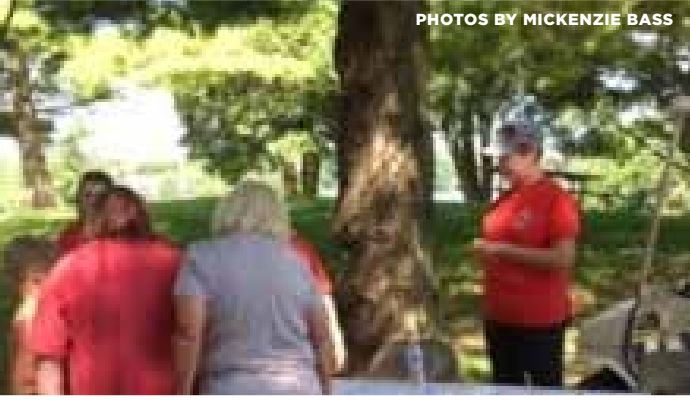


Milking Cows at Apple Canyon Lake

CONSERVATION CONVERSATIONS

WILL YOU BE A HERO?

Last month our lake consultant Joe Rush wrote about the dangers of transporting aquatic plants and animals into our lake. This month I will tell you about the other two parts of the Illinois Department of Natural Resources “Be a hero – transport zero” campaign.

Invasive plant species are a problem throughout Illinois. Two big troublemakers here at ACL are garlic mustard and bush honeysuckle. Once established, invasive species are usually really difficult to eradicate. There are a variety of reasons why plants like these were not a problem in their original ecosystems, but turn invasive when introduced into a new environment. In areas where they originated there were probably natural predators, competitors, and pests to keep them under control. In their new environment, their ability to mature and grow quickly as well as produce a high number of seeds or easily proliferate in other ways allows them to out-compete native plants.

When Illinois natives are displaced by invasives a chain of problems can begin. In some cases, the insects that rely on native species for specialized breeding and nutritional needs begin to decline in numbers. In turn, birds and animals that depend on these insects for a major part of their diet also suffer. Garlic mustard shades out other plants and produces a chemical that can prevent native plants from growing around it. Nothing eats it, not even deer. Although the honeysuckle produces berries, the fruit is a poor nutritional substitute for native plants in the diet of our permanent bird residents.

What can you do? Start by leaving all plants and other materials in their place. Moving plants and the soil around their roots can spread seeds, roots, insects and their eggs, fungi, and bacteria. Only buy and use firewood that was

produced and distributed locally (think emerald ash borer). Make a resolution to remove invasive plants from your property so they can’t spread any further. Garlic mustard must be pulled and bagged in order to stop an individual plant from reproducing. Some recent research by a group of Illinois botanists suggests that applying basal bark treatment to honeysuckle after injuring the bark is the most effective way to destroy it. If you are really ambitious, adopt a greenway close to your property and begin to rid it of these nasty invaders.

The last part of the three-part Be A Hero campaign is release zero. Mr. Rush gave an example in his article about releasing bait into the lake, but there are other ways invaders can gain a foothold here. Many of the plants and animals sold for water gardens and aquariums can cause harm if released into natural areas. Although not harmed themselves, they can introduce diseases into wild populations, degrade natural areas by limiting biodiversity, and changing how our ecosystem functions. Never release fish, snails, turtles, frogs, snakes, or other animals into the wild. Either find a new owner or seek advice on humane disposal.

Decide to be a hero. Follow the guidelines for removing invasives from any water toys (boats, kayaks, paddleboards, ect.) that have been used away from ACL. Use only locally sourced firewood and don’t bring in plants from other areas. Remove invasives from your yard and consider becoming a Greenway Steward. And never release unwanted fish or animals into nature. You can do it. Be a hero. And share your activities with your children and grandchildren. We need heroes for the future, too.

Voluntary Bluegill Limits

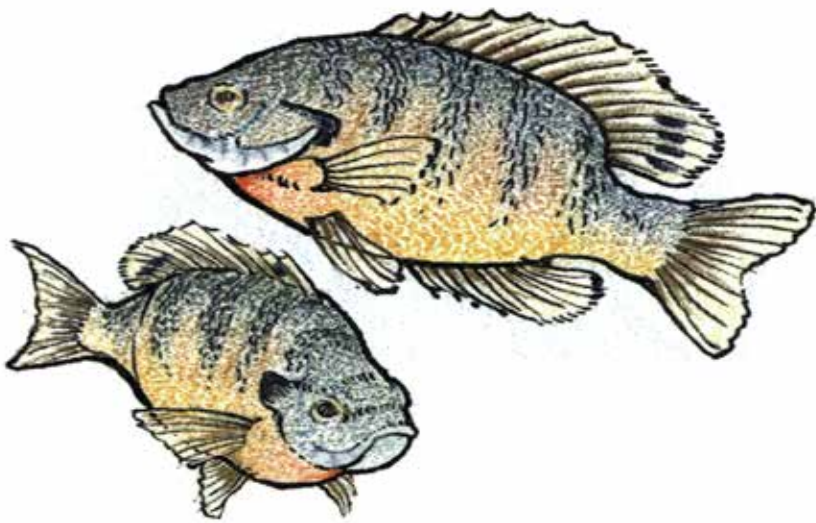

Our lake consultant Joe Rush visited the April Conservation Commission meeting and explained a bluegill creel limit that he experienced at other lakes where he consults. He told us that by reducing the number of large gills – those 8” and larger – in the daily creel limit the population of these more desirable sized fish would increase. At spawning time the large males prevent the smaller gills from reproducing, thereby increasing the overall number of good sized fish. Mr. Rush also estimated that it would take about four years of this creel restriction before fishermen actually saw the effects, but the program had produced a lot of happy blue gill fishermen on the other lakes where it was tried.

The commission discussed the proposal and, along with input from our General Manager Shaun Nordlie, decided to make the creel limit voluntary for this year and possibly 2020 and then evaluate the results. The voluntary creel limit is five bluegill 8” or larger. We realize that these larger gills are much more desirable from both a cleaning and eating standpoint. We also realize that we are asking fisherman to delay gratification now for what we hope will be a more satisfying fishing experience in the future.

This creel limit is voluntary. The Conservation Commission thanks all those who are willing to abide by it now to assure bigger, better bluegills in the future.

ACLPOA Board Approved Policy

THE APPLE CORE: ACCEPTANCE OF MATERIAL

The Apple Core is published by the ACLPOA for the benefit of its Members - to keep them informed about developments with respect to the lake, facilities, activities and finances; to report Board decisions; to provide a handy reference about rules, fees and coming events; and to afford a means of communication on questions and issues of importance to property owners.

The Editorial Review Committee shall consist of a member of the Board, who shall be the Chair; the General Manager, who shall be Vice-Chair; the Editor of The Apple Core, who shall be the Secretary; and such other members as the Board may appoint from time to time. This Committee shall prepare policies for the acceptance of material to be printed in The Apple Core, including, but not limited to, letters to the editor and policies for advertising material printed, which policies shall be submitted to the Board for approval annually.

The General Manager is responsible for having the paper produced. The Communications Director is the Editor. Any and all editorial material (copy other than paid advertising) must be submitted to the Editor's office.

The Editorial Review Committee will determine whether or not letters, advertising material or any other material submitted for publication should be rejected. If material is rejected, property owners will be notified and told cause of rejection.

LETTERS TO THE EDITOR:

Letters from Property Owners are welcome.

Letters to the Editor must be:

- a) Submitted and signed by a Property Owner.
- b) Received by the 15th of the month previous to publication.
- c) Confined to 250 words or less.

The following guidelines for treatment of letters have been adopted for the purpose of encouraging expression of views with the focus on discussion of issues not people. Publication of letters does not necessarily imply agreement or endorsement by the Association or the Board of Directors.

- Whenever possible, letters expressing views on both sides of an issue will be published at the same time.
- Constructive criticism will be accepted. Positive suggestions for improvement are encouraged.
- Letters must be in good taste. Those containing offensive or derogatory language, libelous statements or expressing personal grievances or conflicts will not be published.
- Nothing in these guidelines should be construed to prohibit references to people so long as an issue of importance is the focus of the letter.
- Editorial comments will be limited to factual clarification or update on the matter at issue. No point of view will be expressed.

With respect to Board Elections:

- 1) Candidates will be presented in the March and April issues.
- 2) A special section for questions regarding candidates will be included in the March and April issues of The Apple Core. Questions regarding candidates must be received thirteen (13) days prior to copy deadline in order to provide the candidates with the opportunity to respond in the same edition. Candidate responses must be received two (2) days prior to copy deadlines.

Are you familiar with ACL's Flag Notification System?



A Flag system is in place to notify boaters when the lake has been designated as "Closed" or "No Wake."

Why "No Wake" Status?

To protect you AND the Lake

Please be cautious while on the Lake after any storm with a significant amount of rain. It is very important to slow down for a number of reasons. As water depths change and heavy wake batter the shoreline, excess silt and debris goes into the lake. It is bad for the lake and dangerous for boaters.

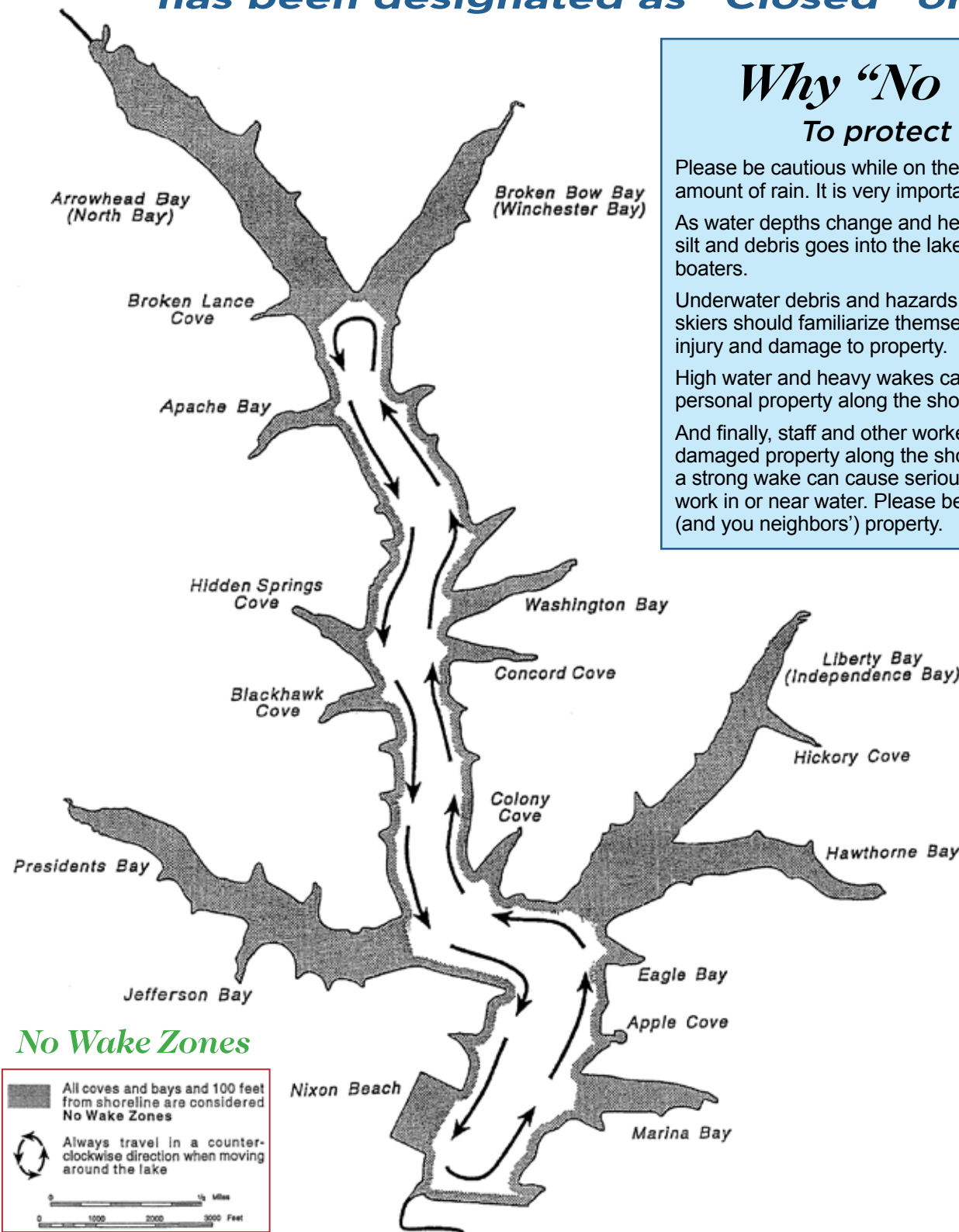
Underwater debris and hazards may exist. Boaters, tubers and water skiers should familiarize themselves with new water depths to prevent injury and damage to property.

High water and heavy wakes cause damage to docks, boats, and other personal property along the shoreline.

And finally, staff and other workers are often attempting repairs to damaged property along the shoreline after any amount of flooding and a strong wake can cause serious injury to someone who is attempting to work in or near water. Please be courteous. Help protect our lake and your (and you neighbors') property.

When the need should arise, RED or YELLOW flags will be posted on the lake where possible, at entrances to Independence Bay, North Bay, Presidents Bay, Nixon Beach, Marina Bay, and at all entrances to Association property.

PLEASE NOTE:
Flags may be affixed to "Trails" signage, however this does not signify that the trails are open or closed.

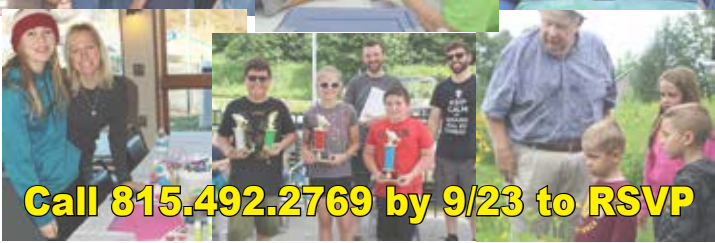
