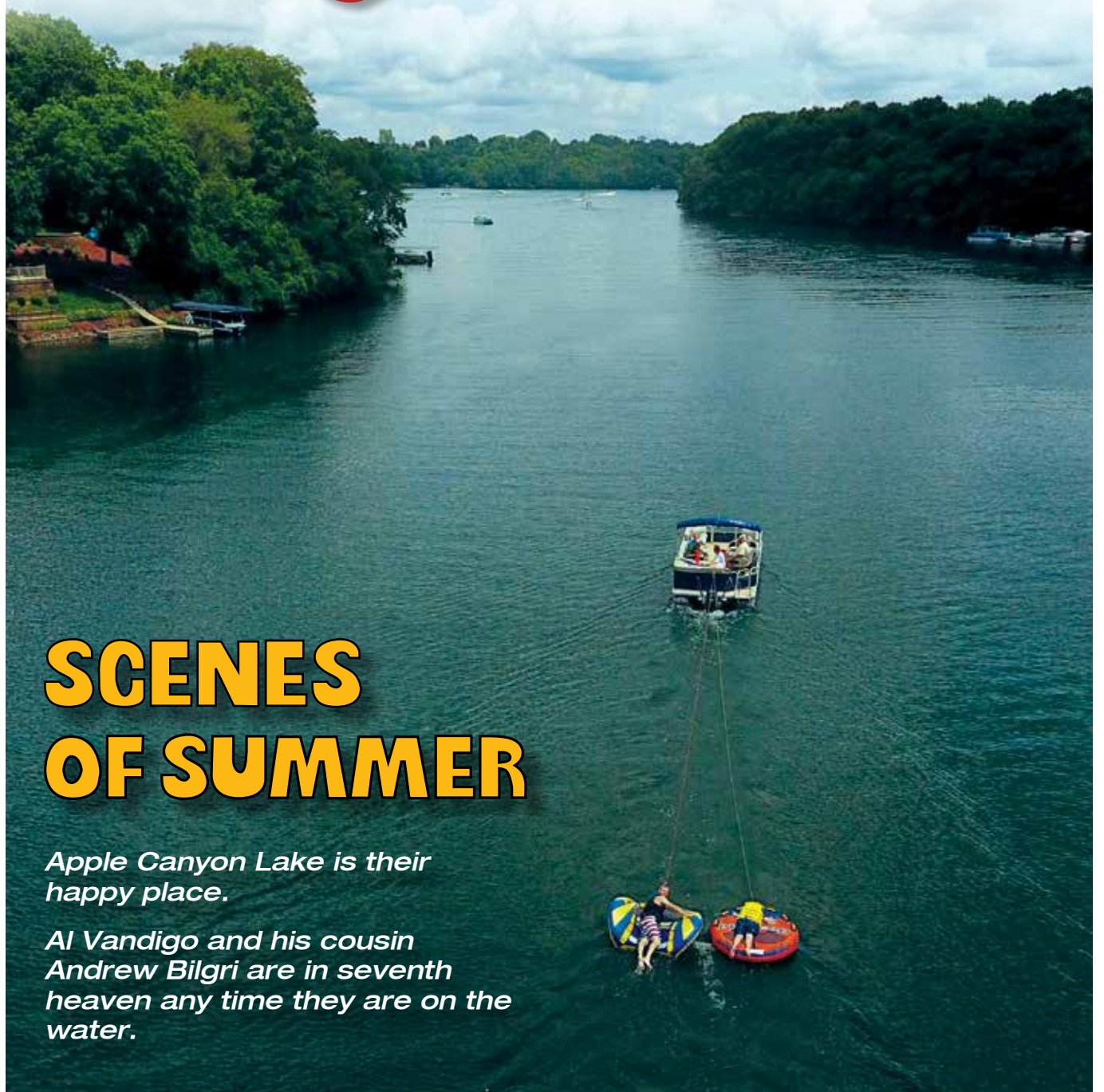

Hopefully, by now you have had a chance to get out on the lake and have some fun. I want to bring you up to date on what we have been doing on the lake and what our plan is for the rest of the summer.

In early May, we started chemical treatment on the Eurasian watermilfoil and Curly-leaf pondweed. Both weeds are invasive, meaning they can overtake a lake or pond if not treated, and both weeds can float off and re-germinate, if cut. For this reason, we prefer to treat these two weeds chemically. Once the water temperatures rise above 50 degrees, we can apply the chemical. If you recall in 2016 we had curly-leaf up in North Bay in June and July. Last year, we harvested the curly-leaf because we did not expect such a large growth. In 2017, since we had the growth in 2016, we were prepared and chemically treated. If you have been on the lake in mid-June you have seen other weeds now coming in where the curly leaf was growing. This is coon tail and elodea. Both weeds are native, which means we do not mind having these weeds in the lake. Coon tail can be aggressive and overtake areas. Since these weeds are native we would prefer to treat them by cutting with the harvester. The harvester did have a maintenance issue in mid-June and we were down for 10 days. Since the harvester has been back in operation, we have been cutting almost every day during the week.

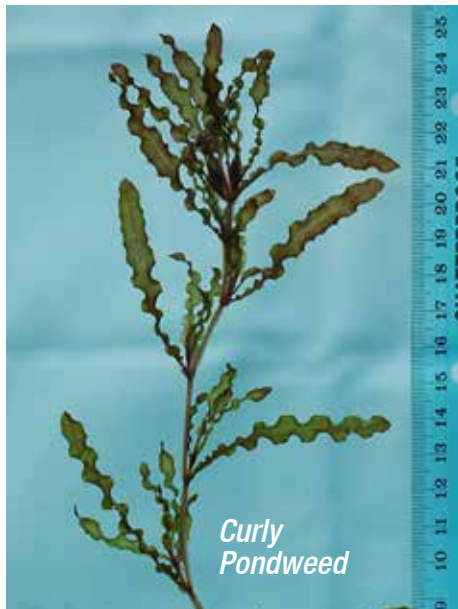
We also added an off load area in North Bay which means that travel time to unload the harvester is minimal. In fact, during the week of June 19, 30 loads of weeds were off-loaded in North Bay.

We also have algae floating and moving around on the surface of the lake. This is filamentous algae, it is not toxic, it just looks bad. We are treating the algae chemically with a surface spray, meaning we spray the top of the algae and the chemical dissolves the algae. Maintenance has also built a rake attachment to the front their work boat. They use this to pick up large clumps of algae and have been focusing on Nixon Beach and the slips around the Cove. The staff at the beach have also been raking the weeds that float to the shore when necessary. We will continue to harvest the coon tail and elodea weeds throughout July and August, and treat the algae as necessary and rake what we can in the high traffic areas. We do not plan to use any more chemicals to treat the lake for invasive weeds, unless a large area of Eurasian watermilfoil would sprout somewhere.

Apple Canyon Lake has a proactive plan to improve the lake quality in the future. We are committed to the Watershed Plan that was approved by the EPA in October 2016. We will begin a project north of the bridge in North Bay this year. This project will decrease the amount of sediment entering the lake at North Bay by redesigning the creek and creating a flood plain. Once this project is complete, when heavy rains occur, the water in the creek will rise and spread out before receding and leaving sediment in the long grass.

The dredge continues to operate and take silt out of the lake. We are concentrating on President's Bay this year; next year we plan to work in North Bay. We had a bathymetric study done on the coves that tells us how much silt we have and how deep the water is in the coves. With this study, we can prioritize which coves should be dredged first and how much silt we have in the small coves to determine if alternative options should be considered.

Nothing Changes if Nothing Changes

This month we review the Vision of Amenities and Service. I feel the above quote is appropriate for this vision. We can accept our amenities and service level as being “fine and acceptable,” and never consider changing them. However, as the quote suggests, if we don’t promote change, nothing will change. The same goes for our Amenities and Service. If we think everything is fine and do not consider change, we will remain the same. But if we look outside the box and ask ourselves “What can be changed?” we can improve our community and make changes for the better.

Here are the updates on the action steps.

- Campground usage and site development is a project I started last year with an occupancy study of the campsites that we rent out on a nightly basis. We currently have nine “improved” campsites that offer water and electricity that we rent out nightly. These popular sites are often booked throughout the summer. We also have tent sites that do not offer water or electricity. These tend to sit open most nights and weekends in the summer. By studying the occupancy of these sites, and figuring the percentage of nights these sites are rented, and how much revenue they bring in each year, we can determine if we should build more campsites, convert tent campsites to seasonal campsites that offer water and electric, or even add more seasonal campsites with permanent campers. We will continue this study through 2017 and determine if we should convert some tent sites to seasonal sites, and whether those sites should be rented on a nightly basis, or used for those on the campsite waiting list.
- Every year we get requests from owners for new items at the Pro Shop and Marina. We consider these suggestions and decide if they would be a good seller or not. One item that is often requested is more breakfast food. This past off-season Terri Stiefel and I visited some local food establishments to get ideas for improving our breakfast options. We are introducing new items this month. Breakfast pizza and breakfast sandwiches will be offered at the Marina, and breakfast burritos will be offered at the Pro Shop. We hope to take this busiest time of the year to try these items and monitor the response from our members. By the time this is published we should have some idea if these will be items

that are offered regularly, or if we need to try something different. Check out the Marina and Pro Shop to see what’s new.

- The Long Range and Strategic Planning Committee looked at lake capacity studies conducted at lakes in the Midwest to determine if it was necessary to do a capacity study on our lake. After researching these studies, conducting boat counts on the lake, and at the marina during busy weekends, and looking at the current rules on boat size and power, it was determined that ACL does not have an issue with capacity on the lake, except for a few weekends in the summer. Since we did not feel it was worth putting restrictions on use of the lake for a few weekends each season, it was determined we do not have a capacity problem on the lake. We are currently evaluating use on the trails and should have those results by the end of summer.
- The Cove Restaurant has a beautiful setting and offers great views of the lake. Sitting on the patio and having dinner with friends and family is tough to beat. The current operator of the Cove is in his third year of a six-year contract. They have learned every year, and I believe, improved during year during year of their contract. As with any restaurant, you get good and bad reviews, but for the most part I have received positive reviews of the Cove. We continue to have a good working relationship with the operators, and want the Cove to be a favorite place for all our owners.
- Department managers are currently in the middle of their budget season. Each year they look at their department and discuss ways to improve service here at ACL, and improve amenities for you. We have areas throughout the property that can offer many new amenities for our owners. When I was sitting in the interviews for CAMP in June, we talked with many talented Landscape Architects who know how to design an area like the lower 80 and master plan the total acreage with amenities for owners of all ages and take the best advantage of our space. We will hire a firm for the Clubhouse Area Master Plan in July. It might be in our best interest to have them design a plan for other areas around ACL at a later date and continue to increase or improve our amenities.

JUNE 17, 2017

- 2.0 Call to Order – President Jody Ware called the regular meeting of the Apple Canyon Lake Property Owners Association to order at 9:01 a.m. on Saturday, June 17, 2017.
- 3.0 Pledge of Allegiance – After the Pledge of Allegiance, a quorum was present with the following directors in attendance: Jody Ware, Barb Hendren, Gordon Williams, John Diehl, Mike Harris, Gary Hannon, John Asta, and Bob Ballenger. Jon Sonntag was absent. General Manager Shaun Nordlie was also in attendance.
- 4.0 Orders of the Day –
 - Bob Ballenger motioned "to nominate Jody Ware for President of the Board of Directors." Seconded by Mike Harris, motion carried unanimously
 - Barb Hendren motioned "to nominate Bob Ballenger for Vice President of the Board of Directors." Seconded by John Asta, motion carried unanimously.
 - Gordon Williams motioned "to nominate Barb Hendren for Corporate Secretary of the Board of Directors." Seconded by John Asta, motion carried unanimously.
 - Mike Harris motioned "to nominate Gary Hannon for Treasurer of the Board of Directors." Seconded by John Asta, motion carried unanimously.
 - Jody Ware welcomed John Diehl and Mike Harris to the Board of Directors. Jody Ware also congratulated Gary Hannon for his continued service.
- 5.0 Approve/Adopt May 20, 2017 Minutes – Gordon Williams motioned "to approve the May 20, 2017 minutes." Seconded by Gary Hannon. Motion carried with Mike Harris and John Diehl abstaining.
- 6.0 Treasurer's Report – Shaun Nordlie reported that right before Memorial Day we were hit with a ransomware that affected the financial package we have with our system. We are re-entering April and May numbers. We will discuss three months of financial information next month.
- 7.0 Committee Reports –
 - Maintenance Committee – Barb Hendren reported that the committee met on June 6. The HVAC proposal for the Cove has been submitted to the Budget Committee. Rick has been asked by Henry Doden about a geothermal system. Tubes would have to be more than 20 feet below the water, concern about boat anchors. Tubes could be in the ground that could be cooled by lake water, but we do not space for cooling there. We could use water coolant units, but the cost is twice as much as gas fired. Dredging is taking place in President's Bay right now; we continue to spray for weeds; and are still working on the trails. A discussion was held about going to quarterly meetings.
 - Lake Monitoring – Gary Hannon reported that on Tuesday, 6/13, clarity of the lake was tested. The lake is at 9'10", whereas last year it was at 13'5". The dissolved oxygen is down to 16', whereas last year it was at 13'. Temperature is at 76.6 degrees, last year it was 72 degrees.
 - Golf Committee – Fred Turek reminded everyone about the Big Cup Tournament next month (7/15), the money raised is to oversee the fairway, \$45.00 for meal, golf, and prizes along with more activities.
 - Campground – Gordon Williams reported that the committee met on May 27 for final preparation for the Pancake Breakfast. They are starting to discuss budget. Water quality at the campground was also discussed and the testing of the water. The campsite waiting list was discussed – waiting list vs. lottery.
 - Recreation - John Diehl reported the committee has been very busy planning some events. Golf Cart Parade, Farm Fun Days are coming up, Kids Camp, Trail Trekker Color Run/Walk on July 29, concert at the beach in August, and September Ice Cream Social. We are soliciting volunteers for those activities. Jody informed everyone that there are sign-up sheets for volunteers available for these events.
- 8.0 General Manager's Report – Shaun Nordlie gave everyone an update on the lake. In early May, the lake was chemically treated for Milfoil and Curly Leaf. These are dying off at North Bay but Coon Tail is in its place. Coon Tail is a native and we would like to have this in the Lake but unfortunately it can get very aggressive. We are harvesting this but the harvester went down on June 9th, needs a new radiator. The plan is to put in the new radiator on Monday and keep cutting on Tuesday; Off loading in Winchester is very time consuming. Maintenance will create an off-load spot at the end of North Bay rather than Winchester. This will make us more efficient. At this point we have no plans for more chemical treatment other than surface spraying for algae and that will be done all summer. Coon Tail will be harvested all summer. We will continue the dredging at President's Bay then move to North Bay next year.
- 9.0 President's Report – Jody Ware reported that the Executive Committee of the Board of Directors evaluated General Manager Shaun Nordlie. He has 14 short and long-term goals and the committee met to review his progress on the short-term goals. An important topic that Jody wants every member to know about is CAMP (Clubhouse Area Master Planning). We interviewed 4 architectural firms to design a clubhouse master planning area design from the tennis courts, old fire house, parking lot, this clubhouse (which is a main priority) and down to the point. Hopefully, at the July 15 Board meeting CAMP will make a recommendation to the Board for the firm to design our master plan for the area. We need membership awareness

- 10.0 Property Owners Comments
 - Henry Doden, 13-129, reported that he talked to Shaun about 350 ft. of shoreline in front of his house, generally there is 8-15 ft. of lily pads along that shoreline. He counted eight. Lily pads are considered very beneficial. He noticed in the Annual Report that the total income for 2016 and divided by 365 would equal \$10,264.00 per day coming in. We spent \$8,035.00 per day. This is a good size operation, yet, we hear very little about what is going on financially. He also commented on the Golf Course and Pro Shop supposedly lost \$84,000 last year. Pro Shop lost \$90.66 each day using 364 days. Why are we giving our employee discounts on meals when losing money? Henry also passed around some photos of Koester's Pond and of the Territory. Territories have put berms to protect the lake.
 - 11.0 Consent Agenda
 - 11.1 Committee Changes – Bob Ballenger motioned "to approve the consent agenda items: Committee changes (to appoint Ric Ruffolo to the Campground Committee and Steve Tribbey to the Architectural & Environmental Control Committee (AECC); and to accept the resignation of Bob Stanger from the Maintenance Committee." Seconded by Mike Harris, motion carried unanimously.
 - 13.0 New Business
 - 13.1 Unauthorized Use of Amenity Tags – Mike Harris motioned "to uphold the rule: sale, or unauthorized use of Association Amenity Tags violation of \$500.00 for first offense and suspend membership rights of the Property Owner for 30 days." Seconded by Gordon Williams. Gordon Williams wanted to commend the security for staying sharp and doing their job. This type of action should not be permitted. Motion carried unanimously.
 - John Diehl motioned "to suspend Robert's Rules of Order." Seconded by Gary Hannon.
 - 13.2 Archery Range Rules and Regulations – First Reading – Jody Ware explained that this was the first reading of the rule and next meeting we will take action. She also explained that the current archery range rule bans the use of arrows tipped with broad heads. At conflict with this rule is the Deer Management Committee requirement for hunter qualification, which requires a hunter to use the equipment he will use in the field which would include broad heads. The rule change wording must include verbiage indicating that the archer must use only a target brought to the range by him/her and any broad head practice must be designated to a specific area of the range. The only exception to this rule would be during hunter qualification. John Sershon explained the quarry is not being maintained and it is difficult to shoot. The Committee is trying to develop and complete an Archery Park Plan. If we put in a small archery park, we would have a designated area along with designated times. A typical broad head target runs close to \$100 each, which is why we would require they bring their own target. Possibility of a fee based archery park, some have fees, some do not. The plan for the quarry area is to clean it up quite a bit after the holiday.
 - 13.3 Boat Length Rules and Regulations – First Reading – Shaun Nordlie reported that after the May meeting, we looked at our definition, how others measure boats, and how to define and show exactly how we measure our boats (bow to stern). After some research, and looking at how other associations define and measure their boats, it was determined to use length overall as our measurement. No platforms included with the measurement. This gives us a better definition of what we are measuring, and will also put consistency into the rule. Will put this change on the agenda for the July board meeting for vote. Molded deck (platform) is not included in the length.
 - Bob Ballenger motioned "to reinstate Robert's Rules of Order." Seconded by Gordon Williams.
 - 13.4 Update to the Amended Declaration to Comply with CICAA – Bob Ballenger motioned "to approve the changes to the amended and restated covenants and restrictions to comply with the Common Interest Community Association Act (CICAA) as recommended by the ACL Legal Counsel." Seconded by John Asta, motion carried unanimously.

ARCHITECTURAL AND ENVIRONMENTAL CONTROL COMMITTEE MEETING

JUNE 3, 2017

UNAPPROVED

- 1.0 Call to Order – The June 3, 2017 meeting of the ACL Architectural & Environmental Control Committee was called to order by Chair Joe Wiener at 8:00 a.m. Committee members present: Joe Wiener, Cindy Zophy, Mike Harris, Jim Frank, Bill Ware, and Bob Ballenger. Also in attendance: Rick Paulson, Shaun Nordlie, Steve Tribbey, Norman Vandigo, Jeff Reeder and Pam Reeder.
- 2.0 Approve Minutes of the May 6, 2017 meeting – Bill Ware moved and Bob Ballenger seconded to approve the minutes of the May 6, 2017 meeting. Motion carried, 1 abstain.
- 3.0 Inspectors Report -
 - 3.1 The new house on Johnson will be complete within the next four weeks.
 - 3.2 The garage on Johnson is complete except for the final grading and moving the propane tank.
 - 3.3 The remodel on Painted Post is completed and occupancy has been granted.
 - 3.4 The new house on Liberty Bell is completed except for final grading.
 - 3.5 The addition on Mustang Lane is under roof and in the interior stage.
 - 3.6 The house on Fair Oaks has the foundation in.
 - 3.7 The new house on Whispering Wind is completed and occupancy has been granted.
 - 3.8 The Fire rebuild on Red Sail is completed and occupancy has been granted.
 - 3.9 The limestone shoreline on Broken Lance will be installed to bring the deck into compliance.
 - 3.10 Septic Inspection letters are being mailed to the homeowners due for an inspection. All septic inspections must be completed by September 15, 2017 to comply.
 - 3.11 Rick Paulson, Mike Harris, Jim Frank, Bill Ware, Bob Ballenger and Joe Wiener visited the properties that will be discussed today
- 4.0 Old Business – From the April meeting section 5.5.2 Work being done without permits. A suggestion was made to require a check to be held without being deposited. If the project is completed without violations, then the check will be returned to the homeowner. To meet this new requirement, additional accounting and inspection staff will be needed. The AECC believes that that a new fine structure is necessary. The \$50.00 fine is not a large enough penalty to prevent homeowners and contractors from working without a permit, working outside of plan and encroaching within the 100-foot lakefront setback without an approved variation. Rick Paulson had recommended changes to Section 106 of the Building and Environmental Code Violations: Procedure, Appeals and Fines section several years ago. Joe Wiener will work with Rick Paulson on these suggestions prior to the July meeting. The committee can discuss the fine structure at the July meeting.
- 5.0 New Business
 - 5.1 8A239 Washington Lane-Retaining wall within the 100-foot lake front setback - Cindy Zophy presented the motion and the motion was seconded by Mike Harris. Motion: To approve a variation for a 12-foot encroachment of the existing asphalt driveway and a new limestone wall at the edge of the existing asphalt driveway into the 100-foot lake front setback for erosion prevention per the submitted plan located at 8A239 Washington Lane for reasons of erosion control. Discussion: Section 112 of the ACC Code Book allows for Driveways, boardwalks, gangways decks and retaining walls may encroach into the setbacks with ACC/BOD approval. Page 11, section 13 of the covenants permits approval based upon practical difficulties. The committee also believe that this retaining wall is necessary due to existing erosion. Motion carried unanimously
 - 5.2 8A148 Liberty Bell - New Home - Cindy Zophy presented the motion and the motion was seconded by Mike Harris. CONSERVATION COMMITTEE MINUTES

3.0 Old Business

3.1 Vandigo stewardship application 12A297 Nixon Lane – Rich Krasula reported the following: Rick Paulson and I met with Norm Vandigo on Tuesday afternoon, May 30, 2017 to review and inspect the second site that Greg Vandigo wants to take on as a Greenway Stewardship project. This site is across Nixon from his house and runs along the cliff overlooking Nixon Beach. The site is several hundred feet long and is completely overrun with honeysuckle and trees. Rick Paulson completed a Greenway Project memo dated April 4, 2017. I agree with it completely, but just wanted to add a couple of suggestions. There is apparently a wire fence running along the cliff, several feet from the edge. However, the bushes are too thick to really get to the fence along most of its length due to the thick bushes. Furthermore, this fence stops as it approaches the house at 12A300 Nixon and there is no protection the rest of the way (this is still greenway). After discussions with Rick and Norm Vandigo (Greg's father) we would suggest that an initial project be to clean out enough bushes so that we can better inspect the fencing all along the edge of cliff. I would be surprised if we found it to be in good shape since it has to be nearly 50 years old. If it turns out to be the flimsy wire fencing that is observed near 12A300, we would suggest replacing it with something more sturdy and secure (e.g., 5 ft high chain link). Once that is completed it would be safe to finish the remainder of the Greenway project. This stewardship application was unanimously approved with the following caveat noted on the application: Project should be done in several steps with the first one being to clean out enough bushes so that the fencing can be inspected before project goes any further.

The Vandigo's have decided to withdraw their stewardship application for 12-292 Lincoln.

3.2 Javadi 3A91 Gen. Sherman – Gary Hannon reported his inspection findings to the committee. Discussion was held and the application was approved with the following caveat noted on the application: remove invasive bushes, shrubs, and plants. Advise Maintenance when work is complete. Do not remove any trees, dead or alive. May clean up existing path, but no new work may be done.

John said that he is still in the process of determining the overall cost for the project and is working with Rick Paulson on aspects of that issue. John said that the plan is flexible in that the complete range does not have to be done all at one time but the overall enclosed area must be secured to provide the required safety aspects. He said that he should be ready to finalize the plan with associated cost by the next meeting.

MAINTENANCE COMMITTEE MEETING MINUTES

JUNE 6, 2017

3.0 Old Business

3.1 Cove HVAC – The HVAC proposal has been submitted to the Budget Committee for the 2018 budget process. Rick asked the principal engineer at MEP Engineers about using a geothermal system and received an e-mail response, which he shared with the group. MEP Engineers has done some ground source systems but never one using a lake. Their opinion is that the lake will not work well for heating due to the fact that the lake water with convection currents gets down to near freezing on its own, and then with additional cooling from the system, ice will form quickly around the tubes and reduce their conductivity. Tubes would need to be placed at a depth of at least 20 feet in the water (we are not sure how deep the lake is there). There is also a concern that boats anchoring in the area could hook the tubes and damage them. (Such as when boats are anchoring near the Cove for an open air concert).

If we want to use a horizontal loop system in the ground next to the lake, it would take a large area (approx. 70' x 100' x 3' for each ton of cooling). Vertical bores would be another option here, but being that close to the lake may not be work because they would have to meet nearly the same requirements as a water well. The cost of vertical bores is about \$2,500 per ton.

Another, more viable option: they have sold an AAON water source heat pump to another customer (which would use lake water for cooling). The cost of that unit was about 2 times the equivalent gas fired air cooled unit.

Rick will advise the Budget Committee about the possibility of using a geothermal system so that they are aware the cost could go up.

Chair Jim said the Board is trying to formulate an approach on how the rules sent to the Board are processed. This recommendation will be presented to the Board at the next meeting for approval. It is for the committee's information only and no action is required at this time. Mr. Petelle said he supports this process for approving rules and asked the committee for their input. Marge Smith made a recommendation that the presence of a committee rep or the chair of the committee requesting the rule, be required at the Board Meeting to answer and rationalize the reason why a rule should be approved. The committee was in agreement.
 - 4.2.2 Boat Length R-17-21 – Mr. Nordlie passed out information he received on the correct way to measure powered boats and pontoons. After discussion, the following motion was made by Fred Pfeiffer and seconded by Marge Clark, "Rules & Regs recommends to the Board to approve the overall length of powered boats to be no longer than 21 feet and pontoon boats no longer than 25 feet. Please refer to R-17-21, Boat Size/Horsepower attached." Motion passed, with one "No" vote (Vickie Sershon).
 - 4.2.3 Archery Range Rule R-17-20 – Jim Petelle passed out copies of the Deer Management Committee's request for a rule change on the current archery range rule that bans the use of arrows tipped with broad heads at the quarry. A discussion followed with Bob Stanger making the motion and Fred Pfeiffer seconded, that "Rules & Regs recommends to the Board to approve deleting from XVIII. Archery, Section C, No. 16. Please refer to R-17-20, "Archery Range Rule Change". Motion passed unanimously.
 - 4.2.4 Deer Harvest Credit R-17-19 – Mr. Petelle passed out copies of R-17-19, Deer Harvest Credit. After discussion, it was agreed this should not be a rule. Mr. Petelle feels this falls under Deer Committee procedures. Jim Petelle reported he wrote a summary of the Deer Committee meetings and decisions that were made. It will be published in the Apple Core and will appear on the same page as the Deer Management Program application to hunt at Apple Canyon Lake.

Governing Documents Updated to Comply with Revised Common Interest Community Association Act 2017

Recent changes made to the Common Interest Community Association Act (CICAA) by the Illinois General Assembly became effective January 1, 2017. Several revisions in the law impact our Amended Declaration and our Bylaws. To comply with CICAA the Board has requested that the Legal Committee prepare the necessary revisions and submit them to the Board for approval.

Under Section 1-60(a) of CICAA, any revisions made to comply with CICAA may be approved by a vote of two-thirds of the Board of Directors, without a membership vote. Section 1-15(b) of CICAA that had made approval by a vote of two-thirds of the Board was deleted and the language was incorporated in Section 1-60(a) with the addition of "inconsistencies" to the title of the section "Errors, omissions, and inconsistencies." Section 1-60(a) states: **"If a provision of the community instruments does not conform to this Act or to another applicable law because of an error, omission, or inconsistency in the community instruments of the association, the association may correct the error, omission, or inconsistency to conform the community instruments to this Act or to another applicable law by an amendment adopted by vote of two-thirds of the board of directors, without a membership vote."**

After review of our governing documents, our Association attorney, Keith R. Jones of Keay & Costello, P.C., has advised the Association to make the following changes to conform to CICAA and the Illinois General Not-For-Profit Corporation Act (NFP Act). The Legal Committee is addressing only those clauses that need to conform to CICAA and can be approved by a two-thirds vote of the Board. Any other

recommended changes will be considered in our continuing work on updating our Amended Declaration and our Bylaws.

Amended Declaration

Preamble, Paragraph 2: This paragraph states that the Amended Declaration was adopted pursuant to Section 1-15(b). As a result of Section 1-15(b) being deleted from CICAA, it is necessary for us to cite Section 1-60(a) that establishes the authority of the Board to make revisions to the document in order to conform to the law without a vote of the membership.

Article I, Section x: Our definition of "Owner" is in question with respect to the use of "equitable owner." Section 1-5 of CICAA's definition of owner, which states that an owner is the "person or persons whose estates or interests, individually or collectively, aggregate fee simple absolute ownership of a unit." The Legal Committee will address this language and draft a revision.

Article III, Section 14: The recommendation states that we should use terms defined in our Declaration regarding our governing documents rather than stating Section 1-35(a) of CICAA verbatim. This section was added to conform to CICAA regarding leasing property at Apple Canyon Lake.

Article IV, Section 2: To correct a scrivener's error in making reference to "ACL lot."

Page 2

Article IX, Section 2. Notices: With the addition of Section 1-85, Use of technology, of CICAA in 2015, we are advised to amend our language to include electronic transmission as an additional means of providing notices to the membership.

Article VI. Board of Directors. Section 1: Section 1-25(a) of CICAA provides for an election of the Board from among the membership of the association. Given the general nature of the CICAA provision, we are advised to delete references to specific qualifications because they may be considered discriminatory and unenforceable.

Article VI. Board of Directors. Section 1: Section 1-35(b) of CICAA provides that "If there are multiple owners of a single unit, only one of the multiple owners shall be eligible to serve as a member of the board at any one time, unless the unit owner owns another unit independently." We are advised to modify our language to conform to this provision.

Article IX. Board Meetings. Section 8, Meetings Open to Members: Section 1-40(b) (5) of CICAA provides for several additions to exceptions to Board meetings being open to the membership. Among the exceptions cited in this section are "(1) discussion of litigation that is either pending or that the Board finds to be probable or imminent; (2) discussion of the appointment, employment, engagement or dismissal of an employee, independent contractor, agent or other provider of goods and services; (3) to interview a potential employee, independent contractor, agent or other provider of goods and services; (4) discussion of violations of the Association's rules and regulations; (5) discussion of an owner's unpaid assessments; and (6) to consult with the Association's attorney." In addition, the most recent changes provide that if the Board only wants to meet in executive session, it can do so without calling a Board meeting with notice to all of the owners. The Board cannot vote at such a separately held executive session; all votes still must be taken during open session of the Board meeting of which owners have been notified. Any of the above items or points not included in the Bylaws need to be added.

Article X. Removal of Directors. Section 1: Section 1-35(c) of CICAA states that "Two-thirds of the membership may remove a board member as a director at a duly called special meeting." We will need to consider our reference to "Voting Member" to conform to this section of CICAA.

Article XIII. Committees. Under the NFP Act our Association committees fall into the category of advisory bodies and do not have the authority to act on behalf of the corporation. They function in an advisory capacity to make recommendations only. These types of bodies are not required to have Board members serving as members on the committee. Only one exception is provided and that is for a committee dealing with the nomination or election of Board members and it is not a requirement. We are advised to modify our committee requirements for Board members serving on our Standing Committees as listed in the Bylaws.

Page 3

Article XIV. Meetings of Members. Section 3, Notice of Meeting: Section 1-85(f) of CICAA, Use of Technology, states that an owner must provide "written to conduct business using acceptable technological means" in order for the Association to send notices to an owner by technological means. It is recommended that we modify our language to include that the Association may provide notice to an owner via one of the methods listed if the owner has given his/her written authorization to conduct business via this method.

Article XVI. Books and Records. Section 1-30(i) of CICAA provides for the right of owners to inspect and copy all contracts, leases or other agreements entered into by the Board. There is no provision requiring an owner to state a proper purpose for reviewing such documents. Therefore, we need to modify our language to reflect the right of an owner without having to state a proper purpose.

All of the points cited above related to the Amended Declaration and the Bylaws can be acted upon by a two-thirds vote of the Board, without a membership vote. That being true, it is the Legal Committee's goal to complete action on the Amended Declaration clauses at our May meeting and to complete action on the Bylaws clauses at our July meeting. As we complete work on each document, our recommendations will be submitted to the Board for action.

Monthly Committee Reports

Approved unanimously.

- 3.0 Election of Officers – Secretary – After considerable approach of all members, Gary Hannon offered to provide committee minutes until another willing secretary can be found.
- 4.0 Old Business
- 4.1 Committee input on trail improvements and safety – There was an expressed concern with large size rocks left behind after grading of trail, predominantly near Hawk Court area and trail extending to marina from Canyon Club Drive. It was also questioned if 3" of stone base is sufficient, should it be thicker. Are we using too big of rock, or perhaps not enough of smaller gravel to cover up larger rocks. The area around Constitution was mentioned with this issue. Henry brought up concern of excessive 'crowning' of trails, too much crowning may cause passing vehicles to slide off trail. While crowning is desired for erosion control it probably needs to be no more than a 2-3 inch crown. Henry mentioned a 'ribbed mat' that rolls up that can be laid down on the trails to help with erosion. George and Shaun asked to see this. George talked about speed bumps as a possible way to help drainage by 'guiding' the water.
- 4.2 Proposed access trail from Winchester Section to the main trail – George passed out a trail map of Winchester, Subdivision 4, with a suggested cart path drawn within the greenway whereas lot owners along Winchester Drive, Springfield Drive, and Marlin Drive could access the main trail. This needs some research by the Trails Committee and Maintenance Department to see if feasible with existing greenway space. It was suggested that maintenance, in conjunction with committee members, scope out (perhaps mow) the suggested new path. Need to determine if lot line pins are needed on lots adjacent to greenway coming from Henry Court, Springfield Drive, Marlin Drive, and Colt Drive. Discussed other issues such as the need for culverts or dry dams.
- 4.3 Discussion of dates to host trail ride with Lake Carroll Trail Committee - It was agreed this is a good idea and we need to make it happen. All members were asked to check availability. It was suggested doing it as a replacement to a future meeting. Next four scheduled meeting dates (last Saturday of every month) would be June 24, July 29, August 26, and September 30. We could entertain Lake Carroll first or vice versa. Shaun and George looking into next 3 meeting months to see if workable. It was mentioned June 24 is Farm Fun Days and marina wine tasting. The July 29 meeting is the trail trekker 5k, pancake breakfast, and beer tasting. With weekends being busy we may have to look at a weekday or a Sunday afternoon option.
- 4.4 Ideas for the 5-year plan – The message delivered was that we need to be persistent in our wants and ideas. Not all wants will come to fruition and not all ideas are feasible but perseverance eventually can pay off. Continue to bring priorities to the board, modify them if necessary and do the needed research so the board becomes educated. The 5-year plan was discussed last month with several items being mentioned, which include: Straightening out the trail where it crosses Apache, (this was said it could possibly be done this year), North Bay water crossing, possible expansion of trail system within ACL, and feasibility to interconnect with other city trails. Discussion ensued on the North Bay crossing with a desire to keep the water crossing yet have an option for a dry crossing. Could we extend trail to the road and cross at existing road bridge, can we put spancrete above or below the creek, if so what size culverts would we need. Options need to be researched and it was mentioned the trails committee should do some homework and present options to maintenance and the board. George will reach out to the Corp of Engineers to see if they have any thoughts. Research by committee members was encouraged.
- 4.5 Other Old Business - None.
- 5.0 New Business - None.
- 6.0 ACL Department Reports
- 6.1 General Manager – Shaun expressed a concern that the committee is losing members due to perceived lack of getting things done. Need to revitalize the members, recruit additional interested parties and continue the charge set forth. Perhaps we need to add/change/update the committee charge to ensure everyone is on the same page. Shaun suggested riding the trails with Rick Paulson and/or a Board member (perhaps in lieu of a meeting) to discuss concerns and issues. As a follow up from last meeting, Shaun will be talking to Dean Williams regarding UTVs on country roads.
- 6.2 Maintenance Department – Trail grader still being researched to ensure it works for our needs. This is a vital piece of equipment for trail maintenance. It was suggested to call Rick Huizenga from Evergreen Landscaping who has a 'drag behind' grader to see if that will work on the trails.
- 6.3 Security Department – Security started doing shifts on trails, found a UTV on trails after 10pm, gave warning. Discussion ensued on what to do with trespassers. We cannot detain but will record vital information for future use. An easy to use form is being created by Shaun/Julie for this purpose. Julie also creating a checklist to help security personnel with reporting of radar and UTV measurement checks. Speed limit came up again, consensus of committee was 25mph but came back from Rules and Regs (several months ago) as a 15mph recommendation. That recommendation did not pass, should the committee revisit. Deb expressed that guests of owners are not informed of trail rules which leads to many of the issues we see.
- 7.0 Next Meeting Date – June 24, 2017 at 9am in the clubhouse
- 8.0 Adjournment - Meeting was adjourned at 10:00am

A Flag system is in place to notify boaters when the lake has been designated as "Closed" or "No Wake."

Why "No Wake" Status?
 To protect you AND the Lake
 Please be cautious while on the Lake after any storm with a significant amount of rain. It is very important to slow down for a number of reasons.
 As water depths change and heavy wake batter the shoreline, excess silt and debris goes into the lake. It is bad for the lake and dangerous for boaters.
 Underwater debris and hazards may exist. Boaters, tubers and water skiers should familiarize themselves with new water depths to prevent injury and damage to property.
 High water and heavy wakes cause damage to docks, boats, and other personal property along the shoreline.
 And finally, staff and other workers are often attempting repairs to damaged property along the shoreline after any amount of flooding and a strong wake can cause serious injury to someone who is attempting to work in or near water. Please be courteous. Help protect our lake and your (and your neighbors') property.

When the need should arise, RED or YELLOW flags will be posted on the lake where possible, at entrances to Independence Bay, North Bay, Presidents Bay, Nixon Beach, Marina Bay, and at all entrances to Association property.

PLEASE NOTE: Flags may be affixed to "Trails" signage, however this does not signify that the trails are open or closed.

No Wake Zones
 All coves and bays and 100 feet from shoreline are considered No Wake Zones.
 Always travel in a counter-clockwise direction when moving around the lake.

RED FLAG means the lake is CLOSED for all watercraft
YELLOW FLAG means the entire lake is at NO WAKE speed

The above activity resulted in YTD Operating Revenues greater than Operating Expenses by \$292,917, which was over budget by \$148,378.

During April the annual budgeted contribution of \$511,500 was transferred from the Operations Fund to the R&R Fund. Also during the month, the 2017 installment for the pool payoff was transferred from the Operating Fund to the R&R Fund via the Capital Projects Fund. The remaining internal debt to the R&R Fund is currently \$209,901 to be paid in 2018.

R&R expenditures for April were \$5,955, mostly for Trails and a Minnow/Bait Cooler. YTD R&R expenditures were \$254,359.

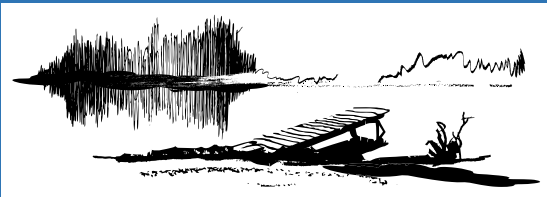

The Safety and Security Department cannot accept any paperwork or issue decals, this must be done at the office. Please call us before coming to the lake to ensure your insurance, registration, etc. is up to date. Most insurance companies are not open on weekends, and we cannot issue a decal if all required paperwork is not on file. An insurance card is not acceptable, because the Association must see what vehicle/watercraft is covered, the amount of liability coverage, the expiration date of the policy, and in the case of vehicles used on the trails, that ACLPOA is listed as Additional Insured or Additional Interest on the policy. All insurance and registration must be in the property owner's name. Illinois State Watercraft Registrations expire every three years on June 30. If your Watercraft Registration expires this year, renew online at <https://www.il.wildlifelicense.com/vehicle.php?action=vehiclelkup> and print the renewal confirmation page. ACL will accept this renewal confirmation page as evidence of registration until the new registration card and decals arrive in the mail. We cannot accept a telephone confirmation number as evidence of renewal.

Voter turnout remains low, with less than one-third of the 2,743 allowable votes cast. This year, 34 of the ballots returned were invalid. They were eliminated for several reasons including no ballot envelope, invalid signature, no signature, and voted for more than three. The property owners elected to the Board of Directors represent you in important plans and changes. Please keep the importance of this vote in mind next May. Thank you to all the candidates who ran for the Board this year. The directors elected are John Diehl, Mike Harris, and Gary Hannon. If you are interested in running for the Board, please contact the Nominating Committee or the office.

The office continues to receive daily calls from property owners seeking a sub-licensed boat slip assignment for the remainder of the 2017 season. If you have an Association-licensed boat slip and you do not plan to use it this season, please enter it in the ACL Sub-License Program! Doing so will result in a \$150 refund to you, and another property owner can use the slip this year. The sub-license will automatically terminate December 31, 2017. Please contact the office for a form or more info! Please note that any sub-licensing conducted outside of the ACL program is unauthorized. Any unauthorized sub-licensing can result in the license holder permanently losing their boat slip and loss of lake privileges for the remainder of the calendar year for the person sub-licensing the slip without ACL authorization. The Safety and Security Department will be checking the boat-to-slip registration, looking for this unauthorized sub-licensing.



Private Docks must display ACL Lot Number

In accordance with the ACL Building Code, all private boat docks at Apple Canyon Lake must display the owner's lot number. The lot numbers must be placed facing the water, and be at least 4 inches in height and of contrasting color to the dock. It is necessary that Safety & Security, and area emergency personnel can identify your property address from the water. In addition, if damage is done to your dock or it floats away, it is easily identifiable. By complying with this request, you are ultimately improving the life safety of the lake for everyone.

Although snapping turtles have fierce dispositions, when they are encountered in the water, or when swimmers approach, they will slip quietly away from any disturbance or may seek shelter under mud or grass nearby. Common snapping turtles are very aggressive if caught, and have a strong enough bite to easily amputate human fingers.

If you did not receive a ballot . . .

for the Board of Directors election, it is likely that a Voting Member was not designated for your lot. If the property is owned by a trust or other legal entity, there is no automatic designation and a ballot will not be mailed. If you have not yet designated a Voting Member, you may do so by submitting the Voting Member Designation Form to the Association Office. If you have designated a Voting Member but would like to change it, you must submit the request in writing; the request must be signed by all owners of the lot and include the Voting Member's name, address, and telephone number. The change is effective when received by the Association. If the lot is owned by a legal entity, the written request must include the name, address, and telephone number of the Voting Member and their spouse, in accordance with the Bylaws. These changes must be approved by Board of Directors. If you have any questions, please contact the Association Office at (815) 492-2238.

Voting Member Designation Form

In compliance with the Amended and Restated Covenants and Restrictions, each lot must designate a Voting Member.¹

¹**Article IV, Section 2.** *The Owners of each Lot or Dwelling shall designate one Natural Person as the Voting Member for said Lot or Dwelling. Only the Voting Member, as defined in Article I, Section 1(x), shall be entitled to vote at any regular or special meeting of the Association, and only the Voting Member shall be sent notice of any regular or special meeting of the Association. In the event there are multiple Owners of a Lot or Dwelling who are Natural Persons, including their spouses, and they fail to designate one Natural Person as the Voting Member, the first person named in the deed conveying title to the Lot or Dwelling shall be deemed to be the Voting Member. In the event a Lot or Dwelling is owned by a Legal Entity, it shall designate one Natural Person to be the Voting Member. The failure of a Legal Entity to designate a Voting Member shall be a bar to the right to vote on any matter, and the vote of such Lot or Dwelling shall not be counted for the determination of a quorum.*

The Association has two pontoon boats available for rent on a daily or half-day basis. All reservations must be made by a property owner or authorized guest. Property Owners must contact the Association Office to give their permission for a guest to make a reservation. Property Owners are reminded that they are responsible for the activities of their guests, and any violation of the rules by a guest or the cost of damages in excess of the security deposit will be charged against the Property Owner. All boats will be checked in and out of the Marina. An Amenity Tag must be presented to the Marina staff by the lessee. Each boat has a capacity of ten (10) persons. Ten (10) adult-size life jackets are provided. Lessees must provide their own life jackets for children and infants. Anyone who leaves the boat to access Nixon Beach, the Marina Bay Trail, etc. must have an Amenity Tag.

Effective January 1, 2016, the Illinois Boat Registration & Safety Act has been amended and now requires that any person operating a rental boat submit a valid Boating Safety Certificate or complete an abbreviated safety course prior to operating the watercraft. A copy of a valid Boating Safety Certificate must be provided to the Association Office by the rental boat operator at least 24 hours in advance of the rental, or completion of the abbreviated safety course at the Marina will be required. Rental boat operators taking the safety course must arrive at the Marina at least 30 minutes prior to the rental. Rentals will not be extended if the rental boat operator fails to complete the course prior to rental start time. Anyone taking the abbreviated safety instruction course must provide the Association with a copy of their driver's license and complete course paperwork, per the IDNR Watercraft Rental Safety Policy. Upon completion of the abbreviated course, a completion receipt valid for one year will be issued.

Reservations for rental boats will be accepted during normal Association Office hours in person or by calling 815-492-2238. Reservations should be made at least 24 hours in advance of the rental. Same day reservations can be made at the Marina. When the reservation is made, payment for the rental must be made in full via credit card. The lessee may choose to pay the \$300 security deposit at the time of the reservation, or at least 24 hours in advance of the rental. All security deposits must be paid with a credit card. If the lessee fails to pay the security deposit at least 24 hours in advance of the rental, an additional \$50 Late Deposit Payment Fee will be charged. If the boat is returned after hours, the renter fails to have the boat inspected, or the lessee fails to refuel the boat, a \$50 fee will be retained from the security deposit. Upon return of the boat in same condition, the security deposit will be returned to the credit card on which it was charged. The Association will make every attempt to refund deposits within 72 hours of the rental completion. Please be advised that the credit card company may not process the refund immediately.

Cancellation policy: In the event of severe weather on the day of the rental, the rental amount and security deposit (if already paid) will be returned to the credit card on which it was paid. If a rental is cancelled for any other reason with less than 24 hours' notice, including no shows, the rental fee will not be refunded. Any security deposit paid in advance will be refunded to the card on which it was paid. Any rentals cancelled with at least 24 hours' notice will be refunded the rental amount in the form of an ACL Gift Card which can be used at the Association Office, Pro Shop, Pro Shop Bar & Grill, and the Marina. ACL Gift Cards cannot be used at The Cove restaurant. Any security deposit paid in advance will be refunded to the card on which it was paid.

Newly registered boats, ATV/ UTVs to be measured

Beginning January 1, 2017, the Association will resume measuring any newly registered watercraft with a length of 19' or greater stated on the Watercraft Registration, and any newly registered ATV/UTV to ensure the vehicle is less than 66" in width. Both size restrictions are in accordance with ACL Rules and Regulations. Regarding watercraft, section V Boating, C.



Boat Size/Horsepower, states:

1. Powered boats, with the exception of pontoon boats, shall be no more than 21 ft. in length from bow to stern, excluding attachments... If watercraft registration shows boat length of 19 ft. or greater, boat must be measured prior to registration with ACL.
2. Pontoon boats shall not exceed 25 ft. as measured from the forward most point of the pontoon(s) to the aft most point of the pontoon(s)." Regarding ATVs and UTVs, section XI Motorized Vehicles-Recreational, F.

Operation Limitations on operation of All Terrain Vehicles (ATV) and Golf Cart, states:

13. All motorized recreational vehicles shall be 66" or less in overall width." Any boat newly registered with Apple Canyon Lake, which has a length of 19' or greater listed on the Watercraft Registration, must be measured at the Association Office before a watercraft decal will be issued.

The same procedure will apply to any newly registered ATV or UTV before a trail decal will be issued. If a property owner is unable to reach the office prior to closing, the office staff will make reasonable arrangements for that property owner to meet with the Safety and Security Department to have the watercraft/vehicle measured and the decal given, provided all paperwork is on file, and the registration fee has been paid in advance. The Safety and Security Department will not accept any paperwork or payments. Please allow extra time for staff to complete these measurements. If the office staff is occupied with other owners, the Safety and Security Department will be called to assist.

Yes, you do need a fishing license at Apple Canyon Lake!

There is some confusion about fishing license regulations at Apple Canyon Lake since our lake is private for our property owners' use only. Per the Illinois Department of Natural Resources, exemption from fishing licenses does not apply to club and organizational lakes or lake developments (ILCS 515). Everyone must have a fishing license to fish in Illinois, unless they meet one of the following requirements: being under 16 years of age, an Illinois resident who is disabled or blind, or an Illinois resident on leave from active duty in the Armed Forces. Please keep in mind that if you take your children or grandchildren fishing, you must have a fishing license if you help cast, set hooks, reel in fish, etc. Fishing licenses can be purchased online or at an IDNR terminal such as our own Marina. An annual Resident Fishing License is only \$15. There are several options for non-residents, including daily and weekend licenses. Resident seniors aged 65 and older receive a reduced rate on fishing licenses. Licenses expire on March 31 of each year, new licenses can be purchased starting around the third week of January. ACL thanks Campground Committee chair Kathy Richards and her Committee for their part in the annual event. It is a tradition worth coming out for.

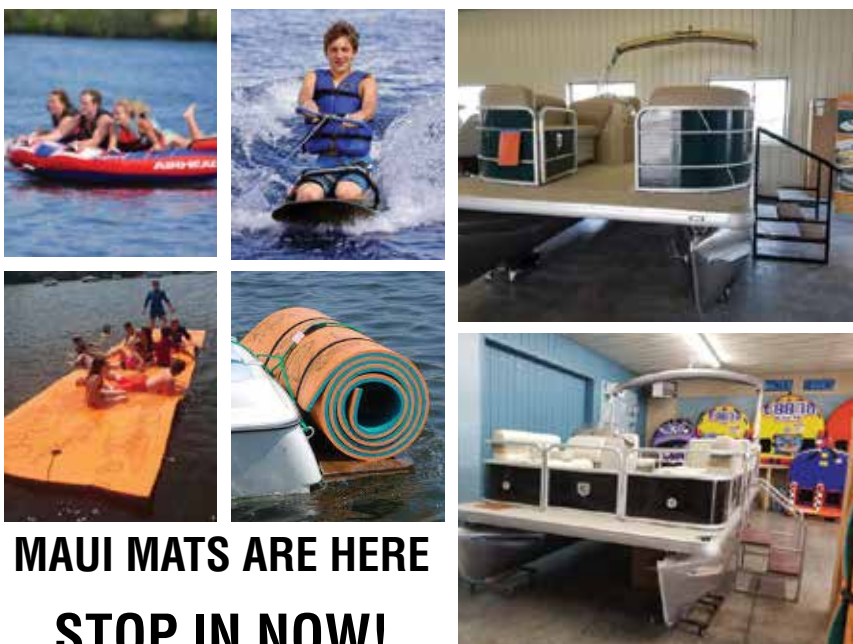

Apple Canyon Lake Watershed BINGO

Whether it's fishing, boating, tubing, swimming, trail riding, or hiking there is always a lot to do at ACL during the summer season. But to boost your attention and help your children and grandchildren develop the knack for observation, we offer a game of Watershed BINGO.

You can find all of these things in the ACL Watershed. Play just like regular BINGO – find four across, up and down, or diagonally, or do a cover-all if you are really ambitious.

•••••

TURTLE – has a long life doing mostly nothing

RIP RAP – the rocks used along shorelines and stream banks to prevent erosion

DEER – backyard feeding stations and salt licks are against the law due to chronic wasting disease

STREAMBANK EROSION – when streams can't spread out over a flood plain, erosion occurs and the stream bed becomes deeper and deeper, causing even more erosion

A POLLINATOR – bees, butterflies and even hummingbirds carry pollen from one plant to another

DEAD TREE – provides a home for small animals and birds and an insect habitat that provides food for a wide range of creatures

ACL WATERSHED SIGN – look for signs on roads surrounding the community that signal you are driving through the ACL Watershed

TURKEY – eliminated from Illinois by 1910 due to overhunting and habitat loss, the wild turkey is back and doing well after its reintroduction

CANADA GOOSE – these birds return to wherever they were born to mate and raise their families. This can cause overpopulation.

PRAIRIE – the plants have very deep root systems that keep the soil from eroding and reduce run-off during heavy rains

SQUIRREL – found in all Illinois environments: urban, suburban, and rural. A bird feeder nuisance.

OAK TREE – the land around ACL was originally an oak prairie

HERON – look closely along shorelines in shallow water for this statuesque bird as it stands motionless waiting for its dinner to swim by (don't mistake it for an egret)

ASIAN LADY BEETLE – this invasive species besides being a nuisance, emits a foul odor and can stain surfaces with their yellowish secretions when disturbed

Bat – a valuable predator that keeps the insect population under control

Conservation Conversations

ACLPOA hosts Illinois RiverWatch Training

On June 3 a new batch of RiverWatch citizen scientists learned how to monitor the macroinvertebrates in the streams feeding Apple Canyon Lake. The types and number of critters present indicate the health of the stream.

The Illinois RiverWatch Network is a volunteer stream monitoring program that seeks to engage Illinois adults by training them as Citizen Scientists. Each year at adopted stream sites in their communities, Citizen Scientists conduct habitat and biological surveys, including the collection and identification of small stream organisms called macroinvertebrates that serve as bioindicators of water quality. The program strives to collect consistent, high-quality data on the conditions of local streams and provide citizens with a hands-on opportunity to be better stewards of our watersheds.

ACL hosts third World's Largest Swimming Lesson Swimming Lessons Save Lives

Cheers to Safety & Security/Aquatics Manager Julie Janssen and the Aquatics Department on another successful World's Largest Swimming Lesson. ACL's participation jumped from 79 last year to 131 registered guests this year. The event was held Thursday, June 22. This is the third year ACL has participated in the world-wide lesson.

ACL hosts the event to build awareness about the vital importance of teaching children to swim to help prevent drowning. Swimming is a life-saving skill for children and a vital tool to prevent drowning, the second leading cause of unintended, injury-related death for children ages 1-14.

The World's Largest Swimming Lesson™ was created in 2010 by the World Waterpark Association to serve as a platform to help local community aquatic facilities and the many different national, regional and state-wide water safety and drowning prevention organizations work together to tell this important story on a local and national level. The WLSL provides programming and materials for purchase to communities and organizations looking to promote their "Swimming Lessons Save Lives" message.

The World Waterpark Association shares these staggering facts:

- Research shows risk of drowning can be reduced by 88% if children participate in formal swimming lessons between ages 1-4. *Source: Archives of Pediatrics & Adolescent Medicine 2009*
- The World's Largest Swimming Lesson™ brings together tens of thousands of individuals from hundreds of communities around the globe who all participate in the same lesson over the course of a 24-hour period to raise awareness about drowning and the fact that swimming is a vital life-saving skill that every child should learn.
- The results from the 2016 WLSL event were amazing. Last year, more than 40,000 kids and adults participated in WLSL events in 24 countries generating more than 200 million media impressions. Aquatic facilities, from Schlitterbahn Waterpark in Galveston, Texas to swim schools in India, to locations in Jamaica, Brazil, Mexico, Australia, the UAE and South Korea, all taught the same swimming lesson with one goal in mind — send the message *Swimming Lesson Save Lives™*.
- Internationally, the World Health Organization estimates drowning is one of the top five causes of death for people ages 1-14 in 48 of the 85 countries it monitors around the globe. Swimming is a vital life-saving skill. Drowning is preventable!

What parents need to know

- Drowning is silent and can happen in seconds.
- Enroll your kids in swimming lessons; learning to swim is the strongest defense against drowning.
- Never leave kids alone in or around water, not even for a second. Put the cell phone away and give young children 100 percent of your attention when they are near or around water.
- Have young children or inexperienced swimmers wear U.S. Coast Guard-approved life jackets around water, but do not rely on life jackets alone.

- There is always risk associated with being in, on and around the water. But, loss of life from drowning CAN and SHOULD be prevented and we have the power to make that happen.
- Being safe in and around the water requires more than just swimming lessons. It requires constant, careful supervision of children, appropriate fencing and safety equipment, protection from hazards, knowing what to do in an emergency, including CPR, and an understanding that safety is a personal responsibility.
- Learning to swim and the exposure to the water safety skills and messages that swimming lessons offer provide a lifelong foundation for drowning prevention.

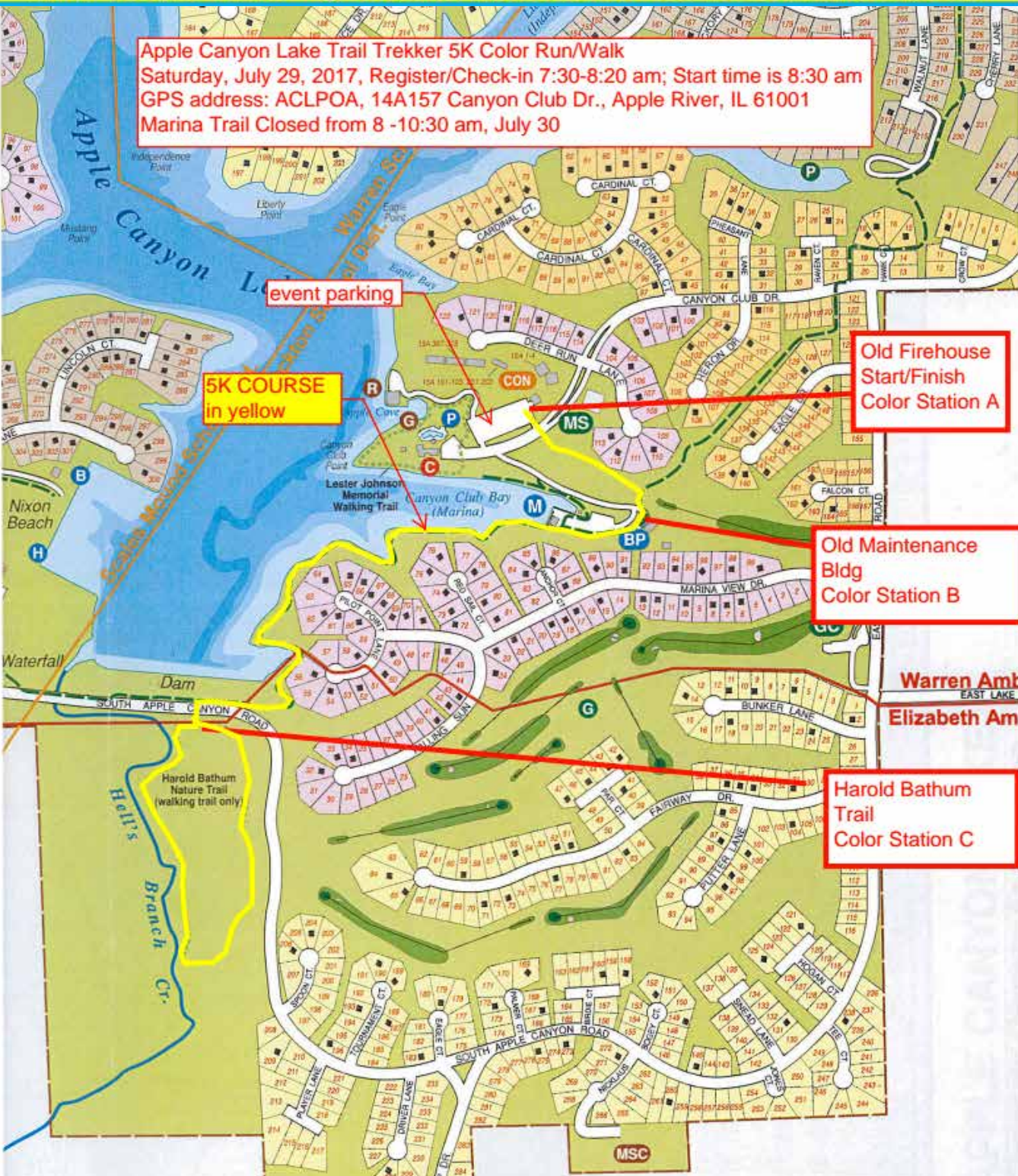

Apple Tree Genealogy: Research, Stories and Questions

REMEMBERING HERITAGE

Research, Stories, Questions by Roger Higgs, Apple Canyon Lake Resident

This column is meant to be helpful in a small way to Apple Canyon Lake residents who have an interest in genealogical research and who may have problems or stories to share.

* * * * *

At the ACL residence of John and Jackie Buckley a memorial has been erected to honor John's father and friends who served in WWII and Viet Nam. The memorial reads "In loving memory of my father, PFC Thomas J. Buckley USMC WWII; who honorably fought and died on Iwo Jima, March 8, 1945 and all my friends I've lost who served in Viet Nam."

John Buckley was about nine months old when his father died in the invasion of Iwo Jima. John never knew his father, although his father held him one time while he was home on leave. (Note: On August 14, 1945, Japan surrendered.) John was only ten days old at this time. On this occasion Thomas walked in the back door of their home just as his mother, Helen, walked in the front door with infant, John.

Thomas J. Buckley is buried at Camp Butler National Cemetery at Springfield, Illinois. Thomas served in the U.S. Marine Corps with a Chicago neighbor, Louis Tedesco. Thomas died in the arms of his friend, Louis when he was fatally wounded in Iwo Jima. Thomas had volunteered to enlist in the Marine Corps because his friends were serving in the war. He could have been deferred because of age, career and family. He enlisted near the end of WWII in the U.S. Marine Corps Reserve on April 11, 1944 in Chicago. Initially, Thomas was buried in the 4th Marine Division Cemetery in Iwo Jima on March 10, 1945. Later, his remains were transferred for burial on March 22, 1948 at Camp Butler in Springfield, Illinois. Thomas received Posthumous Awards including the Purple Heart, Victory Medal and the Presidential Unit Citation.

After WWII, John and his older brother, Jim, were raised by his mother, Helen (Freevol) Buckley. She supported the family mainly through rental income from five rental apartments in a two flat and a four flat in Chicago. John remembered that every winter morning Helen shoveled coal into the furnaces for the apartments. Helen never remarried.

The two sons, Jim and John, had careers as a State Policeman and a construction crane operator, respectively. John spent four years in the Air Force in Salina, Kansas (missile silo) and Guam. His wife, Jackie, was able to join him while he served in Guam, because she had a GS-4 government service rating; which helped provide her employment in Guam.

On the memorial John also paid tribute to friends he lost who had served in Viet Nam. (John did not have enough service time left to serve an 18-month stint in Viet Nam.) His friends died later due to complications from Agent Orange which they encountered while serving in Viet Nam.

FOREBEARS

The forebears of John did not have a military history. John's grandfather was John Owen Buckley (1882-1917) of Chicago. In 1910, John Owen Buckley was a railroad yard master in Chicago. John's great-grandfather was Jeremiah Buckley who was born in 1851 in Peterborough County, Ontario, Western Canada. Jeremiah was born to John and Mary (Reardon) Buckley who were born in Ireland. John and Mary apparently immigrated June 20, 1846 to Montreal and soon to Peterborough County.

John's mother was Helen Freevol (1914-1996) of Chicago. Her parents were Herman Freevol (1883-1968) and Fredricka Osterberg (1886-1965).

Herman's parents' Gunder August Freevol and Anne Hansdotter were born in Norway and died in Chicago. Fredricka ("Freda") parents' were Jons Osterberg and Beata Swenson who lived their lives in Sweden.

In conclusion, John's paternal ancestors are of Irish lineage and his maternal ancestors are of Scandinavian lineage who all immigrated to Chicago

The General Manager is responsible for having the paper produced. The Communications Director is the Editor. Any and all editorial material (copy other than paid advertising) must be submitted to the Editor's office.

The Editorial Review Committee will determine whether or not letters, advertising material or any other material submitted for publication should be rejected. If material is rejected, property owners will be notified and told cause of rejection.


