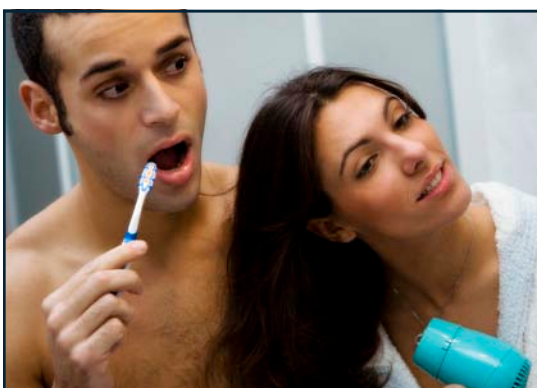
The Apple Core is published in its entirety each month on the Association's web site the same day it reaches local homes via the US Postal Service. See Page 2 inside for local delivery dates.

On May 21, 2016 the Board of Directors passed the revisions to the Covenants to comply with CICA (Common Interest Community Association Act). One of the revisions was the following section that pertains to leasing your home here at

Apple Canyon Lake.

Section 14. Leasing Property, CICA Section 1-35 (a). The provisions of this Act, the Declaration, Bylaws, other community instruments, and Rules and Regulations that relate to the use of an individual unit or the common areas shall be applicable to any person leasing a unit and shall be deemed to be incorporated in any lease executed or renewed on or after the effective date of this Act. Unless otherwise provided in the community instruments, with regard to any lease entered into subsequent to the effective date of this Act, the Unit Owner leasing the unit shall deliver a copy of the signed lease to the Association or if the lease is oral, a memorandum of the lease, not later than the date of occupancy or 10 days after the lease is signed, whichever occurs first.

The purpose of this revision is to inform the Association who is on ACL property. We are not trying to change leases or control leases of property by our owners. We would like to be able to know when you have a guest renting your home for a week or weekend, who they are and where they are staying. This will help us if there is ever an accident involving a renter using a UTV or boat belonging to the owner. If the Association is better informed about the people that will be using the amenities we can be better prepared in the case of an accident or problem. In the next few weeks the Association will be contacting all owners who are licensed with Jo Daviess County to rent their home on a short-term basis. We will be asking for a copy of the lease agreement you have with your renters. I am also interested in what other material you provide your renters about ACL and our amenities. Do your renters know the rules of the Association? Do they know where they need amenity tags and where they are not required to wear them? I hope that ACL and the owners can work together to make this process a positive experience for both parties. It is in the best interest of the owners to have their houses rented, and it is in the best interest of ACL to have the renters know the rules why they are on property and enjoy their time at the lake. Maybe it can turn into a new member for the Association. We will also be looking for owners who rent their homes on a long-term lease (longer than 30 consecutive days). If you rent your home for longer than 30 consecutive days, please contact me at 815-492-2238 or shaun.nordlie@applecanyonlake.org so that we can get a copy of your lease. Since long-term rentals do not need to register with the county we do not have a copy of these rentals. The Association does need a copy of your lease agreements. I hope that we can make this relationship work for the owners and ACL. If you have any questions on this process or why ACL is now requiring this information, please contact me.

President's Message

MIKE HARRIS

This will be my last letter to you as I prepare to leave my position as president of the Board of Directors. I want to take this opportunity to thank you for allowing me the privilege to serve on the Board. Thank you for your support and for allowing me to be part of the leadership team moving our

Association forward.

Over the last month I have been doing a lot of reflecting about how much being a member of the Board of Directors has developed me in making important decisions and being part of a leadership team invested in the best interests of Apple Canyon Lake. Many of the decisions have been very difficult and not always what members were hoping it would be. But, in making those decisions much information was gathered and weighed to assure our decision was the best decision.

As the election of new board members is around the corner, I have been asked what advice I would give a new member of the Board. At the time I was asked, I didn't have a response prepared. But that question has been one that I have been thinking about a lot lately. So, what advice would I give to a new board member?

First, I would remind the new board member that he/she is only one of nine members. Each board member has a role to play. But no one board member has any actual authority. An individual board member's beliefs or ideas are only one-ninth of the entire board's decisions. It is only as a collective team of nine members, working with the General Manager, that the board comes to agreements and leads the Association forward.

My second piece of advice would be to listen. The Association membership voted for the new board member because of his/her credentials and the fact that they trusted him/her. While the new board member was elected to sit in trust and make decisions that, while not popular with some or even most of the community, are essential for the best interest of the Association as a whole. A board member is expected to think of the best long-term solution—not necessarily what is the easiest and least expensive decision—to make the Association a better community to live in or visit. Being trusted to manage the financials and making decisions about spending funds are probably the most difficult decisions for me.

My final piece of advice is that board members belong "in the balcony not on the dance floor." As strange as that sounds, what this statement means is that a board member needs to have a "different perspective" or view. A board member doesn't need to be involved in the "day-to-day" management of the Association other than to observe and note whether the policies that the board has put in place are being carried out reasonably, efficiently, and effectively.

These are my three pieces of advice to a new board member. As I close, I want to believe that a board member has the opportunity to leave a mark and leave a legacy for the Association to endure. I think we all go into the board role wanting to make a positive difference at Apple Canyon Lake. Whatever one's legacy is, being a board member is a special time and memorable. So, again, I thank you for allowing me to serve as a board member and President of Apple Canyon Lake.

BOARD APPROVED CHANGES TO ACLPOA RULES AND REGULATIONS MARCH 19, 2016

Page 6 of Rules and Regulations

III GUESTS

Preamble: Property Owners are responsible for the activities of their guests and any violation of the rules by a guest will be charged against the Property Owner. In order friends and relatives guests may enjoy ACL in comfort and safety.

A. Definitions

- A guest is any invited guest friend, relative, or occupant of a Property Owner using the ACL facilities with or without the Property Owner being present.

V BOATING

Page 10 of Rules and Regulations

E. Waterskiing and Towing Devices

- Boaters towing skiers, tubers, surfers, etc. must display a regulation Red/Orange Flag when the person(s) are "down" or "not actively being towed" but still in the water.
- The operator of any watercraft that is towing a person or persons shall display on the watercraft a bright or brilliant orange flag measuring not less than 12 inches per side. The flag shall be displayed at the highest point of the area surrounding the boat's helm as to be visible from all directions, continuously, while the person or persons being towed depart the boat in preparation for towing and until reentry into the boat when the activity has ceased. Display of the flag for purposes other than the activity described in this section is prohibited.
- Boaters towing skiers, tubers, surfers, etc. must wave a red flag when the person(s) are "down" or in the water.

**BOARD APPROVED CHANGES TO
COMMITTEE PRACTICES AND PROCEDURES, STATEMENTS AND CHARGES
MARCH 19, 2016**

ARTICLE III, COMMITTEE STRUCTURE

Paragraph 1, Sentence 1: A person appointed by the President of the Board of Directors shall chair each ACL committee.

Paragraph 1, Sentence 2: Each committee shall have a chair, vice chair, and secretary who shall be selected by the Committee.

ARTICLE V, CONDUCTING COMMITTEE BUSINESS AND MEETINGS

E. Leave of Absence

When a member of any committee will be absent, excused, for an extended period of time, the member may request a Leave of Absence by completing a Request for Leave of Absence, which is in the Association Office or on the ACL website. If the request is approved by the committee chairperson with notice to the Board of Directors, the committee member will not count in the quorum for a meeting for the duration of the Leave of Absence. Upon return, the member may be reinstated as an active committee member and be included in the quorum for a meeting. No committee shall conduct business with fewer than three (3) members present.

**STANDING COMMITTEES
BUDGET/AUDIT COMMITTEE**

It shall be the duty of this committee to prepare a budget for the fiscal year beginning the first day of January for approval by the Board of Directors and to submit a report of this budget to the membership at the Annual Meeting of Members. It shall be the responsibility of this committee to supervise the Pa

Paragraph 1: The Budget/Audit Committee shall be chaired by the Treasurer and consist of another member of the Board of Directors plus two or more additional Association members. It shall be the duty of this committee to work with the General Manager (GM) to prepare a budget for the next fiscal year beginning the first day of January for submission to the Board of Directors. This committee or its designated member(s) may also: (1) review and consult with the auditors on the annual audit of the Association books; (2) review the adequacy and effectiveness of the accounting controls of the Association; and (3) make recommendations for the improvement of internal control procedures and the correction of any significant financial reporting issues and practices. Additional duties or responsibilities can be assigned by the Board of Directors.

Rules and Regulations Committee begins revisions to Governing Documents

Property Owner input is valuable

In addition to dealing with day-to-day questions on rule changes, the Rules and Regulations (RR) committee is developing a standardized approach to these issues. This approach will consist of a tracking system, a set of criteria, and standardized forms.

This is done because we anticipate a heavy influx of changes to all of our Governing Documents due to the approaching 2016 opportunity to change the Restated Covenants and Restated Bylaws of Apple Canyon Lake, which went into effect in November of 2011.

This procedure is open to all property owners who wish to make suggested rule or regulation changes. We encourage your input.

We have created a form for revision requests that can be tracked. Forms are available in the office lobby and on the Association's website at <http://bit.ly/1GiVFLg>

The form will include the following:

TITLE: Assigned by the RR Comm

TRACKING NUMBER: Assigned by the RR Comm

DATE: Assigned by the RR Comm as received

AFFECTED DOCUMENT: Please identify or stipulate the documents that you wish to change/revise. (i.e. Rules and Regulations, Section VIII ICE FISHING, A, 1.)

DESIRED CHANGE: Please describe the change that you desire. Be as specific as possible. Use additional pages if necessary.

REQUESTED BY: Identify yourself, and include contact phone and email.

Once the form has been completed, please submit to the Association Office to the Attention of Rules and Regulations Committee.

Documents Governing Apple Canyon Lake Property Owners' Association

As of November 6, 2011 Apple Canyon Lake Property Owners' Association is governed by a set of governing documents prepared and approved by the members of the Association, and is no longer governed by the original documents prepared by the Branigar Organization, Apple Canyon Lake's developer.

ACLPOA's Governing Documents include the State of Illinois Statutes Governing Homeowner Associations, commonly known as the Common Interest Community Association Act or CICAA. These documents are the benchmark under which all of our Association governing documents are written. However, changes to the state statutes may be ongoing.

ACLPOA's Primary Governing Documents remain the same from year to year unless there is a vote and approval of the membership before any changes can be made.

These documents consist of:

1. Articles of Incorporation
2. Restated Covenants and Restrictions
3. Restated Bylaws

The Secondary Governing Documents can be changed at any time with those changes going into effect immediately, but require approval by the ACLPOA Board of Directors. These changes go into effect immediately.

These documents include:

1. Rules and Regulations
2. Board Policies
3. Committee Procedures/Mission Statements & Charges
4. Operating Procedures and Programs

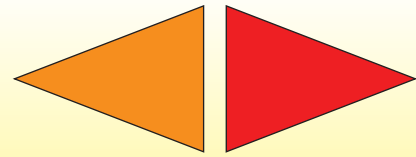

April Revenues were \$295,140. Year-to-Date (YTD) Revenues were \$1,306,498 and were over budget \$27,074. Revenue lines showing a significant deviation from budget were Membership Assessments with \$551,229 which was \$11,251 under budget, Seasonal Docks/Campsites with \$210,855 which was \$14,175 over budget and Bad Debt Recovery with \$12,530 which was \$12,530 over budget.

April Operating Expenses were \$272,332. YTD Operating Expenses were \$917,357 and were under budget \$81,894. Expense lines showing significant deviations from budget were Contract Labor with \$8,247 which was \$11,369

under budget, Gas & Oil with \$6,046 which was \$10,336 under budget, Legal Fees of \$2,070 which was under budget \$24,995, and Accounting Services of \$32,853 which was over budget \$26,413.

The above activity resulted in YTD Operating Revenues over Operating Expenses of \$389,142, which is over budget \$108,968.

R&R expenditures for April were \$11,367 for Long Range Planning, Boat Slip Replacement, Greenway Restoration, Maintenance Building Office, a Beer Cooler/Freezer, Pontoon Trailer, and Accessories for the new Vehicle for Security. YTD R&R expenditures were \$149,787.

UNAPPROVED

2.0 Call to Order – President Mike Harris called the regular meeting of the Apple Canyon Lake Property Owners Association to order at 9:00 a.m. on Saturday, May 21, 2016

3.0 Pledge of Allegiance – After the Pledge of Allegiance, a quorum was present with the following directors in attendance: John Asta, Marge Clark, Jody Ware, Chuck Larsen, Rich Krasula, Jim Craig. Bob Ballenger was absent. Operations Director Shaun Nordie was also in attendance. 4.0 Approve/Adopt April 16, 2016 Minutes – Jody Ware motioned “to remove 12.4 from the agenda and to approve the April 16, 2016 minutes;” seconded by Jim Craig, motion carried.

5.0 Treasurer's Report - Rich Krasula summarized the March, 2016 Treasurer's Report. The full report will be published in The Apple Core.

6.0 Committee Reports –AEC Committee – Mike Harris reported that they had met and discussed two lot combinations, which will be brought to meeting today, construction of a new home at 12A326, and demolition of an old home with construction of a new home at 8A156. Budget – Rich Krasula reported that the Budget Committee met two weeks ago but had no quorum. Updates were discussed about the pool payoff and the change in banking. Shaun Nordie has assisted with putting together a schedule and timeline for working on the budget; discussed having another reserve study done internally, and suggested guidelines on how to present the budget to smooth out the process. Campground - Chuck Larsen reminded the Board about the Pancake Breakfast. Legal – Marge Clark reported that after the last Board meeting, language in the Covenants has been updated about the voting procedures and will be explained today for our third meeting of the three meeting rule. This will complete the updates. If anyone has any other requests for more updates, please submit in writing. Ad Hoc Strategic Plan – Jody Ware reported that this ad hoc committee met two times and are pulling together information from the 2014, 2015 strategic plan and the Wipfli Organizational Study and will plan to meet again next Friday. They may bring something to the Board in June for approval. Ad Hoc Job Descriptions – Jody Ware also reported that this ad hoc committee has met a couple of times and are working on re-writing job descriptions to align with the needs of this organization. Gary Hannon also reported that work is being done to update the employee handbook. Progress is being made with four sections finished of the six sections. Lake Monitoring - Gary Hannon reported the committee has met once and checked water clarity -which is very good - 17ft. Darryle Burmeister has been assisting with this and we are transitioning this task to Gary Hannon and Kim Rees and Erin Winter, with Kim Rees spearheading this committee. Their goal is to report on the quality once per month. Trails – George Drogosz reported that the first meeting was last month. Mr. Paulson gave an update on construction north of Remington. Trails are the best they've been in the last 20 years. Conservation – Rich Krasula reported that they had a great turnout for cleanup day with 49 volunteers. We are still in the VLMP (Volunteer Lake Monitoring Program) supported by the state EPA – but are now Tier 2 since there is no money to spend from the state. However, we will still get sufficient testing that will help us continue to support the watershed program. We have three active greenway stewardship projects. 7.0 General Manager's Report – Shaun Nordie reported that 33 liens were filed this year – this is the lowest we've had other than 2014 where didn't file any. Software demos have started this week. Hoping to make a decision by the end of June with implementation by the end of the year. Trails are open completely now. Lake – weeds have been sprayed for milfoil. The curly leaf invasive weed at North Bay is being treated by cutting right now, next spring we will treat chemically. The harvester is going in North Bay, dredging is going on in Independence, then will move to Hawthorne. The roof is completed at the annex building and the clubhouse along with new doors at the clubhouse. Security shifts will start this week and will have a better presence this year. The first fish survey will be this Thursday at 7:00 a.m. 8.0 President's Report - Mike's report will be in The Apple Core. Mike also wanted to say thank you to the Board for allowing him to be president this past year, it's been exciting to help lead the many improvements and his proudest part of being the president was putting together the search team to hire Shaun as the GM. Other Board members expressed their gratitude to Mike for his leadership and all he has done while president. 9.0 Property Owner's Comments George Drogosz, 08-048, wanted to inform everyone that if you send an email address to the association, you will receive

the Apple Seed. This has great information and a well-informed membership is a good membership. Marcy Stanger, 13-017, reminded everyone about the Jo Carroll Energy annual meeting will be Wednesday, May 25 at the East Dubuque High School with registration starting at 5:00, annual meeting starting at 6:00 and dinner at 7:00. Henry Doden, 13-129, commented that when they first bought their property at the lake, it was an easy walk to their house. Since the trail construction has been done, that is no longer the case. Last year they were told some issues would be solved, and that is not the case – nothing has been done. There has been a lot of discussion about watershed project – where is the set-back distance from the creek? Trail system south of Independence – trail goes straight down as well as the ditch. Hans Bender, 14-058, reported that at the end of February he noticed seven control boxes had 4 leads left open – these should be locked. Why? Called the Maintenance Department.

Ed Helgason, 06-018, questioned if the weed spraying is done all the way to the shoreline and around the docks? Shaun reported that it is most of the time and we prefer to spray where shallow. We should be seeing some results within at least 10 days, sometimes up to three weeks. Henry Doden also questioned why the sprayers had respirators on – should there be a warning to residents? Shaun said there is no restrictions on this chemical other than irrigation. Henry thought an article in The Apple Core might be a good idea.

10.0 Consent Agenda – Jim Craig motioned “to approve the consent agenda items: committee changes (to accept the resignation of Ron Beckel as Vice Chairman of the Ad Hoc Amenity Tag Committee and Appeals Board (will remain on both as a member) and Tim Butvilas from the Deer Management Committee; and to appoint Ted Bluhm to the Deer Management Committee, Mary Hannon and Fred Turek to the Pro Shop Food & Beverages Study Ad Hoc Committee, Jean Burton to the Golf Committee, and Gordon Williams to the Strategic Plan Committee) and appointment of the Nominating Committee (Mike Cammack, Rich Miranda, Rosanne Brandenburg, Barb Hendren, Edie Petelle, Vickie Sershon, and Mike Tyson).” Seconded by Chuck Larsen, motion carried.

11.0 Unfinished Business 11.1 Covenants Revision to Comply with CICAA – Marge reported that after the April meeting some clarification was needed with regard to voting members. With advice from legal counsel, this sentence was added in Article IV, Section 2, Voting Rights-One Voting Member, Para. 1, Sent 4: “Notwithstanding anything to the contrary in this Amended Declaration, where there is more than one owner of an ACL lot, and the designated voting member is not present at a meeting of the membership and has not voted, the owner in attendance shall be entitled to cast the member vote associated with that unit even if that owner is not the designated voting member. The vote must be cast on the day of the meeting prior to the closing of the polls.” Hans Bender asked about a trust, Marge responded that this puts you in as a legal entity category. You have to file your designated voting member. Jody thanked Marge for all of her work with this huge task. Rich Krasula motioned “to approve the amended declaration to conform to the common interest community association act as attached to the motion card.” Seconded by Jody Ware, motion carried.

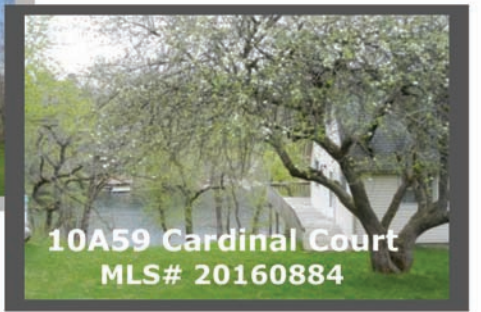

John Sershon stated that the definition of the words “yearling deer” refers to a deer that was born in the spring of the previous year. The word that should have been used in our request to not harvest young deer is “fawns”. This actually refers to deer born during the present year which is what we intended to require. All agreed to change the wording in future communications to our hunters.
- 3.2 Security** - Jim Petelle stated that he had requested that a member of the Security staff attend our meeting. Unfortunately, this was not possible at this time.
- 3.3 Other Old Business** - Jack Finley discussed the issue of how the Deer Management Committee funds are allocated. He noted that the unused funds allocated to the committee from the collection of hunter fees are not rolled over from year to year. John Sershon asked if there were records of the amount of money collected and spent by the Deer Management Committee. Jim Petelle stated that we should request that information from the association. Jack commented that the Deer Management Committee has also contributed income to the Association indirectly thru fines assessed because of our trail camera use by the Security staff. Jack stated that he would request a meeting with our new manager to inform him of the Deer Management Committee’s involvement in the community and cover several of the Deer Committee’s concerns.
- 4.0 New Business**
- 4.1 Review of the Deer Count** - John Sershon made a comment that the deer herd count was consistent with the goal recommended by the DNR. The count this year was 122 deer. It should be noted that the herd may have temporarily moved to adjacent land because of the availability of food. Several large herds were seen on land adjacent to Stagecoach Trail where very few have been seen in previous years.
- 4.2 Volunteers for Upcoming Events** - Again this year we need people to help with the scheduled events. John Sershon commented that only a few hunters in the program help with these events. It seems that their only interest in the program is to take advantage of the hunting. Jack Finley and Jim Petelle stated that we should start designating the hunters as we did for approving the tree stand locations last year. Additionally, the volunteer work should be rewarded in some manner. This will be discussed at a future meeting.
- 4.3 Other New Business.** Jim Petelle commented that there were several articles in various magazines and papers that affect the deer herds in regard to CWD (Chronic Wasting Disease). One indicated that the use of deer urine as an attractor was found to be a distributor of CWD prions that were contained within the urine. Another was related to the feeding of deer as a major contributor of CWD. This information is confirmed by the DNR and as such is against the law and subject to severe fines.
- 5.0 Next Meeting Date** - The next meeting is scheduled for May 28, 2016.

6.0 Adjournment - The meeting was adjourned by general consent.

1.0 Call to Order – Chair Paula Wiener called the Conservation Committee meeting to order on May 7, 2016 at 9:00am.

2.0 Approve Minutes – Phyllis Cady made the motion and Rich Krasula seconded to approve the April 2, 2016 minutes as presented. Motion passed with two abstentions, Darryle Burmeister and Gary Hannon.

3.0 Reports

3.1 Monthly Services Report – Mike Malon sent out the Summary report for services provided in the month of April prior to the meeting. To highlight the report: monthly water sampling started in April. Six sites were sampled with the lab work done by Lyons Lab; there is no date set for the next watershed meeting--in the first quarter \$4,226.25 was paid out for the watershed plan which was for writing the plan content (\$2,440.26 was reimbursed from the EPA); an erosion problem was checked out behind Taft Court; there are several dry dam structures that need repair--plans will be developed for each prioritized by severity of the problems and budgetary restrictions; ACL supplied more information to the EPA in order to renew the dredging permit; and plans are being developed to clean out the dredge pond at Presidents Bay.

3.2 Lake Monitoring – Darryle Burmeister reported Erin Winter, Gary Hannon, and Kim Rees will comprise the Lake Monitoring group. Darryle reviewed an email he received from Greg Ratliff which stated the program Tier 3 was limited to four lakes which had not participated last year, but needed confirmation data collected. Greg said the ACL monitoring group can collect Tier 2 data which is water quality at site one's surface. Greg also stated that we may retain the DO meter to collect DO/Temp profiles as well. He will drop off the equipment needed along with sample bottles and replace DO caps on Monday, May 9th at ACL. The question was asked what is involved in Tier 2 monitoring. Darryle listed DO, Temp, Secchi readings, surface testing and other monitoring observations such as clarity, vegetation, look for zebra mussels, etc.

4.0 Old Business

4.1 Greenway Invasives – Regarding the use of goats getting rid of the invasives, Darryle reported he spoke with Wayne Robbe and he does not want to take part in the program at this time. The question was asked if there were other alternatives for clearing these difficult areas. Darryle spoke to Josh at Random Machine regarding other alternatives. The few Darryle remembers off-hand is that during the winter do cutting in places and burn the stumps, and do selective herbiciding in specific areas. Mr. Nordlie will confer with Rick Paulson on other specific areas and will let the committee know next month.

4.2 Watershed Update – Ms. Wiener feels that it is Conservation's priority to push the Watershed forward and to keep a discussion going in support of it. She asked the committee members how they felt and everyone was definitely a big supporter of the plan. Mr. Nordlie stated that some farmers did not know anything about the watershed. In the future they will invite the farmers for further discussions on the plan and get them up to speed on what the importance of the watershed is to everyone. Shaun said that Mike Malon put together a condensed version of the plan which is about 10 to 15 pages long for better reading. Mike also notified the committee that SWCD has a Facebook page. Mr. Nordlie will email the short version to the committee. Gary Hannon suggested a small paragraph should be placed in the *Apple Core* every month mentioning the Watershed plan. Paula asked Gary if he could write an article on the Watershed.

4.3 Lawn Application Education for Residents and Landscapers Status – Phyllis Cady gave Paula the list of responses received from the landscapers. This list will be given to Cindy with short note stating these landscapers responded that they do not use phosphorous.

4.4 Conservation Conversations Monthly *Apple Core* Article Topics -- Paula reported that June is National Pollinator Month and will do an article on it. Paula asked Gary if he could give her a suggestion for the Watershed box. For July she was thinking about buffer zones on the lakefront. Possibly this could lead to handouts for the Conservation information table.

4.5 Resident Greenway Program

4.5.1 Wojdyła Project – Darryle Burmeister reported that Rick Paulson has the original paperwork. Gary Hannon said it was a simple project of planting about three trees.

4.5.2 LoSasso Project – Project is complete; Rick Paulson to tag trees.

ACL Security Report

This summary covers April 21 to May 20, 2016. During the month of May 11 officers worked a total of 796 hours, and patrolled 4,405 miles of roads, 79 miles of trails, patrolled 15.6 hours on the lake, and used 394.9 gallons of gas. An additional 31 hours were spent training eight new part-time employees.

In addition, officers:

- checked ACL owned buildings 636 times; checked 222 residential homes; made one welfare check; responded to two EMS calls.
- assisted Property Owners 30 times by helping with two locked out of homes, one locked out of car, jump started cars and boats, towed in two boats (gave rides), answered questions.
- gave directions to lost PO; checked for gas leak and called gas company to fix; answered questions about the Lake, Campgrounds, Trails, and Cove.
- performed 62 service calls (ie:) accepted deliveries for the pro shop, Marina Store, and gasoline; delivered Board packets; and picked up deposits from Pro-Shop and Marina Store.
- responded to 13 complaints ranging from ATV's on closed trails, burning yard waste, loose dogs.
- conducted 10 creel checks, responded to one fire alarm, and issued two citations.

New Flag Rule for Boaters

ACLPOA Rules and Regulations

Chapter V: Boating

Section E: Waterskiing and Towing Devices

- The operator of any watercraft that is towing a person or persons shall display on the watercraft a bright or brilliant orange flag measuring not less than 12 inches per side. The flag shall be displayed at the highest point of the area surrounding the boat's helm as to be visible from all directions, continuously, while the person or persons being towed depart the boat in preparation for towing and until reentry into the boat when the activity has ceased. Display of the flag for purposes other than the activity described in this section is prohibited.
- Boaters towing skiers, tubers, surfers, etc. must wave a red flag when the person(s) are "down" or in the water.

State laws supersede our Rules and Regulations and Apple Canyon Lake watercrafts will be required to display the **ORANGE** flag at all times when towing a person. The new law is concerning in that it alerts other boaters that you may be towing a person, but does not alert other boaters when a person has fallen and is no longer being towed by the boat. While the State law must be enforced, the Apple Canyon Flag Rule will remain in place.

Therefore, by state law, all watercrafts towing a person or persons shall display an **ORANGE** flag throughout the duration of the towing activity. Additionally, you will be required to RAISE and WAVE a **RED** skier down flag when a person or persons being towed has fallen into the water. Doing so is the only way to differentiate between towing a person and having someone in the water who may be dangerously vulnerable to other boats in the area. An example of concern would be towing two people on one tube and having one person fall off. The State law requires one flag be displayed at all times but offers no distinction or warning to others that another person is in the water and no longer attached to the moving boat. The State law also prohibits watercrafts from flying the **ORANGE** flag when not towing a person. So if you are not using your watercraft to tow a person then you are required take down the **ORANGE** flag.

The Marina has ordered orange and red flags which will be compliant with the new State law that can be attached to the windshield of your watercraft. They are available for purchase at the Marina and also at the Association Office. We have been very fortunate that we have had no serious injuries involving a person in the water and moving watercraft because of the cooperation of all Apple Canyon Lake watercraft owners, the diligent use of the colored safety flags and the practice of safe boating techniques.

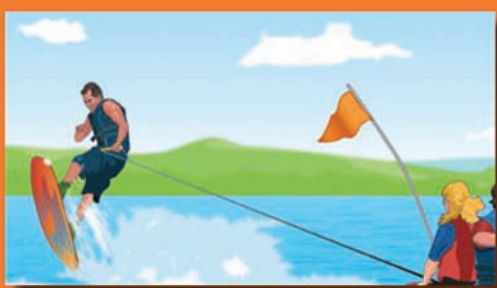

Do you need a Boating Safety Certificate?



The Illinois Boat Registration and Safety Act (625 ILCS 45) has been amended, and effective January 1, 2016, any persons born on or after January 1, 1998 must possess a valid Boating Safety Certificate before they operate any motorboat with over 10 horsepower. The owner of a motorboat or a person given supervisory authority over a motorboat, shall not allow a person who does not meet this requirement to operate their motorboat with over 10 horsepower. Children between the ages of 12 and 18 must also be accompanied on the motorboat and under direct control of a parent or guardian, or a person at least 18 years of age designated by a parent or guardian in addition to possessing a valid Boating Safety Certificate.

A Boating Safety Certificate is not required in very select circumstances, one of which is "a person who has assumed operation of the motorboat due to the illness or physical impairment of the operator, and is returning the motorboat or personal watercraft to shore in order to provide assistance or care for that operator." Other exemptions can be found in Sec 5-18. (i) of the Illinois Boat Registration and Safety Act.

Anyone who rents a boat from Apple Canyon Lake, or another rental service in Illinois, will be required to present proof that they possess a valid Boating Safety Certificate or will be required to take an abbreviated safety course presented by ACL prior to taking out the rental boat. A person who completes the abbreviated operating and safety instruction provided by ACL may operate a boat rented from ACL for up to one year from the date of instruction.

Instructor led classes can be found by calling 1-800-832-2599, or found online by county at <http://www.dnr.illinois.gov/safety/Pages/ListOfEducationCoursesByCounty.aspx>. A Boater Safety Course will be held at Apple Canyon Lake on Saturday, June 4 from 8am to 4:30 pm. For more information or to sign up for the course, please call the Safety and Security Department at (815) 492-2436. There is no charge for the class; participation is limited to the first 20 registrants. Additional classes will be scheduled at ACL later in the year. Online Boating Safety Certificates can be obtained from a variety of vendors. Two vendors listed on the IDNR website are www.Boat-Ed.com and www.BoaterExam.com.

Boating and Marina Safety

5 Tips for Boat Owners

- 1. Swimming Safety** - Never allow swimming near the boat, marina, or launching ramp. Residual current could flow into the water from the boat, or the marina's wiring, potentially putting anyone in the water at risk of Electric Shock Drowning.
- 2. Put It to the Test** - Be sure your boat is properly maintained and consider having it inspected annually. GFCIs and ELCIs should be tested monthly to ensure functionality. Conduct leakage testing to determine if electrical current is escaping the vessel.
- 3. Use the Right Tool** - Never use household cords near water. Use only portable GFCIs or shore power cords (including "Y" adapters) that are "UL- Marine Listed" when using electricity near water.
- 4. Know Your Surroundings** - Know where your main breaker(s) are located on both the boat and the shorepower source so that you can respond quickly in case of an emergency. Be aware of any potential electrical hazards by checking for nearby power lines before boating, fishing, or swimming.
- 5. Learn the Code** - Regularly have your boat's electrical system inspected and upgraded by a certified marine electrician to be sure it meets your local and state NEC, NFPA, and ABYC safety codes and standards.

Safety Device Guide

- 1. What is a circuit breaker?**
Circuit breakers are designed to detect faulty electrical conditions within electrical systems and interrupt current flow.
- 2. What is a Ground Fault Circuit Interrupter (GFCI)?**
These outlets or circuit breakers prevent shock and electrocutions by quickly shutting off power to the circuit if the electricity flowing into the circuit differs by even a slight amount from that returning.
- 3. What is a portable GFCI?**
A portable GFCI requires no special knowledge or equipment to install. Portable GFCIs should only be used on a temporary basis and should be tested prior to every use.
- 4. What is an Equipment Leakage Circuit Interrupter?**
ELCIs measure current flow within electrical wires and immediately switches electricity off if an imbalance of current flow is detected.
- 5. What is a shore power cord or marine power cord?**
Shore power cords and Y-adaptor cords are designed specifically for use near water to provide shore side electrical power to ships and boats while its main and auxiliary engine is turned off.
- 6. What is a power pedestal or dockside electrical system?**

A power pedestal or dockside electrical system is a power box designed with corrosion-resistant materials to provide electricity safely on the dock.

Electric Shock Drowning

Electric Shock Drowning occurs when a body makes contact with electrified water and becomes a conductor of electricity leading to the possibility of complete loss of muscle control, rapid or irregular heart beat (ventricular fibrillation), and even electric shock death.

Common Causes - Docks and boats can carry sources of electricity. Faulty wiring or the use of damaged electrical cords and other devices can cause the surrounding water source to become energized.

How to Avoid

- Obey all "No swimming signs".
- NEVER swim near a marina.
- NEVER swim near a boat while it is running.

If you feel any tingling sensations while in the water, tell someone and swim back in the direction from which you came. Immediately report it to the dock or marina owner.

How to Respond

- Do not enter the water!
- Call 911 or VHF Channel 16 immediately
- If possible turn off all nearby power sources
- Extreme caution should be taken when removing the victim from the water.
- If the victim does not have a pulse and not breathing begin CPR or use (AED) Artificial Electrical Defibrillator if available.

Marina Safety Checklist

- Familiarize yourself with your marina and help prevent electrical hazards. Use this checklist to talk with the marina manager or owner about potential safety concerns
- Are any cords cracked or frayed?
- Is there corrosion or other damage on any of the power pedestals?
- When the marina was last inspected? Inspections should be performed yearly
- What edition of the codes (NEC, NFPA, ABYC) does the marina comply with?
- What type of ground fault protection does the marina provide?

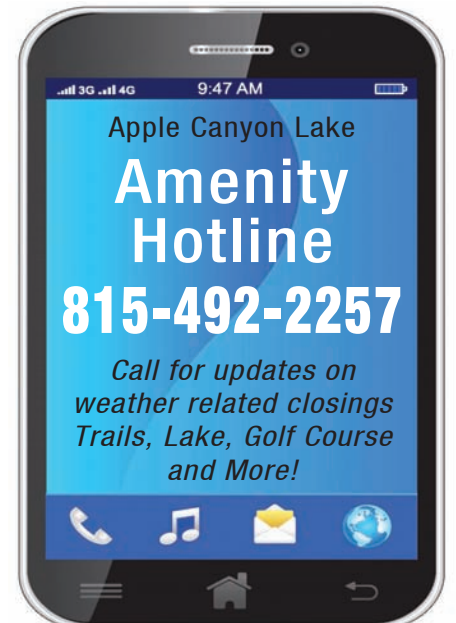

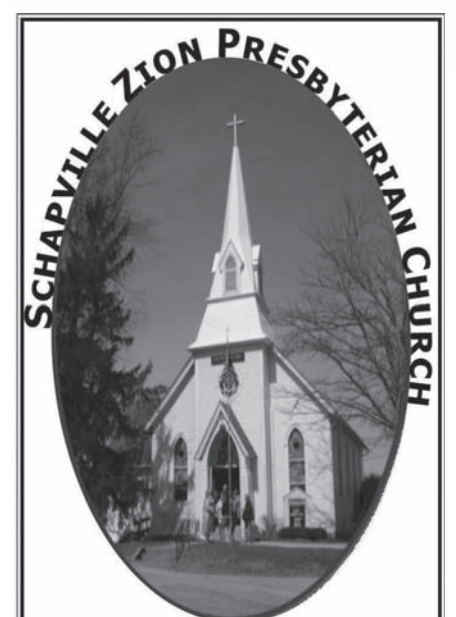

Trash Facts

Every lot with a home at ACL is required to pay an annual \$75 Trash Assessment. Other property owners may elect to pay the trash fee and use the Solid Waste/ Recycling Center. For each \$75 fee paid, the property owner has a choice of a trash decal sticker or a paper trash pass. Unless the same vehicle is used to drop off trash every time, a paper trash pass is needed. The paper trash pass can be transferred between vehicles or presented if an ATV, UTV, or golf cart is used to drop off trash. Photocopies or photos of the pass are not acceptable and entry to the facility will be denied without a decal sticker of a paper trash pass as issued by the Association. If needed, one additional trash pass (paper or decal) can be purchased for \$10, provided the \$75 fee has already been paid. A total of two passes is allowed per lot. If a pass is lost, the replacement fee for each pass is \$30.

If a member has paid the \$75 Trash Assessment, they are then eligible to purchase Large Item and Electronic Item Disposal Permits. These permits are available at the ACL Office for \$15 each and allow the property owner to dispose of televisions, furniture, large appliances, etc. This is a very handy service as fewer and fewer locations allow the disposal of items such as televisions and old computer monitors.

No hazardous materials can be disposed of at the Center, nor are septic tanks or septic components, tires, or batteries allowed. Building materials cannot be disposed of at the Solid Waste/Recycling Center, the property owner needs to ensure an on-site dumpster is rented for any construction or renovation projects. We cannot accept compact fluorescent light bulbs (CFLs), however drop off is available at True Value in Stockton, Lowe's in Dubuque, or Menards in Freeport.

Detailed recycling information and a list of items accepted for Large Item and Electronic Item Disposal is included on the Solid Waste/ Recycling Hours brochure given to each property owner with their trash pass. Totally Tomatoes and Perfect Peppers

Tomatoes, eggplant and peppers are some of the most popular crops grown by market gardeners and homeowners. All of these crops are part of the Solanaceous family. In order to have a better understanding of these crops the University of Illinois Extension is offering a program to equip growers with the information they need to grow these crops called "Totally Tomatoes and Perfect Peppers".

During the program "Totally Tomatoes and Perfect Peppers", Extension Educator, Grant McCarty, will provide an overview of peppers, eggplant, and tomatoes. He will talk about the different varieties of each and what these varieties have to offer the grower. He will discuss insect and disease issues that growers may see on these crops, scouting methods, and pest control measures. 2016 Mosquito-Borne Surveillance Begins in Jo Daviess County

Health Department offers tips to families on protection from mosquito-borne viruses

Jo Daviess County – Summer is around the corner and temperatures are heating up which may result in the amplification (increase) in mosquito-borne viruses in northern Illinois. Above normal temperatures can increase the rate of mosquito production, mosquito flight activity, and virus replication, thereby increasing the proportion of mosquitoes that can carry an increased risk of disease to humans.

The Jo Daviess County Health Department wants to remind residents that every summer there maybe the presence of mosquito-borne viruses such as West Nile Virus, St. Louis Encephalitis, Eastern and Western Equine Encephalitis, and California Encephalitis. Taking precautions to protect yourself and your family reduces the risk of being bitten by an infected mosquito. The best way to prevent mosquito-borne illness is to reduce the number of mosquitoes around your home and to take personal precautions to avoid mosquito bites. Precautions include practicing the three “R’s” – Reduce, Repel and Report.

REDUCE exposure

Avoid being outdoors when mosquitoes are most active, especially between dusk and dawn. Make sure doors and windows have tight-fitting screens. Repair or replace screens that have tears or other openings. Try to keep doors and windows shut, especially at night.

Eliminate all sources of standing water where mosquitoes can breed, including water in bird baths, ponds, flowerpots, wading pools, old tires and any other receptacles.

REPEL - When outdoors, wear shoes and socks, long pants and a long-sleeved shirt, and apply insect repellent that contains DEET, picaridin, oil of lemon eucalyptus or IR 3535, according to label instructions. Consult a physician before using repellents on infants.

REPORT – Please call the Jo Daviess County Health Department to report the location of recently expired birds. The number to call is (815) 777-0283.

The Health Department plans on placing several gravid traps throughout the county for collection of mosquitos for testing in addition to the dead bird collection. These two assessments help to identify the presence of mosquito activity which in turn, provides notification and education to the public where the increased amplification of mosquito-borne viruses are occurring.

The Health Department also maintains several other informational resources for the public regarding mosquito borne viruses. The JDCHD has added information related to West Nile Virus in the Environmental Health page of their website that can be found under the heading of Vector Control.

In Jo Daviess County, there are seven farmers markets:

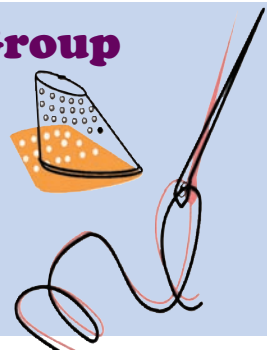

The Wapello Land & Water Reserve is located at 8642 IL Rt 84 South just south of downtown Hanover, IL. The site features a 63-acre restored prairie, mowed trails, and interpretive signage explaining the Native American village site that was once occupied along the banks of the Apple River at Wapello. The site is owned and stewarded by JDCF, local non-profit whose mission is to preserve land for the lasting well-being of people and wildlife. JDCF owns several beautiful and unique preserves that are open to the public for hiking, wildlife viewing, and picnicking. Experience Galena Gateway Park - A Walking Tour

GALENA: Have you ever wondered what a guided tour of the City of Galena's Gateway Park would be like? Wonder no more and join staff from the Jo Daviess Conservation Foundation (JDCF) along with Jim Louderman, Collections Specialist with the Chicago Field Museum, on Monday, June 6th at 1:00 PM. Participants will get the inside scoop on insect sampling techniques that will be used as a baseline measurement for the success of the prairie restoration taking place over the next several years. JDCF staff will also discuss the history of the park and the community effort that led to in the original 100 acre purchase in 2010 and the 80-acre addition in 2016. The walk will take place on mowed trails over rolling terrain and will feature the restored prairie, beautiful views of downtown Galena, and a rare grove of Kentucky Coffee. We will meet in the park's parking lot at 9300 Powderhouse Hill Road just east of downtown Galena off of Hwy 20. This event is free to the public and RSVP's are not required.

The Jo Daviess Conservation Foundation is a local non-profit whose mission is to protect land for the lasting well-being of people and wildlife. In 2010, JDCF acquired the 100-acre Gateway Park with funding from the Illinois Clean Energy Community Foundation (ICECF), the Grand Victoria Foundation, the Doris Duke Charitable Foundation, and funds raised by the Friends of Galena Gateway Park from local individuals, businesses and family foundations to raise the \$1.3 million purchase price for the venerable property. An 80-acre addition to the park was purchased in 2016 with funds provided by anonymous donors, the ICECF, and the Flanagan South Pipeline Mitigation Fund, which was made available by Enbridge, Inc. in partnership with The Conservation Fund and the U.S. Fish & Wildlife Service. Apple Tree Genealogy

CAVALIERS AND SERVANTS IMMIGRATION 1642-1675 - FROM THE SOUTH OF ENGLAND

This column is meant to be helpful in a small way to Apple Canyon Lake residents who have an interest in genealogical research and who may have problems or stories to share.

The Cavaliers and servants' immigration to the Chesapeake Bay area and Virginia in 1642-1675 was the second major immigrant group from the British Isles to Colonial America. These were the "so-called" Cavaliers of the South, whose birth can be traced to the immigration of 45,000 gentry and indentured servants from Saxon South and West England. The origin in England was principally between Bristol and London and north to Warwickshire. The other three immigrant groups were the Puritans (1629-1640), Quakers (1675-1725) and the Scots-Irish (1717-1775). These four groups are discussed in the book, "Albion's Seed" by David H. Fischer, 1989.

The "so-called" Cavaliers and Servants' groups differed in many customs and folkways from the other three immigrant groups. A large portion of these immigrants (25%) came from well-to-do families, although the largest portion (75%) was indentured servants. Included here were many "second sons" who were destined to inherit little from their fathers. Additionally, others were "distressed Cavaliers" who were fleeing a hostile political/religious environment in England.

In the 1650's, the Puritans gained the upper hand in England and tried to impose its beliefs by force upon unwilling people. Virginia's (and Maryland's) Royalist immigrants were refugees from oppression, just as New England's Puritans had been earlier. Sir William Berkley, Virginia's Governor for the Crown, 1642-76, successfully recruited many of the Royalist elite for Virginia. The Cavaliers were concerned with rank, ceremony, fortune, honor and leisure. After Virginia became a royal colony, the Assembly passed laws making the Church of England (Anglican) the State Church of Virginia. That made it difficult for persons of dissenting religions to remain in Virginia. They were Anglicans, wealthy, educated and of high social standing. The 75% from the lower classes came as servants, many as indentured servants, to work on large plantations established by the "Cavaliers". These were lower class and were poor, illiterate and unskilled. So, in the beginning there was a class system established in the Virginia Colony that was different than New England.

The Chesapeake Bay area of settlement was both positive and negative. Fishing was excellent in the bays and streams. There was plenty of rich alluvial soil for cropping and trees were abundant. But, the warm climate caused more disease and death than in New England. Typhoid fever, amoebic dysentery and malaria caused heavy mortality and disrupted many nuclear households.

The Cavalier/Servant group had many customs or folkways which differed from other British-speaking immigrant groups which came to early America. The comparison follows:

Speech Ways: Virginia's speech was a soft, slow, melodious drawl. They tended to add syllables, i.e., half was ha-alf", care was "ke-er", pretty was purriddy", etc. Consonants were softened, i.e., floor was "flo", this was "dis", etc. These Virginia speech ways were derived from several regional dialects that had been spoken throughout the south and west of England in the 17th Century.

Building Ways: The plantations had a "brick-great house" surrounded by outbuildings, gardens and fields. This was similar to English country homes, except they were built of stones in England. But, most houses in the Chesapeake were very modest, with two rooms, a loft and a chimney.

Family Ways: Families were smaller than New England, because the death rate was high. There were large numbers of servants in households. Masters and house-servants lived close together - often sleeping in the same room. Their houses were rarely closed to strangers. A gentleman in Virginia took pride in his hospitality. This custom had long existed in England.

Marriage Ways: Everyone was expected to marry in Virginia. Marriage was a sacred knot that could not be untied. Divorce was not allowed in the Anglican church in Virginia. There were five required steps to marriage: espousal, banns, religious ceremony, marriage feast and sexual consummation. Written permission from parents was required. There was interest in "keeping it in the family"; thus love was not a prerequisite and first cousin marriages were permissible. Men were aged 25-26 and women 18-20. There was a shortage of women, so some men did not marry.

Naming Way: The most common naming pattern was for the first-born children to be named for their grandparents and second-born for parents.

Child-rearing Ways: The parents in Virginia were more indulgent than parents in New England. Children were encouraged to be self-willed, but they were also expected to observe self-restraint. They had to learn "right conduct" and dance. One-third of children died by the age of two.

Religious Ways: Anglican orthodoxy was strong and the official religion in Virginia. The order of worship in morning and evening service was strictly defined by the Book of Common Prayer. Sermons were twenty minutes in length. Churches had choirs and some had organs.

Learning Ways: There were few schools. Children of the elite class were educated at home and the poor remained illiterate. Most women, even of high rank, were unable to write their names. This was all similar to those parts of rural England from whence the colonists came. The learning ways were not the product of slavery or rural poverty. These learning attitudes were rooted in a culture which came out of England and persisted in the southern states for three hundred years.

Food Ways: Prosperous planters ate roast beef, game, vegetables and fruits. They rarely ate native American potatoes and tomatoes. Colonists of humble rank commonly ate a one-dish meal ("mess"), which included greens, salt meat and wild herbs and hominy. The style of Virginia cooking became the basis of a distinctive regional food way in America - highly-seasoned with much roasting, simmering and frying. This is very similar to cuisine of southern and western England and also called "Dorset cooked". In households of high or middling ranks, meals were highly developed rituals. Even poor families had tablecloths.

Dress Ways: The Virginians and Chesapeake elite dressed similarly to the gentry of southern England. The men dressed in fragile fabrics, perishable colors, necklaces, brooches and earrings which were designed to display their riches and refinement, their freedom from manual labor and their dominion over others. Farm workers dressed in worn and tattered garments. Black slaves were not dressed in African apparel, but in the ordinary apparel of country laborers.

Sport Ways: The folks of the Chesapeake region did not play ball sports as in New England. They loved horse races, many times with betting. Hunting and bloodsports were popular.

Work Ways: Characterizing work ways and attitudes among Virginia planters is difficult. They had an ambivalence about wealth, trade and work. Yet, most Virginia gentlemen worked harder than they cared to admit. Crop and tobacco raising and marketing required lots of time and work. Interestingly, indebtedness was a chronic problem in Virginia and Maryland among planters. This debt accounted for most of indebtedness due English creditors after the War of Independence.

Time Ways: The use of time in the Chesapeake seemed more relaxed in Virginia, than in New England. However, growing tobacco was very time intensive. Servants and slaves worked full days except Sundays and holidays. Time was not their own.

Wealth Ways: The distribution of wealth was profoundly unequal. The planters owned much of the lands which was about 50-75% of the land. The yeomen represented 20-30% of the population and owned and tilled their own land, sometimes with the help of one-two servants. The bottom 60-70% of Virginia's male population owned no land. Below these tenants were poor white laborers, servants and black slaves.

Rank Ways: The rigidity of social rank and order was strong in Virginia. For social purposes, Virginia's ruling elite required an underclass. In short, slavery in Virginia had a cultural imperative and slavery helped perpetuate their system.

Order Ways: In the 17th century Virginia, order was fundamentally a hierarchical conception. The sheriff was the leading executive officer in a county. The death penalty was common in Virginia and many felonies were capital offenses. The elite were treated with more leniency.

Power Ways: The cavaliers held most of the offices in local government. A vestry system which was a remnant of southern England was put into place in every Virginia parish by 1643. A municipal council or state assembly was established in Virginia which was called the House of Burgesses. They called it "our Parliament" and some of its system became a part of the U.S. Constitution.

Freedom Ways: The Virginia idea of hegemonic liberty was far different than the New England system in which people voluntarily imposed restraints upon themselves. It never occurred to most Virginia gentlemen that liberty belonged to everyone. It was thought to be a birthright of free-born Englishmen.

Summary: Many of the leading families of Virginia are renown in American history - the Washingtons, Jeffersons, Lees, Byrds, Carters, Culpeppers, etc. Thomas Jefferson was the chief author of the Declaration of Independence and George Washington's perseverance and leadership won the Revolution.

For genealogists, a great source of records for the early years is the Episcopal Church records. This author has personally found that individual counties in Virginia as well as the Library of Virginia in Richmond have excellent records.

The Association has two pontoon boats, Lake Yacht and Olive Oyl, available for rent to property owners and their authorized guests. Property Owners must contact the Association Office to give their guests permission to make a reservation and are reminded that the Property Owner is responsible for the activities of their guests, and any violation of the rules by a guest or the cost of damages in excess of the security deposit will be charged against the Property Owner. Rental boats will be checked in and out of the Marina. An Amenity Tag must be presented to the Marina staff by the lessee. Each boat has a capacity of ten (10) persons. Ten (10) adult-size life jackets are provided. Lessees must provide their own life jackets for children and infants. Anyone who leaves the boat to access Nixon Beach, the Marina Bay Trail, etc. must have an Amenity Tag.

Reservations for rental boats will be accepted during normal Association Office hours in person or by calling 815-492-2238. Reservations cannot be made at the Marina. We encourage reservations be made at least 24 hours in advance. When the reservation is made, payment for the rental must be made in full via credit card. The renter may elect to pay the \$300 security deposit at the time of the reservation, or at least 24 hours prior to the rental. All security deposits must be paid with a credit card. If the lessee fails to pay the security deposit at least 24 hours in advance of the rental, an additional \$50 Late Deposit Payment Fee will be charged. If the boat is returned after hours, the renter fails to have the boat inspected, or the lessee fails to refuel the boat, a \$50 fuel fee will be retained from the security deposit. Upon return of the boat in same condition, the Marina will submit paperwork

to the Association Office requesting the security deposit be released. We will make every effort to refund deposits within 72 hours of the rental completion. Please be advised that the credit card company may not process the refund immediately. Effective January 1, 2016, the Illinois Boat Registration & Safety Act has been amended and now requires that any person operating a rental boat submit a valid Boating Safety Certificate or participate in an abbreviated safety course prior to operating the watercraft. A copy of a valid Boating Safety Certificate must be provided to the Association Office by the rental boat operator at least 24 hours in advance of the rental, or completion of an abbreviated safety course at the Marina will be required. Rental boat operators taking the safety course must arrive at the Marina 30 minutes prior to the rental. Rentals will not be extended if the rental boat operator fails to complete the course prior to commencement of the rental.

Cancellation policy: In the event of severe weather on the day of the rental, the rental amount and security deposit (if already paid) will be returned to the credit card on which it was paid. If a rental is cancelled for any other reason with less than 24 hours' notice, including no shows, the rental fee will not be refunded. Any security deposit paid in advance will be refunded to the card on which it was paid. Any rentals cancelled with at least 24 hours' notice will be refunded the rental amount in the form of an ACL Gift Card which can be used at the Association Office, Pro Shop, Pro Shop Bar & Grill, and the Marina. ACL Gift Cards cannot be used at The Cove restaurant. Any security deposit paid in advance will be refunded to the card on which it was paid.

Conservation Conversations



Conservation Consultant's Report

MIKE MALON, JO DAVIESS SOIL AND WATER CONSERVATION DISTRICT

Pollinator plantings in northern Illinois

Planting areas for pollinators can be beneficial from many angles. These areas not only provide food for pollinating species, but can also be used to beautify areas used for erosion control and nutrient sequestration, and reduce maintenance costs and labor for un-utilized areas.

Pollinator plantings are more than just wildflowers. A pollinator planting needs to have at least three species of plants blooming at all times of the growing season in order to assure that pollinators have food throughout the seasons and not just in the middle of summer. Early spring and late summer are particularly hard times of year for pollinating species.

The USDA has several recommended species mixes for pollinators which are specifically adapted to different regions of the U.S. and different soils. For example, a basic mix suitable for most soils (mesic) has plants that flower early in the spring, such as foxglove beardtongue, purple prairie clover, and Ohio spiderwort, in addition to plants which flower later in the fall, such as partridge pea, stiff goldenrod, and smooth blue aster. These plants are part of a mix

which contains a total of 13 wildflower species and three native grasses. For more information about recommended seed mixes for pollinators, contact your local SWCD office.

The mixture of grasses with the wildflowers allows you to add the beauty of wildflower blooms throughout the growing season to the deep rooting erosion control, and nutrient sequestration of native prairie grasses. This is useful for stabilizing steep slopes and shorelines, and reducing nutrient movement to waterways and the lake. If you own lakefront property, this is an attractive way to improve your shoreline, adhere to the shoreline buffer rules in the covenants, and protect the lake from soil and nutrient runoff.

Finally, if you feel like you are spending too much time mowing the lawn or if you have extra space that isn't providing a purpose, consider converting it to a pollinator planting. Once established these areas require very little maintenance and also provide some eye candy for the neighborhood, not to mention food for the struggling pollinators on which we depend for so much of our food.

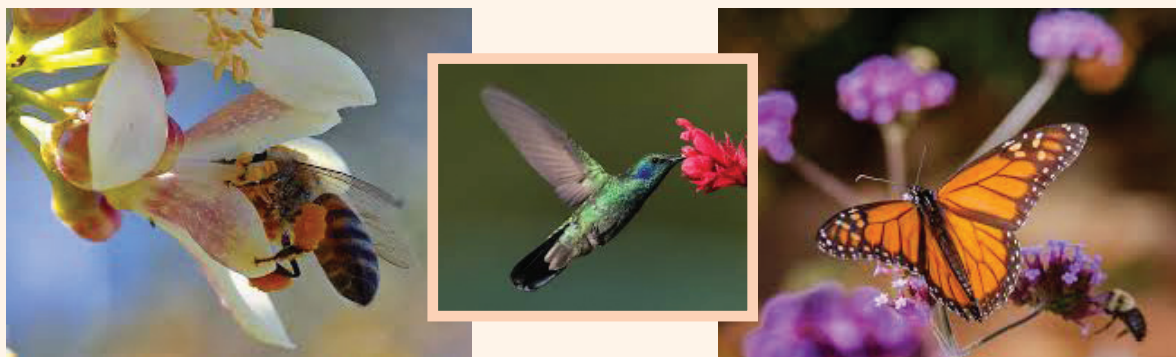

Celebrating Pollinators

When you read the word "pollinator" you probably think of bees, and they are certainly among the most important members of this class. But hummingbirds, butterflies, flies, beetles, moths, and even bats are part of this hard working and vital group. Although bats do not act as pollinators in the area designated as the Eastern Broadleaf Forest where we live, they are important pollinators in the southwest where they feed on agave and cactus.

Pollination occurs when pollen is carried from flower to flower by wind, water animals, or insects. The transfer of pollen between flowers of the same species leads to fertilization and successful seed and fruit production. Pollination ensures production of full-bodied fruit and viable seeds for future plants.

One of every three bites of food we eat is the result of pollinators. They are the key to successful procreation for 80% of the world's flowering plants. Of the 1,200 plant species in the world that provide food, beverages, fibers, spices, and medicines, 1,000 of them need the services of pollinators. Some of the food products that result from successful pollination include apples, blueberries, chocolate, coffee, melons, peaches, potatoes, pumpkins, vanilla, almonds, and that very important ingredient for you Margarita drinkers – tequila.

But there is disturbing evidence that the pollinator population worldwide may be in trouble. In the U.S. we have lost over 50% of our managed honeybee colonies over the past 10 years due to hive collapse. The E.U. has spent more than \$20 million investigating the status of pollinators in Europe. Contributing to pollinator demise is loss of habitat, chemical misuse, introduced and invasive plant and animal species, diseases, and parasites. The threat is so significant that eight years ago the U.S. Senate unanimously approved the designation of a week in June as "National Pollinator Week". This year it takes place June 20-26.

Improving and then maintaining the quality of our watershed is a priority for all of us who enjoy the many treasures it offers us. All watersheds are living, breathing systems consisting of interrelationships connecting soil, water, plants, animals and humans to one another. Pollinators play an intricate role here. There are a variety of things you can do to help them to prosper.

Replace some of your lawn with plants that offer habitat and nutrition for bees, butterflies, moths, beetles, and hummingbirds. Even though they are not native, herbs and annuals including mint, oregano, garlic, chives, parsley and lavender are good for pollinators and add excitement to your menus. Old fashioned flowers like zinnias, cosmos, and single sunflowers are excellent for bees and butterflies. Wild flowers like columbine, sage, cardinal flower, anise hyssop, bee balm, and woodland phlox are attractive to hummingbirds and some of the other pollinators as well. And although you may have to do a little weeding, you won't have to cut these plants on a weekly basis like you did the lawn you replaced.

Build bee boxes to encourage solitary, non-aggressive bees to nest on your property. Leave some areas of soil uncovered to allow nesting insects easy access to underground tunnels. Provide a clean, reliable source of water that has a shallow or sloping side so pollinators can approach the water without drowning. Remember that pesticides are usually toxic to pollinators. Exercise extreme caution when using any pesticide, apply strategically and target only problematic species, or learn to use integrated pest management practices.

The key to a healthy and thriving watershed is understanding the role that every living species has to play within this complex system. Small changes made by many individuals can positively impact our pollinator population and our Apple Canyon Lake Watershed as a whole. Be a part of those changes and watch what happens.

Summary Report for services provided in April, 2016

MIKE MALON, JO DAVIESS SOIL AND WATER CONSERVATION DISTRICT

Monthly water sampling started in April. Six sites were sampled and lab work was performed by Lyons Lab. Lyons reports results within a month instead previous reporting being done by the EPA at the end of the year. All results for April were normal.

A meeting was held with Rich Krasula and Shaun Nordlie going over the watershed plan and how to move forward. Currently there is no date set for the next watershed meeting. The public comment period for the watershed plan ended April 30 and no additional comments have been received.

Quarterly reporting was completed for the watershed grant. Between January 1 and March 31, 2016, \$4,226.25 was paid out for the watershed plan; most of which was for writing the plan content. Of this amount, \$2,440.26 was reimbursed by the EPA.

An erosion problem was investigated behind Taft Court. There is a deep ditch forming between a road culvert and the adjacent stream, which is affecting some property owner's back yards. Initial survey and design estimates about \$5,000 to repair, with approximately \$500 in costs to each adjacent property owner for improvements to their own drainage which also impacts the project.

The SWCD produced estimates for several dry dam structures that need repair, identified by one of last semester's UW Platteville student projects. Plans will be developed for each prioritized by severity of the problems and budgetary restrictions.

The current UW Platteville student project was completed, investigating the feasibility of retention structures in North Bay. Two proposals were concluded: one large pond just upstream of North Bay situated on one property, or five smaller ponds located throughout the subwatershed on five different properties. Shaun Nordlie has directed that nothing be done with this project until the information is taken to the board and funding can be directed. The next step would be to gather a meeting of the landowners and discuss their interest in participating.

The EPA contacted ACL needing more information in order to renew the dredging permit. At this time, the EPA has all of the information they need and a new permit should be issued any day.

Plans are being developed for cleaning out the dredge pond at Presidents Bay. Once ACL decides where to go with the material these plans will be finalized and go out to bid.

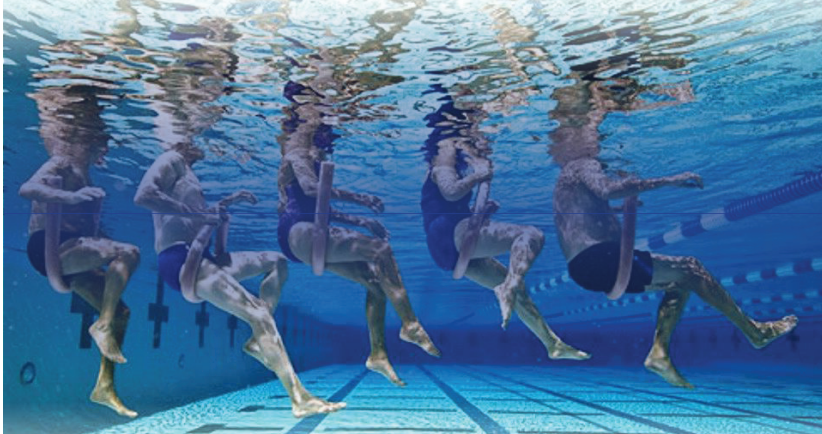

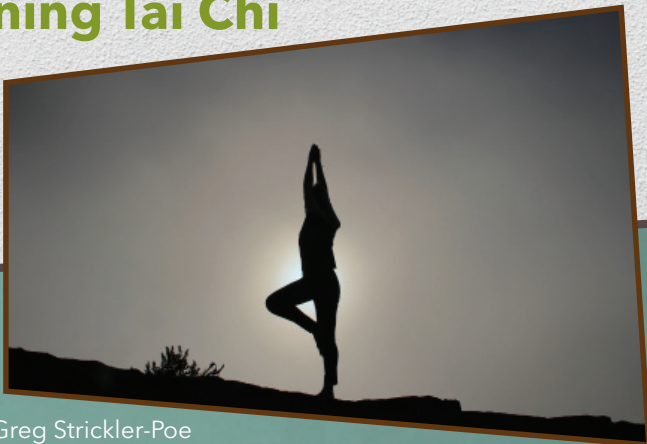
