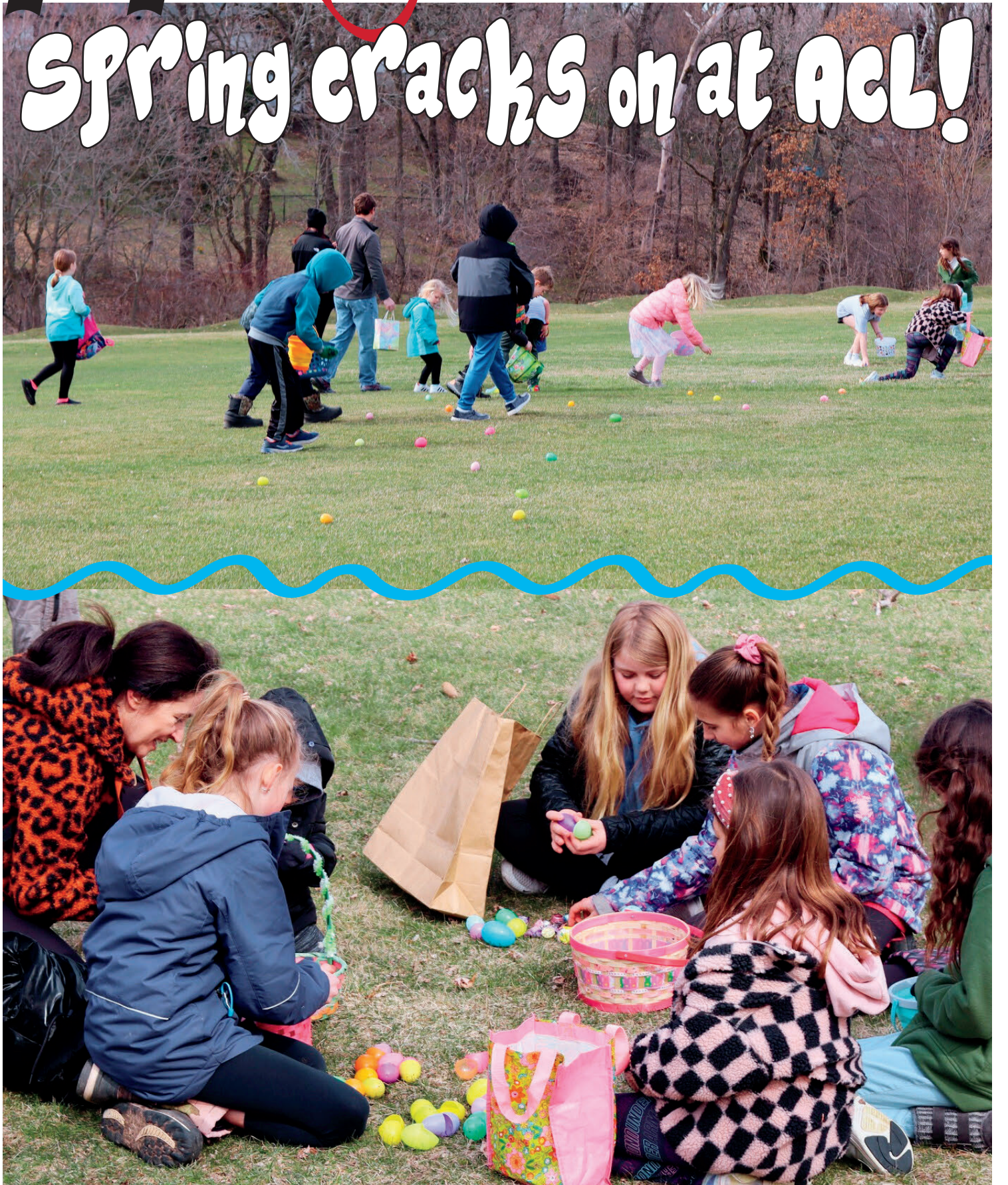

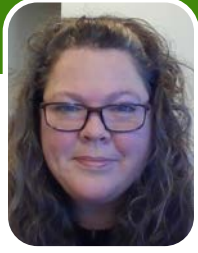

# GENERAL MANAGER'S MESSAGE...

### Member Services –

- The dock & campground lottery/swaps were a success! This year, everyone on the dock slip list that showed up got a slip! With a waiting list of 332 for seasonal slips, we got all the way through 325, with the few remaining able to get subleases. It was a happy day for boaters (especially some new owners who thought they would have to wait years!).

### Accounting/Finance –

- Audit site visit was in April. A lot of work goes into preparing for the annual audit (thank you, Ashlee Miller!). During this process, the auditing team runs a variety of checks and balances to make sure what we are reporting meets standards. They issue a final financial report within a few weeks that will be available for everyone to review.
- We are currently looking at some technology tools that will help us streamline some of our processes to be significantly less time-consuming and improve record retention as well as enforce checks and balances. Ashlee will have her hands full as Maddy leaves for maternity leave, but we are all confident she can do it!

### Human Resources –

- We have really had some great success in attracting some great employees & have brought on over 56 employees in the past 30 days! Our specific need right now is in the 21+ category for the Pro Shop/Cove and kitchen help in both locations.

### Communications/Marketing/Events –

- Check out Tim's updates in this Apple Core. The team continues to amaze me with what they put together as new events, new activities, new designs, you name it!

### Safety & Security –

- Julie continues her preparation for the summer activities. In addition to providing 24/7 patrol, EMS services, overall safety monitoring, and rules enforcement, this department is also in charge of opening the pool, staffing and training lifeguards and seasonal boat/trail patrols, checking in the campground, and helping with boat docks and campground lotteries.

### Maintenance/Natural Resources –

- Tyler and Kelsey have been working on prescribed burns to keep our greenspace and prairie areas healthy and strong. In addition, they have made great progress in clearing out some of

the invasive tree species. They are also lining up our required permits for lake treatments.

- Ed's maintenance crew has been instrumental in getting everything ready for the Cove, the Marina, trails, and everything else in between.

### Golf –

- The course is open, carts have been delivered, and the tee sheet is ready! While we have had and continue to have some hiccups with our tee system and payment processing, we are assured that our provider is working on a solution with high priority. In the meantime, we appreciate your patience with the Pro Shop.

### Pro Shop –

- Speaking of Pro Shop, our new menu is live, and we are doing our best to accommodate. Staffing in the 21+ age group and kitchen help continues to be a challenge, so your patience is absolutely appreciated. The new menu is supposed to help the kitchen push food out more efficiently as well as reduce complexity to expand the level of kitchen help, we need to execute the menu.
- We have new merchandise! For now, we have golf balls, shirts, divot tools, and towels. With more to come!

### Marina –

- We are open! We hope you all appreciate the expansion of offerings! With your support, we hope to be able to continue to be a convenient source for all owners and guests (and neighbors) for basic supplies, groceries, and other fun stuff.
- Special shout out to Sue Meusel who is officially the Marina General Store supervisor with the support of Ashlee Miller who will be overseeing merchandising and Tim Brokyl who will make sure we are stocked with ACL swag. The entire team has worked tirelessly to get up and running in record time.

# FROM THE PRESIDENT...

Last month I said, Spring is finally here. Then we got what seemed like three more weeks of Winter. May is fast approaching and hopefully, we will finally get the weather we deserve to enjoy ACL and its amenities.

You may have noticed the dredging project I previously wrote about is in full swing. In addition to dredging North, Independence, Presidents, and Winchester Bays, the Board approved change orders to include Washington Cove, Hawthorne Bay, and Council Cove.

I attended the Flood Mitigation Ad Hoc Commission meeting. It was good to hear that the new spillway construction and dam leveling projects are still moving forward. The lake may have to be lowered up to eight feet to complete this project. Lowering the lake will create some challenges that we must plan and prepare for.

There was more discussion on the Multi-Sport Complex at the April BOD meeting. The consensus was to keep working with the ad hoc, hoping to either a) get more bids; b) find ways to cut costs in the one bid we received; or c) look at options to repair or replace the current surface in the same footprint.

The Board also discussed upgrading the microphones at the clubhouse. I think anyone that has ever listened to Board meeting recordings or joined meetings via Zoom, would agree the experience was less than desirable. Our General Manager is looking into options for us to improve your listening experience.

"Meet the Candidates" was held on April 8 at the clubhouse. I would like to thank all the BOD candidates for attending and answering questions. The Annual Meeting of the membership will be held on June 10 at the clubhouse during which time, the Tellers Commission will reveal who our new Board members are. I encourage everyone to research the candidates and Make Your Vote Count!

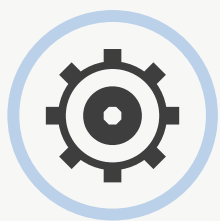

## BOARD OF DIRECTORS MEETING MINUTES MARCH 18, 2023 UNAPPROVED

Call to Order: Meeting was called to order at 9:03 am.

Pledge of Allegiance – after the Pledge of Allegiance, a quorum was present with the following Directors in attendance: Nolan Mullen, Henry Doden (via Zoom), Steve Borst, Bill Becker, Mark Kosco, Bob Ballenger (via Zoom), John Anderson (via Zoom) and Laura Pratt. Absent: Mike Harris. General Manager Jen Callaghan was also present.

Approval/Adopt Minutes - Mark Kosco motioned “to approve/adopt minutes from the February 18, 2023 Executive Session and Regular Meeting.” Seconded by Laura Pratt, motion carried unanimously.

Treasurer's Report – Treasurer's Report will be in The Apple Core.

### 5.0 Committee/Commission Reports

Conservation - Mike Yorke reported at last month's BOD meeting, a plan was created and approved by the Board for zebra mussels. While not completely agreeing with the plan, Conservation is thrilled that there is a plan and we are fully behind that plan. Greenway Stewardship program – currently 12 applications. Memorial Pavilion – other side of the tower. Need to figure out the invasives surrounding the area for clearing. We want to do our part to make the pavilion the best it can be. Last year was the year of the walleye. So far, all indications are the walleye are still biting. Compliment to the fishery.

Nominating – Mike Yorke reported everything is good, where we want to be. Getting ready for more information out in The Apple Core. April 8th – Meet the Candidates event.

Cove Ad Hoc - Mike Yorke reported important dates coming up. Auction of some of the memorial items on April 15th. That will build towards the soft opening on April 27; which will build towards the grand opening on May 15. Biggest issue we have right now is staffing. So far we are under budget as we move forward.

Rules & Regulations – Mark Kosco reported Long Term Rentals and Ice Shelter is finalized.

Recreation – John Anderson reported we have the Easter Egg hunt coming up on April 2. May 20th golf outing for Safe Haven.

Memorial Pavilion – Laura Pratt reported things are progressing. Should have everything ready for the Board in May. Our grant application to the Foundation was rejected. We will resubmit.

Zebra Mussels – Bill Becker reported they are picking up materials to construct live cages used for monitoring and will work on getting them assembled. Al Zobjeck also reported that coming up in April the IL DNR Officer, Audrey Jones will be meeting with this commission to discuss next steps as far as recommendation from the state of IL. Spreadsheets will be shared with Dr Sonnenberg, who works with college students. In May will be meeting with McCloud & Company to talk about the spread of the shoreline application and how it is done.

### 6.0 General Manager's Report

6.1 Capital Projects Update – Office is starting to slow down. Stacy has done a great job, extra shout out. Maintenance – getting everything ready for the summer, spending extra time at the Cove and Marina. Trying to get labor at the Pro Shop. Spillway engineer was out this past week, inspecting the overflow. Special meeting in the next two weeks of the commission. Dredging did secure a dredge permit for three more bays for a total of seven bays.

7.0 President's Report will be in The Apple Core. Did have a special meeting, used executive session to discuss the dredging contract and explore additional options. Some questions about why seven feet was the depth of dredging – driven by the capacity of our holding ponds. We will maximize the amount of dredging to be done.

Marcie Stanger, 13-17 – I am on the Jo Carroll Energy commission. Facing problems of reliability and availability, affordability. Would ask all to read the bios, they'll be out in the paper, consider your options for voting.

George Drogusz, 8-48 - questions about the dredge project. Weeds growing behind the silt curtain in Presidents Bay. Needs to be cleaned up. Are we dredging near the boat docks? Hope our dredge, once the company is done, will work and we utilize the piece of equipment we spent a lot of money on.

Bill Becker motioned “to add discussion item on Maintenance Commission.” Seconded by Mark Kosco. Motion carried unanimously to add 12.11 under new business.

### 12.0 New Business

12.1 Memo 2023-018 – Plan on a Page Update - Steve Borst motioned “to approve the updated/aligned Plan on a Page for 2023.” Seconded by Bill Becker. Discussion: Steve Borst (co-chair of Strategic Planning) reported there was a lot of time spent on the timeline and on how we prepare the strategic plan. Long range vision of where we would like to go. When Board sets goals for the General Manager, we highlighted what was on the Plan on a Page and highlighted the GM goals – some things were unaligned. Best for the Association for those to say the same thing. That is what we are proposing today – aligned goals. Created a timeline on how we will go forward with the Plan on a Page, logical transition to have everybody working towards the same goals. Motion carried with Henry Doden abstaining.

12.2 Memo 2023-019 – Bylaws for Publishing to Election Ballot – Steve Borst motioned “to approve the re-publication of the Bylaws via the formal voting process established for the June Annual Meeting.” Seconded by Laura Pratt. Discussion: is this a Legal Commission recommendation? Jen – they are working on this too and they understand we are trying to republish. Would need to go out in April before next board meeting. Steve Borst was on the Legal Commission when this was transpiring. In order to pass the bylaws, needed a majority of the people that voted that day. Bylaws had that majority. Declaration requires 2/3 of the membership. Much tougher document to get restated. We continued the voting process, but votes were not being counted by our Tellers Commission. Bylaws did get 2/3 majority to pass, now coming back to republish. Would revote on a ballot and Tellers Commission would count. Why do we want to pass a bylaw unaligned with our declaration? Always told you wanted those documents aligned. Jen – supposed to be two different things. Pass the bylaws without the declaration passing. Henry Doden - bylaws disagree with declaration – would have a problem. Jen – from attorney perspective, not an issue. Doesn't think what was done in the first place was wrong. Henry Doden – problems with bylaws the way they are written. No Maintenance Commission listed. Nolan Mullen – we can add that back in, needs to be in there. Henry Doden – people will be notified by The Apple Core as far as ballots. Don't believe people are getting this electronically. Number of problems. Should be both – electronic and paper. Jen – we don't want to vote if too many issues. Motion failed with Bob Ballenger abstaining.

12.3 Memo 2023-020 – Adoption to Support Updated Jo Daviess Water Resource Management Plan - Laura Pratt motioned “to support the updated Jo Daviess Water Resource Management Plan.” Seconded by Mark Kosco, motion carried unanimously.

12.4 Memo 2023-021 – Ratification of Backhoe Repair - Laura Pratt motioned “to ratify the repair of the ACL Backhoe for a cost of \$13,534.30 plus tax.” Seconded by Mark Kosco. Discussion: do we have any records on maintenance on this? Working on developing a maintenance schedule for everything. Heading in the right direction. Motion carried with Henry Doden abstaining.

12.5 Memo 2023-022 – Foundation Grant – Prairie Seed - Bill Becker motioned “to approve the Prairie Seed Planting project on Independence Prairie, funded by the ACLPOA Foundation.” Seconded by Steve Borst. Discussion: funding the seed only, maintenance will take care of mowing. Steve Borst - shout out to the Foundation – like the relationship we have with the Foundation. Motion carried unanimously.

12.6 Memo 2023-023 – Foundation Grant – Wetland Garden Phase 2 – Steve Borst motioned “to approve the Wetland Garden Phase 2 Project, funded by the ACLPOA Foundation.” Seconded by Mark Kosco, motion carried unanimously.

12.7 Memo 2023-024 – Foundation Grant – Garden Club use of Children's Garden & Grant Projects – Laura Pratt motioned “to approve the Garden Club request to continue the use of the Children's Garden as well as additions funded by the ACLPOA Foundation.” Seconded by Mark Kosco. Discussion: Children's Garden to the Pavilion – will flow nicely. Will putting the pavilion in tear things up? Laura Pratt – equipment will be brought in from the other side. Motion carried unanimously.

Mark Kosco motioned “to suspend Roberts Rule of Order.” Seconded by Laura Pratt, motion carried unanimously.

### 12.8 Discussion – Fees for Paddleboards (Ballenger)

– Discussion: Bob Ballenger - don't think we should be sticker or charging a fee for paddleboards. State of Illinois has a history of making up rules, increase taxes, adding fees, etc. We can decide what we want, totally ignore Illinois and the fact they think it is a vehicle. John

Anderson agrees. Mark Kosco – not a vehicle, it is a watercraft. No discussion of what the state of Illinois did or didn't do. George Drogusz – on R&R committee – if security finds a paddleboard floating, don't know who it belongs to, if they fall off and drown, we don't know how to identify them or the paddleboard. Seeing the lake is closed to general public we have no way to make sure someone from surrounding town pulls into a bay. If they get hurt on our lake, the first thing they will do is hire a lawyer. That is why we want to register a paddleboard. What we have to do as an association. Bob Ballenger – weakest argument ever heard. We should not be taxing the property owners. Paddleboard is not a vehicle. George Drogusz – not a matter of taxing, matter of identification. Not looking to collect money. Henry Doden – people renting out houses and bringing out paddleboards. Who belongs on our lake and who doesn't. Mark Kosco – life jacket on a stand up paddleboard – state requires. Will have to rescind the registration then for kayaks, classified as watercraft by state of IL. Non-motorized water craft – if we charge on one we should charge on all. George Drogusz – not up to the state to register a paddleboard. Up to ACL. Henry Doden – keeping records if we register paddleboards will be an expense. Nolan Mullen – already charging the sticker fee – Bob would like us to get rid of sticker rule and what about refunding? Bob Ballenger – we need to stop charging in the future. Nolan Mullen - bring to vote next month.

12.9 Discussion – Air BnB Rules (Doden) – Henry Doden – website listed all sorts of recreation opportunities at ACL. Listed hunting in the advertising. Mark Kosco – Bylaws state 10 days' notice for renting out, usually day before. Henry Doden – septic systems, normal occupancy. Some rentals will say will sleep six couples. Overloading septic systems. None of the advertising says anything about being part of a homeowners association with rules to follow. Rental properties cause us to spend more money and we are not getting more money for them. Laura Pratt – boat rentals come through the office. Boat rental has to come through the owner. Property owner does not have to be present. Security deposit needed. If deposit was put down by property owner, would solve some problems. George Drogusz – knows of an owner supplying his pontoon boat to renters. Nolan Mullen – sounds like any type of rental discussion should go to R&R. Place to start. Benchmark with other HOAs. Guests and renters' situations. Bob Ballenger – we need to define problems before we create new rules. Henry Doden – short term rental places are not letting people know they are renting their place.

12.10 Discussion – Reserve Study (Mullen) – Discussion: we talked about this during the budget process. Now that we have a maintenance mechanic, we do need to continue this conversation. Steve Borst – part of the budget process, felt this is important and keep up to date. Nolan Mullen – pull away from the budget and have its own commission then give to Budget to give final input and update. Mark, Bill, Jen, maintenance manager, John.

12.11 Maintenance Commission (Becker) – Discussion: Bill Becker - Identify best practices and what we can do to extend the life and up keep of our equipment. Jen talked to Carmel [Cottrell] about a facility management tool/software. Equipment and facilities. Record everything. Solar/Natural Gas discussion. First meeting is scheduled. Henry Doden – Every January should write down mileage on trucks, hours on the equipment, etc.

Laura Pratt motioned “to reinstate Roberts Rule of Order,” seconded by Mark Kosco. Motion carried unanimously.

Mark Kosco motioned “to adjourn at 11:10 am.” Seconded by Laura Pratt. Motion passed

ACL Building and Environmental Code – Jim Frank moved, and Bob Ballenger seconded, "Motion to discuss revising ACL Building Code language" Discussion: The committee unanimously agreed to move agenda item 6.1 to the next meeting on April 1, 2023.

Violation Resolution - Bob Ballenger moved, and Jim Frank seconded. "Motion to discuss the resolution of the violation of Article III Section 8, no animals other than inoffensive common domestic household pets, shall be domiciled on any lot or in any dwelling." Discussion: Proper notification and appeal procedures were followed. The Board of Directors acted in Executive session. The poultry have been removed from ACL. The accessory structure is to be removed. Motion did not require a vote.

New Business

7.1 7A251 Tomahawk Ln – Property Owner Steve Scalf was present. Jim Frank moved, and Bob Ballenger seconded, "In accordance with Amended Declaration Article III Section 13.a, to approve the requested Variation to ACL Code 123.1, permitting a SFT pier extension of thirty feet into the lake for reasons of lake depth. Seven property owners were notified of the request for variation. No negative responses were received. One positive response was received." Motion passed unanimously with 7 ayes. A Variation is granted subject to approval by the Board of Directors.

14A103 Canyon Club Dr – Jim Frank moved, and John Anderson seconded, "In accordance with ACL Code 110.4.E., to construct a 314-sf paved patio, fire pit, and 20' long by 17" high retaining wall encroaching 9'-6" into the rear yard setback. Lot corner posts and structure setbacks must be located and flagged by a licensed surveyor in accordance with ACL B&E Code

7.2. A silt fence shall be installed and maintained throughout the project until the ground cover is restored. Disturbed ground shall be seeded and mulched as soon as is practical. No variance is granted." Discussion: The ACL Building Code allows encroachment into setback for a paved patio with AECC written approval. No documentation was provided regarding the location of the dwelling on the lot. Isn't there enough room to have the retaining wall on the opposite side of the seating area between the dwelling and the lot line? A chipstone seating area is an alternative to pavers. Motion failed with 0 aye, 7 nay, 0 abstain.

14A052 Pilot Point Ln - Bob Ballenger moved, and Jim Frank seconded. "In accordance with ACL Code 110, to rebuild an attached screened porch, to replace and extend one existing attached deck and to construct a new 132-sf attached sun deck to code as per the submitted plans. The Jo Daviess County Planning and Development permit must be obtained before the ACL permit will be considered issued. Lot corner posts and structure setbacks must be located and flagged by a licensed surveyor in accordance with ACL B&E Code 102.4. A silt fence shall be installed and maintained throughout the project until the ground cover is restored. Disturbed ground shall be seeded and mulched as soon as is practical. No variance is granted." Discussion: The AECC requires a current survey. An existing deck appears to encroach into the side yard setback. The requested extension may cross the lot line. A lot combination may resolve the difficulties. Motion failed 0 aye, 7 nay, 0 abstain.

### Commission & Committee Summaries...

#### Flood Mitigation Ad Hoc:

Approved minutes of August 30, 2022, meeting.

Ted LaBelle gave an update of the design now that the survey is complete. CMT has met with the IDNR and has a permit review meeting scheduled for April 6, 2023 with the Army CORPS. With the updated design, the 60% probably max flood now has 1' of freeboard. CMT discussed that due to the survey showing how shallow the approach is, it will need to be removed. This will cause the lake to be brought down 8' for construction. This will need to be discussed further. The lake will need to be lowered slowly, could take 4-6 weeks. CMT is working on the construction schedule to help contractors. Once plans are ready for bid, would be about 30 days to bid. The August 2022 plan had construction commencing after Labor Day 2023. Due to task scheduling delays this schedule may be moved one year post Labor day 2024. This is not a definite change at this time. Due to fluctuation in costs this year, CMT has not updated the cost estimate but will at the appropriate time.

Drawdown Diversion capability to avoid major drawdown of lake. Cost – CMT discussed that due to the survey showing how shallow the approach is, it will need to be removed. This will cause the lake to be brought down 8' for construction. This will need to be discussed further. The idea of the dam being built in phases that would include water diversion during construction, and therefore not need to lower the water level 8' would be difficult if not impossible due to the need for the ledge removal.

Rock storage from blasting and use for rip rap on shorelines. - We may be able to specify the size of blasting and we would need a storage location for rip rap.

#### Maintenance:

Election of Officers: Carmel Cottrell, Chair & Secretary; George Drogasz, Vice Chair. Bill Becker, Board Liaison. Moved by George Drogasz, seconded by Ed Reich. Officers approved unanimously.

Charge Discussion – review of charge to advise matters pertaining to the maintenance, repair, or improvement of the common properties and facilities of Apple Canyon Lake.

Solar information was disseminated by Carmel of four local companies to provide energy to our amenities, as well as incentives for the Association from Federal and State levels with the installation of solar energy. We will continue to investigate.

Maintenance Software – Discussion for a Computerized Maintenance Management System, and what we want the program to include. Must be Cloud based, an asset tracker, show reoccurring work orders, and reports. Software will manage a database of information about ACL's maintenance operations and will organize equipment and other business assets to allow for an efficient maintenance schedule. Bill Becker will bring in samples of work orders and equipment information he presently uses. Carmel will continue to research software programs. We will work with the Maintenance Department to pull a program together that fits Apple Canyon Lake needs.

#### Memorial Pavilion Ad Hoc:

Approved March 15, 2023, Minutes.

Carmel spoke with two members of the ACLPO Foundation who urged us to submit a second addendum to the Grant submitted in February 2023. Therese Nelson revised, a second Addendum and it was resubmitted, April 1, 2023.

Carmel will create a template for ordering brick pavers to be submitted in the May Apple Core. Paver sizes and prices, along with order form will be included. 8x4 inches, 2 lines, 15 characters/line, \$100. 8x8 inches, 3 lines, 15 characters/line, \$200. 12x8 inches, 4 lines, 15 characters/line, \$300.

It was discussed and decided to have a display table set up to share information and sell the Memorial Pavilion fundraiser pavers at all upcoming ACL events this summer. We will ask permission from Jen and the BOD.

It was also agreed to have the paver walkway constructed 4 feet wide (ADA) to curve up the small slope from the clubhouse sidewalk to the pavilion. Laura and Carmel staked out the 30x50 foot pavilion location and took pictures to share with the commission. All building plans, and contracts will be submitted to the BOD for final approval at the May 2023 Board Meeting. If additional funding is needed, we may need to ask the BOD.

#### Recreation:

Approved March 16, 2023, Minutes.

Reviewed Easter Egg Hunt. 120+ kids in attendance. Online reservations maxed.

Discussed volunteers for Summer Kick-off.

Discussed volunteers to assist with Safe Haven Golf Outing and Goofy Golf. John D. John A, and LeAnne will assist.

The commission has decided to discontinue the Haunted Clubhouse and sell the majority of their decorations with the proceed to go back into the Recreation designated fund that purchased the items. The commission will begin planning a new Halloween themed activity for families in 2023.

#### Rules and Regulations:

The Commission continued discussion on collecting another fee on the paddleboard. The main reason is to register the paddleboards and add them to the list of non-motorized vessels along with the canoes, kayaks, row boats, paddleboats and sailboats. In Illinois kayaks, canoes, paddleboats or sailboats are deemed as motorized if powered by any type of machinery, including a trolling motor. Julie asked Jen to check with ACL's insurance agent, and he replied back there is absolutely no reason to collect insurance on anything non-motorized. This is covered under homeowner's insurance. But as an association, ACL can instill the rules necessary and we can state that a non-motorized vessel is to be registered through ACL. That is what the ID numbers are for. Regarding the paddleboards, they were never listed under Registration in VI. Boating section. It's needed in order to be able to identify they belong at ACL. Forget the floating plastic vessels. Having the non-motorized vessels not registered and no fee collected, the numbers were checked and there are about 936 plus non-motorized vessels in Apple Canyon Lake. Check the math. Julie will follow up and check where the non-motorized fee revenue would be applied. It was thought to take this back to Jen and the Board for more discussion. Now knowing that insurance is not necessary on the non-motorized vessels, the rules will have to be revisited.

Julie reported she spoke to Joe Wiener regarding the rule for Security to ticket the private dock owners who do not have the proper labeling of their lot and the reflective. Joe said he and AECC is in complete agreement for Security to enforcing it. Everything in the AECC Building Code regarding this would be repeated. It will be discussed further where to place this and establish a fine at the May meeting.

Mark Kosco reported that at the last Board meeting it was brought up on how many homes are being rented up here at the lake. A big problem is that the office staff gets inundated with the renters coming in wanting the amenity tags or want to rent a boat. It gets quite busy and time consuming for the staff especially during the summer on the weekends. According to the by-laws it says a ten-day notice is supposed to take place. A question arose should the staff require registration to keep track. Another item is Jo Daviess requires that the septic systems on rentals must be pumped every year. If requested, Jo Daviess would send this information to ACL. The norm is that the tank has to be able to hold 500 gallons per bedroom in order for the system to work properly. According to Mark Kosco Lake Carroll rentals are a minimum of six months at a time, Galena Territories is whenever; Lake Holiday does not offer rentals and Lake Somerset does one month at a time. Julie will check with Stacy on what her process is with the rentals and she will also check with the county to get a list of the registrations on how many rentals are at ACL.

- The current year ACL sticker will be given by the Association Office. Display ID numbers and current year ACL sticker on the side of camper trailer tongue that faces the road.

## ACL ID Numbers & Current Year Stickers

ID number and current year ACL sticker placement were clarified as part of the Rules & Regulations housekeeping changes approved at the November 2019 Board of Directors meeting. Please take the time to make sure all current 2023 decals and ID numbers are correctly placed before launching your boat or taking your UTV out on the trails. The appropriate decal and ID number locations for each toy type are outlined below. If you have mistakenly placed them in any other place, you will be asked to remove the decal and have a new sticker issued by the Office and placed in the correct location. It does not matter if the sticker is damaged; if it is turned in to the Office; there will be no charge for the replacement. ID numbers, license plates, and zip ties are also available at the Office at no charge. Failure to display ID numbers and/or a current-year ACL sticker will result in fine(s).

### Golf Carts, ATVs, UTVs

Display ID numbers as follows:

- front center hood or front license plate
- rear license plate

Place the current year trail sticker on the center front of the vehicle (front roll bar, windshield, or front of hood panel so that sticker may be clearly seen from another approaching vehicle or trail walker).

**Boats** – Display ID numbers on both the right and left sides of the watercraft near the rear of the boat and on the RIGHT side of boat trailer tongue. Place the current year ACL watercraft sticker on the starboard side (driver's side, right) of the watercraft next to the ID numbers.

**Campers** – the current year ACL camper sticker and ID numbers are to be displayed on the side of the camper trailer tongue that faces the road.

### THE APPLE CORE: ACCEPTANCE OF MATERIAL

# NOTES FROM NATURAL RESOURCES

## Hawthorne Oak Savanna Restoration

If you have driven on the Apple Canyon Lake trail system, you may have noticed some changes occurring to the forested area in the Hawthorne Greenway. This is the work of the Natural Resources Department at Apple Canyon Lake that's been conducting a 20-acre grant-funded oak savanna restoration. An oak savanna is a habitat consisting of spread-out dominant old-growth oak trees containing less than 50% canopy coverage which allows for the growth of native prairie grasses and shrubs in the forest's understory. These areas hold high biodiversity creating homes and food for wildlife and pollinator species since you have multiple species' needs met in one area.

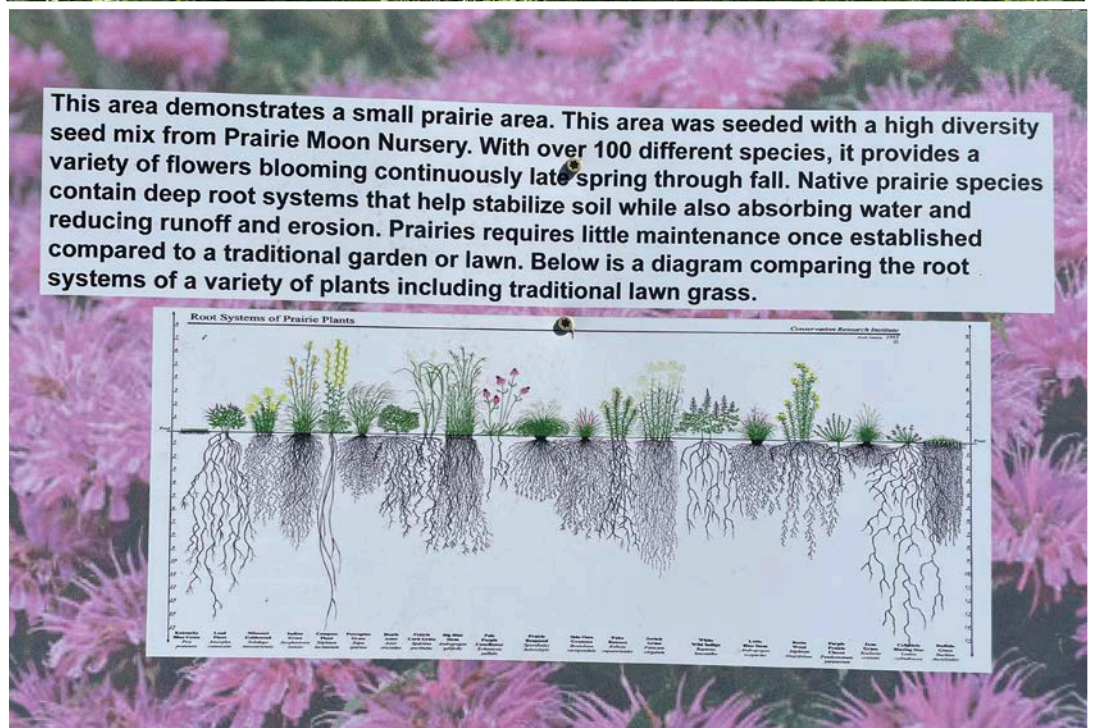
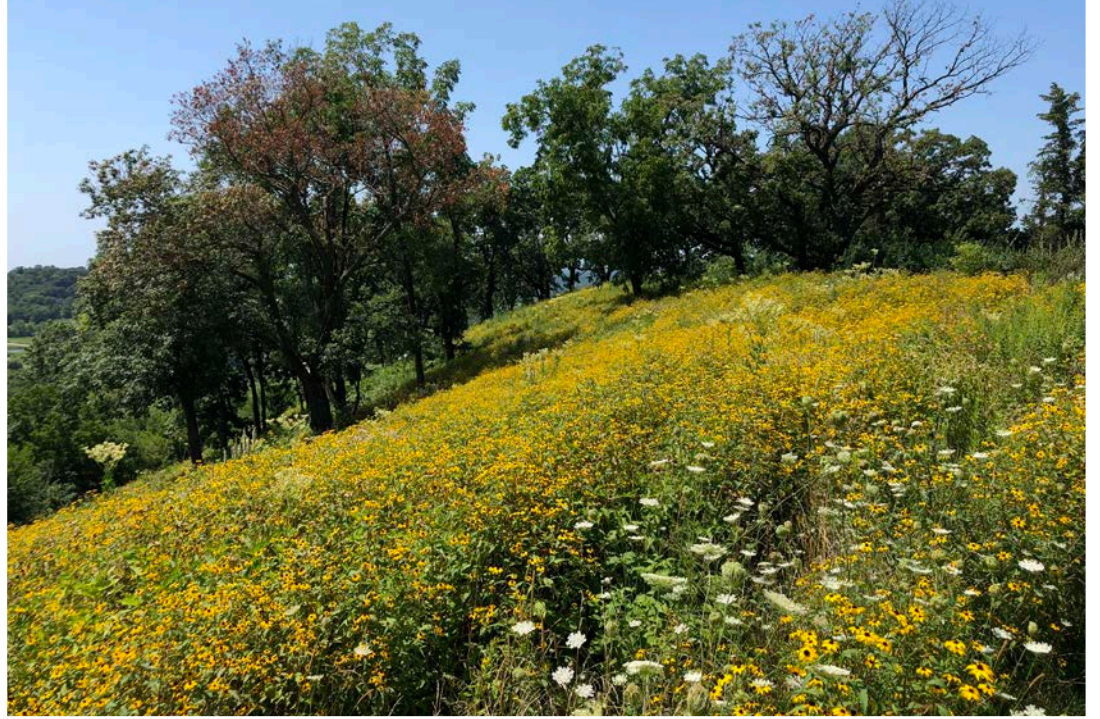
Throughout Jo Daviess County you may have noticed scattered old-growth oak tree forests, but you may not know why and how they came to be dominant in the Midwest. Oak trees are a hardy species that are drought and fire-resistant as well as providers of valuable nutrient-rich acorns that get wildlife through the long winter months. At one point in time, fires spread openly throughout the Midwest by either natural causes or by Native Americans setting them to clear areas for easier traveling and hunting. Due to the nature of these highly flammable prairie grass fires only the toughest fire-tolerant tree species were able to survive and thrive- oak trees. Today many oak savanna habitats have been converted to other land uses and are a rarer phenomenon. Fire suppression has also increased along with the uptake in the human development of areas leading to the presence of less fire-tolerant tree species such as maples, black cherries, mulberries, and basswoods that are able to outcompete oak trees and are primed to take over once the mature oak trees are gone. In short, oak savanna habitats provide many benefits in a continually changing world and they need to have a chance at thriving in the future.

Organizations such as the United States Department of Agriculture's Natural Resources Conservation Service have funded grants that incentivize property owners and organizations to manage their land more sustainably. The program that assisted Apple Canyon Lake with the funding for this grant restoration is called the Environmental Quality Incentives Program (EQIP) which is designed to help with natural resource concerns relating to soil and water health, improving wildlife habitat, as well as mitigating hazardous weather and reducing soil erosion.

Our hope for this restoration is to mitigate soil erosion and improve water filtration in the greenway. By selecting an oak savanna for erosion control, you get the best root stability from both the oak trees and prairie grasses. For example, oak trees tend to spread their roots laterally and can extend as far as 90 feet away from the trunk holding the topsoil in place and storing water. Native prairie grasses send their roots deep and form fibrous dense mats underground that can extend up to 9 feet holding the soil's foundational structure in place leading to less erosion and less silt flowing into the lake. By removing invasive species such as honeysuckle and the less desirable tree species we hope to recreate a landscape that once was present.

We urge homeowners to be patient as restorations require time and continual management to get the desired habitat quality we are attempting to recreate.

These pictures of the Jo Daviess Conservation Foundation Horseshoe Mound project reflect what our restoration should look like in approximately five years.



This area demonstrates a small prairie area. This area was seeded with a high diversity seed mix from Prairie Moon Nursery. With over 100 different species, it provides a variety of flowers blooming continuously late spring through fall. Native prairie species contain deep root systems that help stabilize soil while also absorbing water and reducing runoff and erosion. Prairies requires little maintenance once established compared to a traditional garden or lawn. Below is a diagram comparing the root systems of a variety of plants including traditional lawn grass.

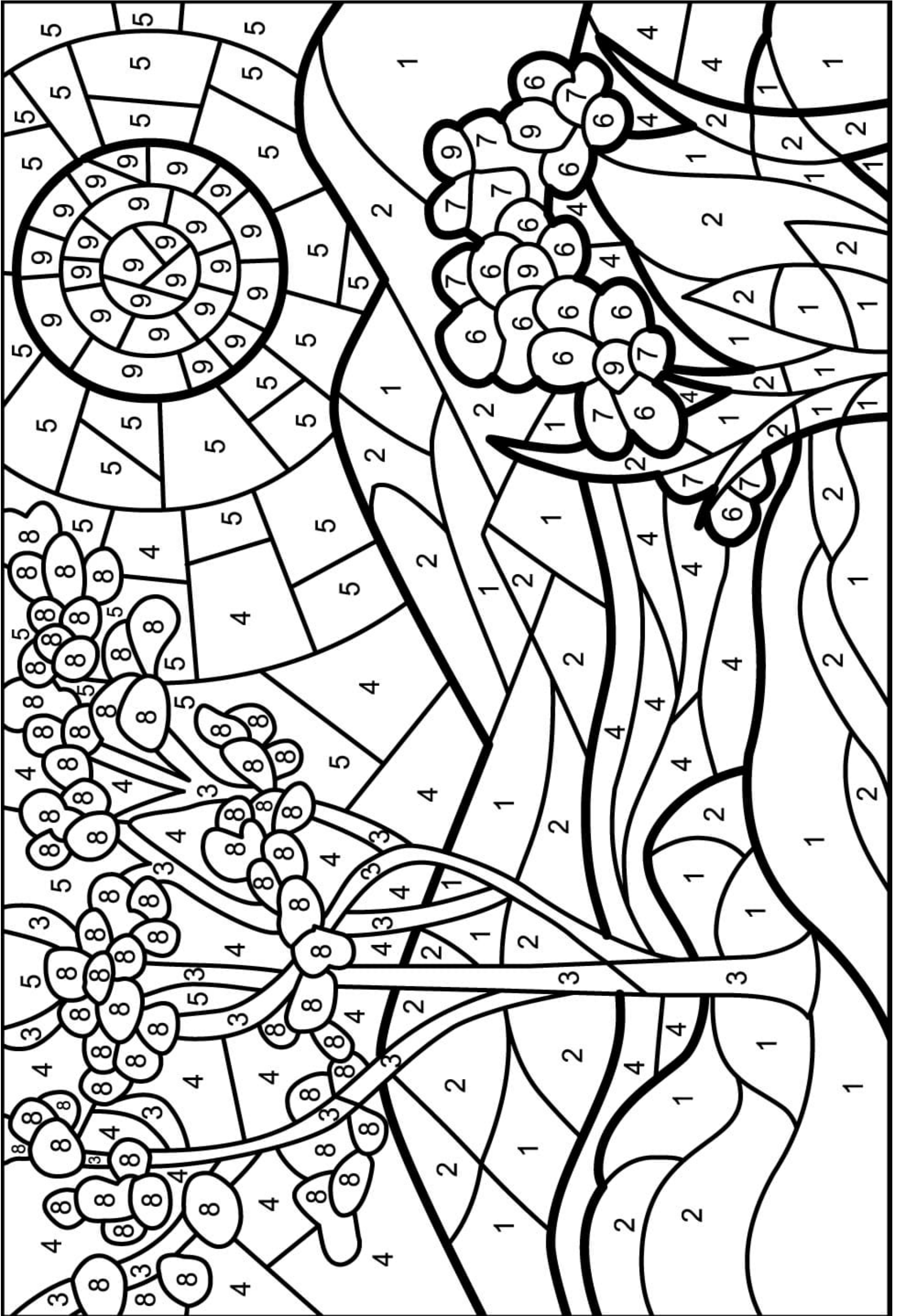

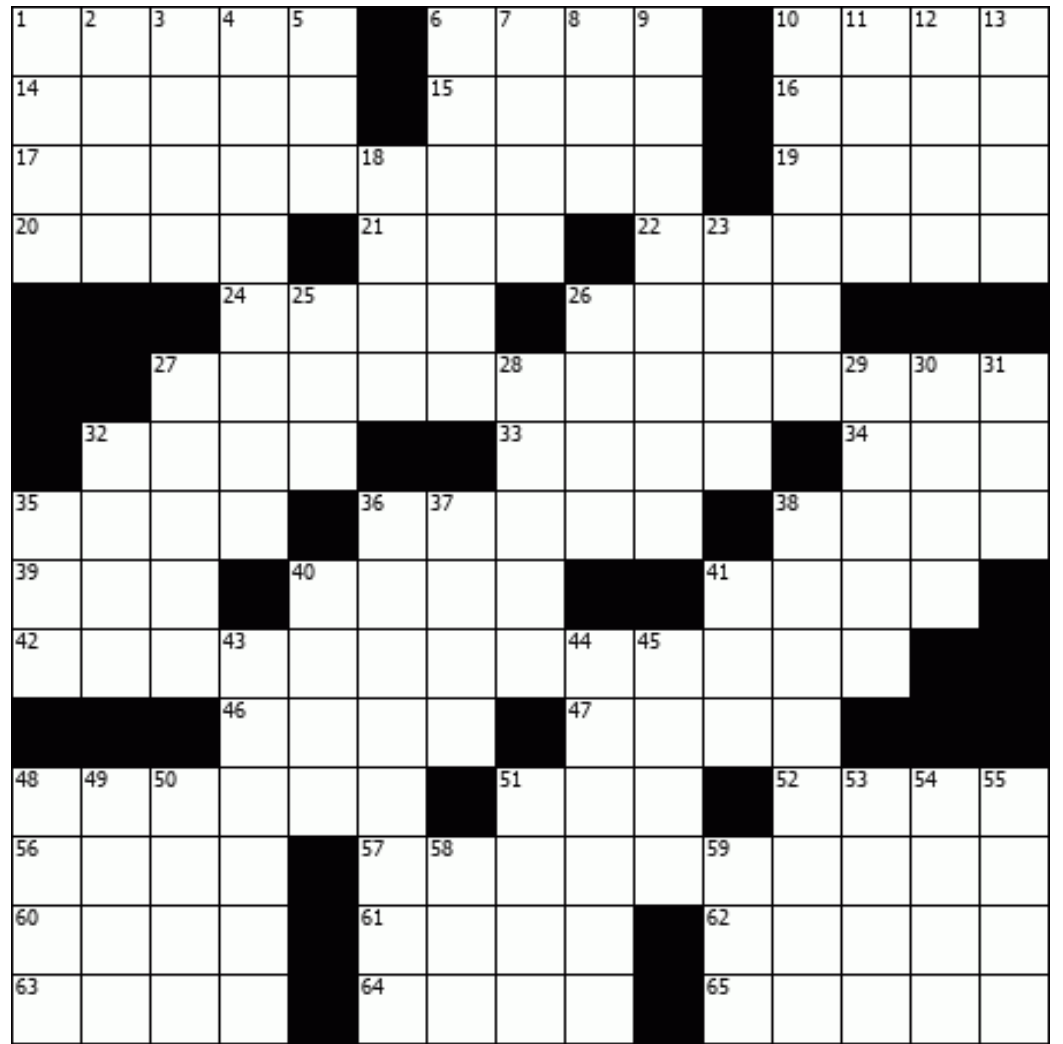

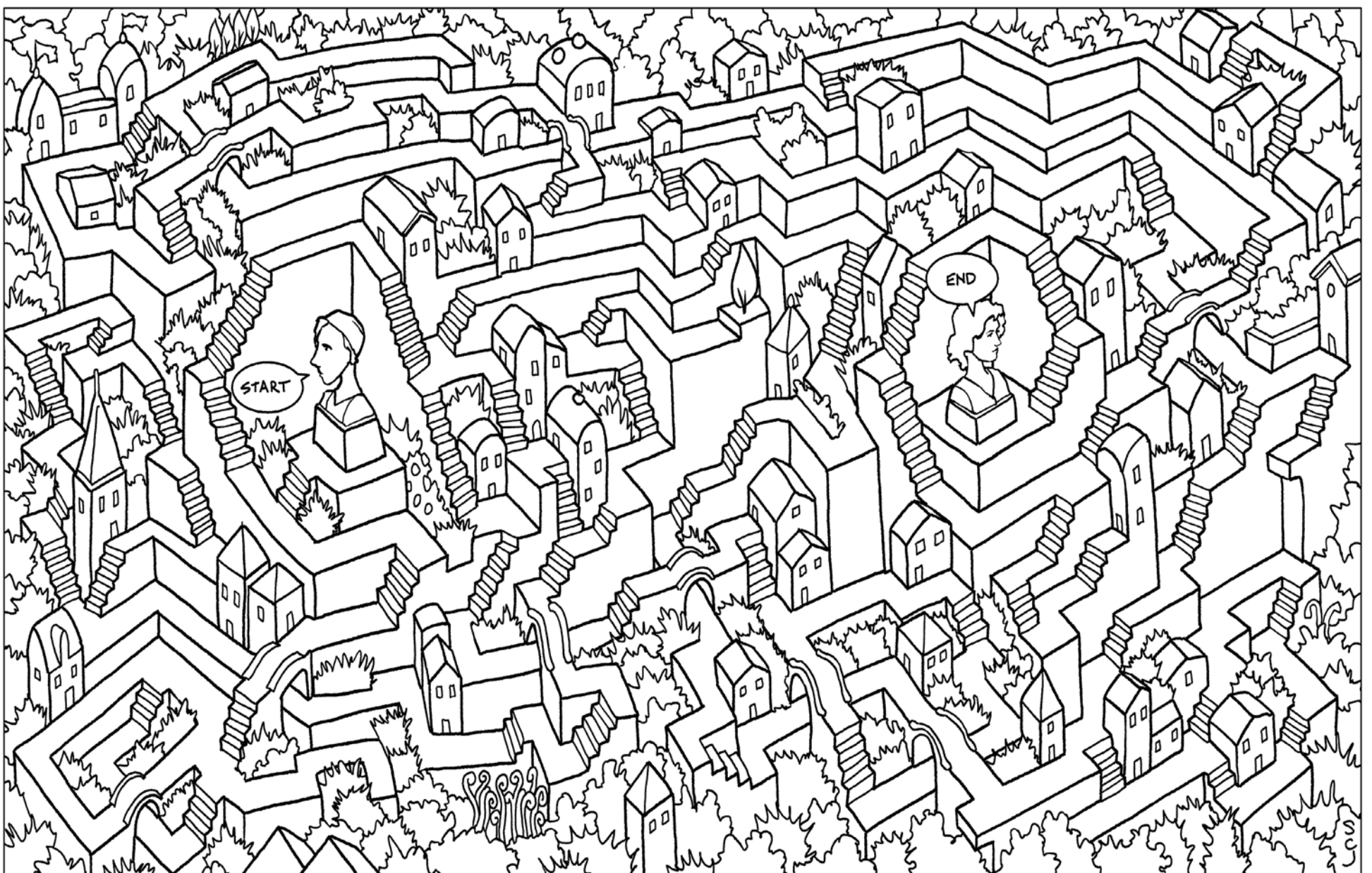

Most of our lifeguards are returning for another fun pool season. One of the changes this year is you can sign up for swimming lessons online or still drop your registrations off at the office. Check out all the posters with the times and dates of the classes.

Weather is always a high priority in the pool swimming season. I want to remind everyone that if thunder or lightning is heard or seen it means immediate evacuation of the pool and pool deck. Then it starts a 30-minute time closer to the last thunder or lightning occurrence. Once the weather clears and it is safe, we will re-open.

Diarrhea, nobody wants to talk about this, but it is super important. If you have had diarrhea within two weeks of swimming do not swim! This type of stool carries bacteria that is super hard to kill without shutting the pool down for days if released into the water! Believe it or not, when a fecal emergency happens hard stool is what we like to see!!! So, let's just avoid these types of situations, do not show up if you have diarrhea!

Food and drinks, take your food outside the fenced area or to the pool deck, please do not eat poolside, it helps with keeping the bees, ants, and other critters not bothering us

while we enjoy the water, and nobody wants to step in mushed goldfish.

Remember that you will need to show your amenity tags as you check into the pool so make sure you have the current year's tags and not last year's. You must have a tag for every swimmer that is entering the pool.

Follow the rules, be respectful to other patrons, be safe, and we are going to have a wonderful summer. I can't wait to see you all!

### Life Jacket Loaner Program Promotes Safety at The Lake

### Do you know how old you have to be to NOT wear a life jacket?

Illinois State law requires that anyone under the age of 13 must wear a life jacket while aboard any watercraft under 26 feet in length at all times the boat is underway, unless they are below deck in an enclosed cabin or operating on private property.

There will be two locations established soon displayed with the two logos above. One station will be at Nixon Beach Pavilion and the other will be at the outdoor area of the Marina building. Currently, we have plenty of life jackets to support both stations. More details to follow as the banners and life jackets are put in place.

Together with ACL, the Adventure Committee will utilize a variety of media and host public, in-person mini-lessons on water/lake/boat safety with Julie Janssen, our Safety & Security Manager. Julie is also an expert at inspecting life jackets, fitting life jackets, and with this new initiative, the Children's Adventure Committee will loan life jackets as well as provide important safety tips.

## RULE REMINDERS



### Lifejackets for Kayaks, Canoes & Paddle Boards

BY RESCUE RANDY

Do you have to wear a life jacket on a kayak in Illinois? All vessels are required to have a wearable USCG-approved Type I, II, or III personal flotation device for each person. PFDs must be in good condition, properly sized for each person, and readily accessible.

Do I need a whistle on a kayak in Illinois? Vessels less than 65.6 feet (20 meters) in length are required to carry on board a whistle or horn or some other means to make an efficient sound signal audible for at least one-half mile. On Illinois state waters, all motorized vessels must have a mouth-, hand-, or power-operated whistle or another device capable of producing a blast that is two seconds or more in duration and audible for at least one-half mile.

Illinois boating law requires that anyone under the age of 13 must *always wear a life jacket while aboard any watercraft under 26 feet in length* when the boat is underway.

## IN-CI-DENTAL-LY

### Gum Disease Has No Age Restrictions

Periodontal disease, often referred to as “gum disease,” is a serious bacterial infection that can destroy the gums and supporting structures of your teeth. Many people hold the mistaken belief that periodontal disease only occurs in adults. The disturbing truth is that many children and adolescents in the United States are affected by some form of periodontal disease, which can range from mild to severe. The primary cause of periodontal disease at any age is poor oral hygiene. While periodontal disease tends to be a chronic condition in adults, children and adolescents are more likely to experience aggressive periodontitis.

Most children have the mildest form of periodontal disease, known as gingivitis. Since this stage is generally not painful, it is important that you recognize the most common symptoms of gingivitis and report these to your child’s dentist. These include red, enlarged gums and bleeding while brushing or flossing. If left untreated more advanced symptoms can develop, including gum recession, loose or separating teeth, and changes in bite and/or jaw alignment.

In addition to poor oral hygiene, the following factors can increase the risk for periodontal disease in childhood and adolescence: Clenching and grinding teeth, mouth breathing, crowded teeth, poor diet, autoimmune and systemic disease (such as diabetes and leukemia), poor diet, hormonal changes in the body (such as puberty, menstruation, pregnancy and oral contraceptives use), smoking, vaping and using smokeless tobacco products, certain medications, and genetic predisposition.

It is critical to know that some of the symptoms of periodontal disease can be the result of systemic disease. Overgrowth of gum tissues that may appear dark red or purple, gingival bleeding, oral ulcers and petechiae, accompanied by swollen lymph glands, fatigue, and sudden weight loss can be seen in acute and chronic leukemias. Gingivitis, periodontitis, xerostomia (dry mouth), and oral candida (yeast) infections can indicate undiagnosed diabetes or poorly controlled diabetes.

Early diagnosis and treatment are critical for disease control. This is why your dentist performs a periodontal check during your child’s routine dental checkup. Early treatment can prevent periodontal disease from causing permanent damage. If your dentist suspects an underlying medical condition, a referral to your pediatrician will be given.

Aggressive periodontitis, in the absence of systemic disease or plaque build-up, can rapidly lead to detachment of the periodontal ligament and destruction of alveolar bone. If your child is diagnosed with aggressive periodontitis, it is important to notify your family members. Aggressive periodontitis can run in families, so it is critical that they report this diagnosis to their children’s dentist.

If you suspect that your child may have gingivitis or periodontitis, make an appointment with your dentist immediately.

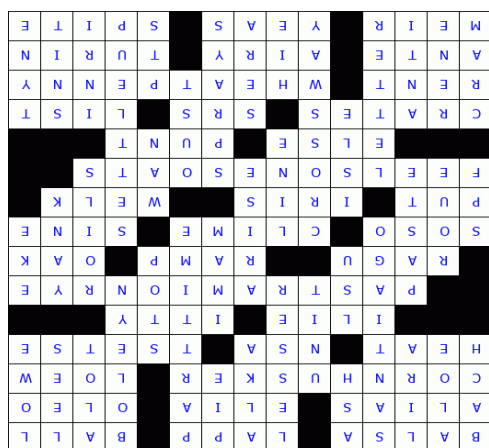
